The Secretary of State for Health, in exercise of the powers conferred upon him by section 44(3) of the Chiropractors Act 1994(a), hereby makes the following Order:—

**Citation and interpretation**

1. This Order may be cited as the Chiropractors Act 1994 (Commencement No.7) Order 2004.

**Appointed Day**

2. The day appointed for the coming into force of section 17 of the Chiropractors Act 1994 (post registration training) is 1<sup>st</sup> July 2004.

**EXPLANATORY NOTE**

This Order brings into force, on 1<sup>st</sup> July 2004, section 17 of the Chiropractors Act 1994 which gives the General Chiropractic Council power to make rules requiring registered chiropractors to undertake post registration training.
