The Biocidal Products (Amendment) Regulations 2005

Citation, commencement and extent

1. These Regulations may be cited as the Biocidal Products (Amendment) Regulations 2005 and shall come into force on 1st October 2005 and extend to the United Kingdom.

Amendment of the Biocidal Products Regulations 2001

2. In the Biocidal Products Regulations 2001 ^{M3}, for regulation 3(2) substitute—

“(2) Subject to Schedule 13, these Regulations, except regulations 29 and 39A and Schedule 12A, shall not apply to a biocidal product which contains an existing active substance.”

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend regulation 3(2) of the Biocidal Products Regulations 2001 and regulation 3(2) of the Biocidal Products Regulations (Northern Ireland) 2001.
