**The Anti-social Behaviour Act 2003 (Commencement No. 5)  
(England) Order 2005**

The Secretary of State, in exercise of the powers conferred upon him by section 93(3) of the Anti-social Behaviour Act 2003<sup>(a)</sup> hereby makes the following Order:

**Citation**

1. This Order may be cited as the Anti-social Behaviour Act 2003 (Commencement No. 5) (England) Order 2005.

**Provisions coming into force in England on 1st June 2005**

2. To the extent to which it has not already been commenced<sup>(b)</sup>, Part 8 of the Anti-social Behaviour Act 2003 (high hedges) shall come into force, in relation to complaints about high hedges situated in England on 1st June 2005.

## EXPLANATORY NOTE

*(This note is not part of the Order)*

This Order brings into force on 1st June 2005, in relation to England, Part 8 of the Anti-social Behaviour Act 2003 (other than sections 71(7) and 72 of that Part which are already in force).

Part 8 gives local authorities the power to deal with complaints about high hedges which are having an adverse effect on a neighbour's enjoyment of his or her domestic property (other than complaints about the effect of the roots of a high hedge). "High hedge" is defined in section 66 and "domestic property" in section 67.
