The Nottingham University Hospitals National Health Service Trust (Transfer of Trust Property) Order 2006

Made - - - - 11th October 2006

Coming into force - - 6th November 2006

The Secretary of State for Health makes the following Order in exercise of the powers conferred on her by section 11(3) of the National Health Service and Community Care Act 1990⁽¹⁾ and section 126(4) of the National Health Service Act 1977⁽²⁾.

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Nottingham University Hospitals National Health Service Trust (Transfer of Trust Property) Order 2006 and shall come into force on 6th November 2006.

(2) In this Order—

“the NHS Trust” means the Nottingham University Hospitals National Health Service Trust⁽³⁾;

“the new trustees” means the trustees for the Nottingham University Hospitals National Health Service Trust⁽⁴⁾; and

“the trust property” means the property specified in the schedule of trust property prepared and agreed by the NHS Trust and the new trustees and signed on behalf of the NHS Trust on 9th August 2006 and on behalf of the new trustees on 14th August 2006.

Transfer of trust property

2.—(1) On the date that this Order comes into force the trust property, and any rights and liabilities arising from that property, shall be transferred from the NHS Trust to the new trustees.

(2) In any instrument relating to the trust property, any reference to the name by which the trustees of the trust property are to be known shall be construed as a reference to the new trustees and any
