**ROAD TRAFFIC**

**The Road Vehicles (Registration and Licensing)  
(Amendment) (No. 2) Regulations 2007**

*Made* - - - - 23rd March 2007  
*Laid before Parliament* 28th March 2007  
*Coming into force* - - 1st May 2007

The Secretary of State for Transport makes the following Regulations in exercise of the powers conferred by sections 21(3) and 22(1)(i) of the Vehicle Excise and Registration Act 1994<sup>(1)</sup> and by virtue of the Department for Transport (Driver Licensing and Vehicle Registration Fees) Order 2003<sup>(2)</sup>.

**Citation and commencement**

1. These Regulations may be cited as the Road Vehicles (Registration and Licensing) (Amendment) (No. 2) Regulations 2007 and shall come into force on 1st May 2007.

**Amendment of Regulations**

2. The Road Vehicles (Registration and Licensing) Regulations 2002<sup>(3)</sup> shall be amended in accordance with the following regulations.

3. In regulation 10 (registration and issue of registration document), in paragraph (1) for “£38” there shall be substituted “£50”.

4. In the regulations referred to in column (1) of the Table below, in the paragraphs referred to in column (2) thereof, for “£19” there shall be substituted “£25”.

## EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations amend the Road Vehicles (Registration and Licensing) Regulations 2002 to increase the fees payable in respect of first registration and the replacement of a registration document.

The Regulations provide that on 1st May 2007—

- (a) the first registration fee increases from £38 to £50 (an increase of 31.6%) (*regulation 3*);  
and
- (b) the fee for a new registration document increases from £19 to £25 (an increase of 31.6%) (*regulation 4*).
