The Police and Justice Act 2006 (Commencement No. 6) Order 2007

Made - - - 8th November 2007

The Secretary of State makes the following Order in exercise of the powers conferred by section 53(1) of the Police and Justice Act 2006(a).

- 1. This Order may be cited as the Police and Justice Act 2006 (Commencement No. 6) Order 2007.
- **2.** The following provisions of the Police and Justice Act 2006 shall come into force on 1st December 2007 to the extent not already in force—
 - (a) section 7 (standard powers and duties of community support officers);
 - (b) section 9 (exercise of police powers by civilians) in so far as it relates to the entries in Schedule 5 (exercise of police powers by civilians) referred to in sub-paragraph (c);
 - (c) in Schedule 5 (exercise of police powers by civilians) paragraphs 1 to 6, apart from paragraph 5(11);
 - (d) section 52 (amendments and repeals) in so far as it relates to the entry in Schedule 15 (repeals and revocations) referred to in sub-paragraph (e); and
 - (e) in Schedule 15 (repeals and revocations), the entry in Part 1(B) relating to Schedule 4 of the Police Reform Act 2002(**b**).
- **3.** The following provisions of the Police and Justice Act 2006 shall come into force on 31st December 2007—
 - (a) section 5 (power to merge schemes); and
 - (b) Schedule 3 (power to merge police pension schemes).
