The A1(M) Motorway (Junction 35, Wadworth Interchange) (Temporary Restriction and Prohibition of Traffic) Order 2010

 Made
 30 April 2010

 Coming into force
 5 May 2010

WHEREAS, the Secretary of State for Transport, being the traffic authority for the A1(M) Motorway, in the District of Doncaster in the County of South Yorkshire, is satisfied that traffic on that motorway should be restricted and prohibited because bridge inspection works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) and (7) of the Road Traffic Regulation Act 1984(a), makes the following Order: -

- **1.** This Order may be cited as the A1(M) Motorway (Junction 35, Wadworth Interchange) (Temporary Restriction and Prohibition of Traffic) Order 2010 and shall come into force on 5 May 2010.
- **2.** In this Order "the northbound carriageway" means the A1(M) Motorway northbound carriageway between the nosings of the northbound exit and entry slip roads at Junction 35 (Wadworth Interchange), a distance of 800 metres.
- **3.** Subject as mentioned in article 4 of this Order no person shall, during a period of 10 hours starting at 20:00 hours on Thursday 6 May 2010 or any subsequent night thereafter until the said works have been completed, cause or permit any vehicle to enter or proceed in the northbound carriageway.
- **4.** The provisions of article 3 of this Order shall apply only during such times and to such extent as shall, from time to time, be indicated by traffic signs and shall not apply to:
 - (a) a vehicle being used for police, fire and rescue authority or ambulance purposes;
 - (b) a vehicle being used for, or in connection with, the said works, or for winter maintenance or traffic officer purposes; or
 - (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform.
- **5.** The provisions of regulations 5 and (in so far as it relates to a vehicle being driven) 9 of the Motorways Traffic (England and Wales) Regulations 1982(**b**) are suspended in relation to the hard shoulder adjacent to the northbound carriageway as described in article 2 of this Order at such times and to such extent as may, from time to time, be indicated by traffic signs; and in this article "hard shoulder" has the meaning given in regulation 3(1)(e) of those Regulations.
