# The Parental Responsibility and Measures for the Protection of Children (International Obligations) (England and Wales and Northern Ireland) Regulations 2010

#### Local authorities and Northern Ireland authorities: requirement to provide a report

**13.**—(1) This regulation applies if a local authority in England and Wales or a Northern Ireland authority is contemplating—

- (a) placing a child in another Contracting State, within the meaning given by Article 33 of the Convention. <sup>F1</sup>...

(2) Either the court or the local authority or Northern Ireland authority, whichever has jurisdiction under Articles 5 to 10 of the Convention  $^{F2}$ ... ("the authority")—
