## **ROAD TRAFFIC**

## The M25 Motorway (Junctions 6 – 10, Slip Roads) (Temporary Prohibition of Traffic) (No. 2) Order 2010

WHEREAS the Secretary of State for Transport, being the traffic authority for the M25 Motorway and connecting roads, is satisfied that traffic should be prohibited on some of those connecting roads because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act  $1984(\mathbf{a})$ , hereby makes the following Order:-

**1.** This Order may be cited as the M25 Motorway (Junctions 6 - 10, Slip Roads) (Temporary Prohibition of Traffic) (No. 2) Order 2010 and shall come into force on 15th January 2011 and shall apply for a period of twelve months.

**2.** In this Order:

"the motorway" means the M25 Motorway in the County of Surrey;

"a slip road" means -

- (i) the road leading from the clockwise carriageway of the motorway to the A22 at Junction 6 near Godstone,
- (ii) the road leading from the A22 to the clockwise carriageway of the motorway at Junction 6 near Godstone,
- (iii) the road leading from the anti-clockwise carriageway of the motorway to the A22 at Junction 6 near Godstone,
- (iv) the road leading from the A22 to the anti-clockwise carriageway of the motorway at Junction 6 near Godstone,
- (v) the road leading from the anti-clockwise carriageway of the motorway to the A217 at Junction 8 near Reigate,
- (vi) the road leading from the clockwise carriageway of the motorway to the A243 and the A245 at Junction 9 at Leatherhead,
- (vii) the road leading from the anti-clockwise carriageway of the motorway to the A243 and the A244 at Junction 9 at Leatherhead,
- (viii) the road leading from the clockwise carriageway of the motorway to the A3 (Portsmouth Road) at Junction 10 at Wisley Interchange,

- (ix) the road leading from the A3 (Portsmouth Road) to the clockwise carriageway of the motorway at Junction 10 at Wisley Interchange,
- (x) the road leading from the anti-clockwise carriageway of the motorway to the A3 (Portsmouth Road) at Junction 10 at Wisley Interchange, or
- (xi) the road leading from the A3 (Portsmouth Road) to the anti-clockwise carriageway of the motorway at Junction 10 at Wisley Interchange;

"works" mean cyclic maintenance and/or urgent repair work on the motorway; and

"a works period" means a period of -

- (i) 8 hours starting at 2200 hours on Saturday 15th January 2011 or on any subsequent Saturday,
- (ii) 7 hours starting at 2230 hours on Sunday 16th January 2011 or on any subsequent Sunday,
- (iii) 7<sup>1</sup>/<sub>2</sub> hours starting at 2200 hours on Monday 17th January 2011 or on any subsequent day other than a Friday, Saturday or Sunday, or
- (iv) 7 hours starting at 2300 hours on Friday 21st January 2011 or on any subsequent Friday,

until Saturday 14th January 2012.

**3.** Subject as mentioned in article 4 below, no person shall, during a works period, cause or permit any vehicle to enter or proceed in a slip road.

**4.** The provisions of article 3 above shall apply only at such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to -

- (a) a vehicle being used in connection with the said works;
- (b) a vehicle being used for police, ambulance, fire and rescue authority or traffic officer purposes;
- (c) anything done at the direction of, or with the permission of, a constable or traffic officer in uniform; or
- (d) any vehicle being used for winter maintenance purposes.
