ROAD TRAFFIC

The A590 Trunk Road (Roam Bridge Layby Improvement Scheme) (Temporary Prohibition of Traffic) Order 2011

Made - - - - - *28th December 2011*

Coming into force - - - *15th January 2012*

WHEREAS the Secretary of State for Transport, being the traffic authority for the A590 Trunk Road, is satisfied that traffic on that road in the District of South Lakeland in the County of Cumbria should be prohibited because works are proposed to be executed thereon:

NOW, THEREFORE, the Secretary of State, in exercise of the powers conferred by section 14(1)(a) of the Road Traffic Regulation Act 1984(a), hereby makes the following Order:-

1. This Order may be cited as the A590 Trunk Road (Roam Bridge Layby Improvement Scheme) (Temporary Prohibition of Traffic) Order 2011 and shall come into force on 15th January 2012.

2. In this Order:

“the trunk road” means the A590 Trunk Road;

“the layby to be closed” means the layby adjacent to the eastbound carriageway of the trunk road at a point 210 metres west of the end of the kerbed central reserve nosing at the western end of the dual carriageway section of the trunk road;

“the works period” means a period starting at 0800 hours on Monday 16 January 2012 and ending at 1630 hours on Wednesday 18 January 2012. Works may start and continue beyond these dates for such period not exceeding 18 months as shall be required to complete the work;

“works” means geotechnical surveying works on the trunk road;

“layby” means an area of carriageway, intended for the waiting of vehicles, bounded partly by a road marking on the outer edge of that carriageway complying with diagram 1010 in Schedule 6 to the Traffic Signs Regulations and General Directions 2002 (b);

3. Subject as mentioned in article 4 of this Order, during the works period, no person shall cause or permit any vehicle to enter or proceed in the layby to be closed.

4. The provisions of article 3 of this Order shall apply only during such times and to such extent as shall from time to time be indicated by traffic signs, and shall not apply to a vehicle being used for emergency purposes by the police, fire and rescue authority or ambulance services or anything done at the direction, or with the permission, of a constable, or a traffic officer in uniform.
