The Additional Statutory Paternity Pay (General) (Amendment) Regulations 2011

The Secretary of State makes the following Regulations in exercise of the power conferred by section 171ZEE(2) of the Social Security Contributions and Benefits Act 1992⁽¹⁾ and after agreement by the Social Security Advisory Committee that the proposals in respect of these Regulations shall not be referred to it⁽²⁾.

Citation and commencement

1. These Regulations may be cited as the Additional Statutory Paternity Pay (General) (Amendment) Regulations 2011 and shall come into force on 1st April 2011.

Amendment to the Additional Statutory Paternity Pay (General) Regulations 2010

2. In regulation 14 of the Additional Statutory Paternity Pay (General) Regulations 2010⁽³⁾ (additional statutory paternity pay period (adoption)), in paragraph (1), for “before” substitute “after”.

(2) Section 173(1)(b) of the Social Security Administration Act 1992 ([c.5](#)) provides that proposals in respect of regulations which would otherwise be referable to the Social Security Advisory Committee may not be so referred with the agreement of that Committee. The proposals in respect of these Regulations would otherwise be referable to that Committee by virtue of section 172(1) of that Act.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations, issued free of charge, amend the Additional Statutory Paternity Pay (General) Regulations 2010 (“the Principal Regulations”) to correct a drafting error in regulation 14 of those Regulations. The error concerns the date of the beginning of the additional statutory paternity pay period (adoption).

An impact assessment has not been prepared for these Regulations since they have the same effect on the costs to business and the voluntary sector as the Principal Regulations.
