 - (b) section 38 (duty of smaller authorities to publish information) so far as it is not yet in force.

This Order brings into force on the day after the day on which it is made section 38 (duty of smaller authorities to publish information) of the Local Audit and Accountability Act 2014, which amends section 2 of the Local Government, Planning and Land Act 1980, to the extent that it is not already in force. It also brings into force on that day sections 5 (modification of Act in relation to smaller authorities) and 6 (meaning of "smaller authority") of the 2014 Act in so far as they relate to the amendments made by section 38.
