The Secretary of State makes the following Order in exercise of the powers conferred by section 1(4), (6) and (7) of the Gambling (Licensing and Advertising) Act 2014(a).

Title and commencement

1. The title of this Order is the Gambling (Licensing and Advertising) Act 2014 (Transitional Provisions) (Amendment) Order 2014 and it comes into force on 16th July 2014.

2. In article 2(1)(d) of the Gambling (Licensing and Advertising) Act 2014 (Transitional Provisions) Order 2014(b), after “Gibraltar,” insert “the Isle of Man,”.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the definition of “relevant state” in article 2(1)(d) of the Gambling (Licensing and Advertising) Act 2014 (Transitional Provisions) Order 2014 (S.I. 2014/1641) (“the 2014 Order”) so as to include a reference to the Isle of Man which was omitted in error.

The 2014 Order provides for the transitional arrangements that will apply in respect of advance applications made under the Gambling Act 2005 for, or to vary, a remote operating licence in

anticipation of the coming into force of the new licensing requirement in subsections 1(1)(and (2) of the Gambling (Licensing and Advertising) Act 2014 (“the 2014 Act”).
