The Welfare Reform Act 2012 (Commencement No. 22 and Transitional and Transitory Provisions) Order 2015

The Secretary of State for Work and Pensions makes the following Order, in exercise of the powers conferred by section 150(3) and (4)(a), (b)(i) and (c) of the Welfare Reform Act 2012<sup>M1</sup>:

## Citation

**1.** This Order may be cited as the Welfare Reform Act 2012 (Commencement No. 22 and Transitional and Transitory Provisions) Order 2015.

#### Interpretation

**2.**—(1) In this Order—

"the 2015 Amendment Order" means the Welfare Reform Act 2012 (Commencement No. 9, 11, 13, 14, 16, 17 and 19 and Transitional and Transitory Provisions (Amendment)) Order  $2015^{M2}$ ;

"the Act" means the Welfare Reform Act 2012;

"the amending provisions" means the provisions referred to in article 4(1)(a) to (c) of the No. 9 Order (day appointed for the abolition of income-related employment and support allowance and income-based jobseeker's allowance)<sup>M3</sup>;

"the Claims and Payments Regulations 1987" means the Social Security (Claims and Payments) Regulations 1987<sup>M4</sup>;

"claimant"-

(a) in relation to an employment and support allowance, has the same meaning as in Part 1 of the Welfare Reform Act 2007 <sup>M5</sup>;

- (b) in relation to a jobseeker's allowance, has the same meaning as in the Jobseekers Act 1995 <sup>M6</sup> (as it applies apart from the amendments made by Part 1 of Schedule 14 to the Act that remove references to an income-based jobseeker's allowance);
- (c) in relation to universal credit, has the same meaning as in Part 1 of the Act  $^{M7}$ ;

"employment and support allowance" means an employment and support allowance under Part 1 of the Welfare Reform Act 2007;

"First-tier Tribunal" has the same meaning as in the Social Security Act 1998 <sup>M8</sup>;

"Index of Relevant Districts" means the Index of Relevant Districts issued by the Department for Work and Pensions on 10th February 2015<sup>M9</sup>;

"jobseeker's allowance" means a jobseeker's allowance under the Jobseekers Act 1995;

"the No. 9 Order" means the Welfare Reform Act 2012 (Commencement No. 9 and Transitional and Transitory Provisions and Commencement No 8 and Savings and Transitional Provisions (Amendment)) Order 2013;

"Upper Tribunal" has the same meaning as in the Social Security Act 1998.

(2) In this Order, "gateway conditions" means the conditions specified in Schedule 5 to the No. 9 Order <sup>M10</sup>—

- (a) as that Schedule has effect apart from the amendments made by article 4(5)(b) of the 2015 Amendment Order;
- (b) as if that Schedule, as it has effect under sub-paragraph (a), were amended in accordance with paragraph (4) of this article; and
- (c) in relation to a case where a claim for universal credit, an employment and support allowance or a jobseeker's allowance is made or treated as made on or after 6th April 2015, as if, in paragraph 4(1) of that Schedule, as that Schedule has effect under sub-paragraph (b), for "£330" there were substituted "£338".

(3) In this Order, references to numbered "relevant districts" are to the postcode districts and partdistricts specified in the first column of the table in the Index of Relevant Districts corresponding to the number relating to those relevant districts that is specified in the third column of that table.

(4) The amendments to Schedule 5 to the No. 9 Order (gateway conditions) referred to in subparagraph (2)(b) are—

- (a) after paragraph 1(a) (personal characteristics)<sup>M11</sup> insert—
  - "(b) a single person (where that expression has the meaning given by section 40 of the Act);";
- (b) for paragraph 4 (income and capital)<sup>M12</sup> substitute—

"4.—(1) The claimant must declare that, during the period of one month starting with the date on which the claim for universal credit is made, the claimant's earned income is expected not to exceed  $\pm 330$ .

(2) The claimant's capital must not exceed  $\pounds 6,000$ .

(3) For the purposes of this paragraph, "earned income" and "capital" have the same meanings as they have in Part 6 of the Universal Credit Regulations.";

(c) in paragraph 8 (declarations)—

(i) in sub-paragraph (1) omit ", 4(2)";

(ii) omit sub-paragraph (2).

(5) For the purposes of this Order, the Universal Credit, Personal Independence Payment, Jobseeker's Allowance and Employment and Support Allowance (Claims and Payments) Regulations 2013 <sup>M13</sup> apply for the purposes of deciding—

- (a) whether a claim for universal credit is made; and
- (b) the date on which such a claim is made.

(6) For the purposes of this Order, the Claims and Payments Regulations 1987 apply, subject to paragraphs (7) and (8), for the purposes of deciding—

- (a) whether a claim for an employment and support allowance or a jobseeker's allowance is made; and
- (b) the date on which the claim is made or treated as made.
- (7) Subject to paragraph (8), for the purposes of this Order-
  - (a) a person makes a claim for an employment and support allowance or a jobseeker's allowance if he or she takes any action which results in a decision on a claim being required under the Claims and Payments Regulations 1987; and
  - (b) it is irrelevant that the effect of any provision of those Regulations is that, for the purposes of those Regulations, the claim is made or treated as made at a date that is earlier than the date on which that action is taken.
- (8) Where, by virtue of-
  - (a) regulation 6(1F)(b) or (c) of the Claims and Payments Regulations 1987 <sup>M14</sup>, in the case of a claim for an employment and support allowance; or
  - (b) regulation 6(4ZA) to (4ZD) and (4A)(a)(i) and (b) of those Regulations <sup>M15</sup>, in the case of a claim for a jobseeker's allowance,

a claim for an employment and support allowance or a jobseeker's allowance is treated as made at a date that is earlier than the date on which the action referred to in paragraph (7)(a) is taken, the claim is treated as made on that earlier date.

#### Day appointed for the coming into force of the universal credit provisions

**3.**—(1) The day appointed for the coming into force of the provisions of the Act listed in Schedule 2 to the No. 9 Order, in so far as they are not already in force, in relation to a claim referred to in paragraph (2), and any award that is made in respect of the claim, is the day appointed in accordance with paragraph (3).

- (2) The claims referred to are—
  - (a) a claim for universal credit that is made on or after 16th February 2015 in respect of a period that begins on or after 16th February 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 29 relevant districts and meets the gateway conditions;
  - (b) a claim for universal credit that is made on or after 23rd February 2015 in respect of a period that begins on or after 23rd February 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 30 relevant districts and meets the gateway conditions;
  - (c) a claim for universal credit that is made on or after 2nd March 2015 in respect of a period that begins on or after 2nd March 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 31 relevant districts and meets the gateway conditions;
  - (d) a claim for universal credit that is made on or after 9th March 2015 in respect of a period that begins on or after 9th March 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 32 relevant districts and meets the gateway conditions;
  - (e) a claim for universal credit that is made on or after 16th March 2015 in respect of a period that begins on or after 16th March 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 33 relevant districts and meets the gateway conditions;
  - (f) a claim for universal credit that is made on or after 23rd March 2015 in respect of a period that begins on or after 23rd March 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 34 relevant districts and meets the gateway conditions;
  - (g) a claim for universal credit that is made on or after 13th April 2015 in respect of a period that begins on or after 13th April 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 35 relevant districts and meets the gateway conditions;
  - (h) a claim for universal credit that is made on or after 20th April 2015 in respect of a period that begins on or after 20th April 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 36 relevant districts and meets the gateway conditions;
  - (i) a claim for universal credit that is made on or after 27th April 2015 in respect of a period that begins on or after 27th April 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 37 relevant districts and meets the gateway conditions;
  - (j) a claim for universal credit that is made on or after 4th May 2015 in respect of a period that begins on or after 4th May 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 38 relevant districts and meets the gateway conditions;
  - (k) a claim for universal credit that is made on or after 11th May 2015 in respect of a period that begins on or after 11th May 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 39 relevant districts and meets the gateway conditions;

- a claim for universal credit that is made on or after 18th May 2015 in respect of a period that begins on or after 18th May 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 40 relevant districts and meets the gateway conditions;
- (m) a claim for universal credit that is made on or after 25th May 2015 in respect of a period that begins on or after 25th May 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 41 relevant districts and meets the gateway conditions;
- (n) a claim for universal credit that is made on or after 1st June 2015 in respect of a period that begins on or after 1st June 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 42 relevant districts and meets the gateway conditions;
- (o) a claim for universal credit that is made on or after 8th June 2015 in respect of a period that begins on or after 8th June 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 43 relevant districts and meets the gateway conditions;
- (p) a claim for universal credit that is made on or after 15th June 2015 in respect of a period that begins on or after 15th June 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 44 relevant districts and meets the gateway conditions;
- (q) a claim for universal credit that is made on or after 22nd June 2015 in respect of a period that begins on or after 22nd June 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 45 relevant districts and meets the gateway conditions;
- (r) a claim for universal credit that is made on or after 29th June 2015 in respect of a period that begins on or after 29th June 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 46 relevant districts and meets the gateway conditions;
- (s) a claim for universal credit that is made on or after 6th July 2015 in respect of a period that begins on or after 6th July 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 47 relevant districts and meets the gateway conditions;
- (t) a claim for universal credit that is made on or after 13th July 2015 in respect of a period that begins on or after 13th July 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 48 relevant districts and meets the gateway conditions;
- (u) a claim for universal credit that is made on or after 20th July 2015 in respect of a period that begins on or after 20th July 2015 where, on the date on which the claim is made, the claimant resides in one of the No. 49 relevant districts and meets the gateway conditions;
- (v) a claim for universal credit that is made on or after the date referred to in any of subparagraphs (a) to (u), in respect of a period that begins on or after that date where—
  - (i) the claimant gives incorrect information regarding the claimant residing in a district as referred to in the sub-paragraph in question or meeting the gateway conditions and the claimant does not reside in such a district or does not meet the gateway conditions on the date on which the claim is made; and
  - (ii) after a decision is made that the claimant is entitled to universal credit and one or more payments have been made in respect of the claimant, the Secretary of State discovers that incorrect information has been given regarding residence or meeting the gateway conditions.

(3) The day appointed in relation to a claim referred in paragraph (2), and any award that is made in respect of the claim, is the first day of the period in respect of which the claim is made.

(4) Article 3(6) of the No. 9 Order applies for the purposes of paragraph (3) as it applies for the purposes of article 3(4)(a) of the No. 9 Order.

(5) Article 3A of the No. 9 Order <sup>M16</sup> applies in connection with a claim for universal credit where a claimant gives incorrect information regarding his or her residing in one of the No. 29, No. 30, No. 31, No. 32, No. 33, No. 34, No. 35, No. 36, No. 37, No. 38, No. 39, No. 40, No. 41, No. 42, No. 43, No. 44, No. 45, No. 46, No. 47, No. 48, or No. 49 relevant districts or meeting the gateway

conditions, as it applies in connection with the giving of incorrect information regarding a claimant residing in a relevant district (as defined in the No. 9 Order) or meeting the gateway conditions (as defined in the No. 9 Order)<sup>M17</sup>.

- (qq) a claim for universal credit that is made on or after the date referred to in any of subparagraphs (a), (c), (e), (g), (i), (k), (m), (o), (q), (s), (u), (w), (y), (aa), (cc), (ee), (gg), (ii), (kk), (mm) or (oo), in respect of a period that begins on or after that date, where—
  - (i) the claimant gives incorrect information regarding the claimant residing in a district as referred to in the sub-paragraph in question or meeting the gateway conditions and the claimant does not reside in such a district or does not meet the gateway conditions on the date on which the claim is made; and

- (ii) after a decision is made that the claimant is entitled to universal credit and one or more payments have been made in respect of the claimant, the Secretary of State discovers that incorrect information has been given regarding residence or meeting the gateway conditions:
- (rr) a claim for an employment and support allowance or a jobseeker's allowance other than (dd), (ff), (hh), (jj), (ll), (nn) or (pp) that is made or treated as made during the relevant period by a claimant of universal credit who has made a claim for universal credit within this paragraph.

(3) The day appointed in relation to a claim referred to in paragraph (2), and any award that is made in respect of the claim, is the first day of the period in respect of which the claim is made.

(4) For the purposes of paragraph (2)(rr), the "relevant period" means, in relation to a claim for universal credit within paragraph (2), any UC claim period and any period subsequent to any UC claim period in respect of which the claimant is entitled to an award of universal credit in respect of the claim

- (5) For the purposes of paragraph (4), a "UC claim period" is a period when-
  - (a) a claim for universal credit within one of the sub-paragraphs (a), (c), (e), (g), (i), (k), (m), (o), (q), (s), (u), (w), (v), (aa), (cc), (ee), (gg), (ii), (kk), (mm), (oo) or (qq)(i) of paragraph (2) has been made but a decision has not yet been made on the claim; or
  - (b) a decision has been made that the claimant is not entitled to universal credit and—
    - (i) the Secretary of State is considering whether to revise that decision under section 9 of the Social Security Act 1998, whether on an application made for that purpose or on the Secretary of State's own initiative; or
    - (ii) the claimant has appealed against that decision to the First-tier Tribunal and that appeal or any subsequent appeal to the Upper Tribunal or to a court has not been finally determined.

(6) Paragraphs (6), (7), (9) and (10) of article 4 of the No. 9 Order <sup>M18</sup> apply in relation to a claim for universal credit referred to in paragraph (2) (and any award that is made in respect of the claim) as they apply to a claim for universal credit referred to in sub-paragraphs (a) and (b) of article 4(2) of the No. 9 Order (and any award that is made in respect of the claim).

(7) Article 5(1)(a) of the No. 9 Order <sup>M19</sup> applies for the purposes of the sub-paragraphs (relating to a claim for an employment and support allowance or a jobseeker's allowance) referred to in subparagraph (rr) as it applies for the purposes of article 4(2)(a) of the No. 9 Order.

(8) Article 5(8) of the No. 9 Order applies for the purposes of paragraph (3) as it applies for the purposes of article 4(3)(a) of the No. 9 Order.

### **EXPLANATORY NOTE**

#### (This note is not part of the Order)

This Order brings into force provisions of the Welfare Reform Act 2012 (c. 5) ("the Act") that relate to universal credit ("UC") and the abolition of income-related employment and support allowance and income-based jobseeker's allowance, in relation to the cases set out in articles 3 and 4.

Article 2 defines the gateway conditions, which are the requirements to be met to make a claim for UC. They are set out in Schedule 5 to the Welfare Reform Act 2012 (Commencement No. 9 and Transitional and Transitory Provisions and Commencement No. 8 and Savings and Transitional Provisions (Amendment)) Order 2013 (S.I. 2013/983 (C. 41) ("the No. 9 Order")) and have effect apart from the amendments made by article 4(5)(b) of the Welfare Reform Act 2012 (Commencement No. 9, 11, 13, 14, 16, 17 and 19 and Transitional and Transitory Provisions (Amendment)) Order 2015 (S.I. 2015/32 (C.3)) ("the 2015 Amendment Order"). The 2015 Amendment Order removed the condition that a claimant must not, for the majority of cases, have responsibility for children or young persons. By article 2(2)(a), this Order applies that condition for claims made with respect to the areas to which this Order applies.

The gateway conditions are also modified by article 2(2)(b) and (4) to require that a claimant must be single ("the modified gateway conditions").

Article 2(2)(c) has the effect that the same amendment is made to the modified gateway conditions as is made by the amendment to the gateway conditions in Schedule 5 by article 5(a)(i) of the 2015 Amendment Order. The amendment increases the maximum earnings threshold in the modified gateway conditions and takes effect, as does the amendment under the 2015 Amendment Order, on or after 6th April 2015 for claims made or treated as made on or after that date. Article 3 brings into force provisions relating to UC in Part 1 of the Act ("the UC provisions"), as set out in Schedule 2 to the No. 9 Order, in relation to a number of different cases as set out below. Under article 3(2)(a) to (u), the UC provisions come into force in relation to a claim for UC and any award that is made in respect of the claim, where the claim is made on or after a specified date with respect to a period that begins on or after that date and, on the date on which the claim is made, the claimant resides in a specified area and complies with the modified gateway conditions as set out in Schedule 5 to the No. 9 Order. The specified dates and areas are as follows–

- (a) 16th February 2015: the No. 29 relevant districts;
- (b) 23rd February 2015: the No. 30 relevant districts;
- (c) 2nd March 2015: the No. 31 relevant districts;
- (d) 9th March 2015: the No. 32 relevant districts;
- (e) 16th March 2015: the No. 33 relevant districts;
- (f) 23rd March 2015: the No. 34 relevant districts;
- (g) 13th April 2015: the No. 35 relevant districts;
- (h) 20th April 2015: the No. 36 relevant districts;
- (i) 27th April 2015: the No. 37 relevant districts;
- (j) 4th May 2015: the No. 38 relevant districts;
- (k) 11th May 2015: the No. 39 relevant districts;
- (l) 18th May 2015: the No. 40 relevant districts;
- (m) 25th May 2015: the No. 41 relevant districts;

- (n) 1st June 2015: the No. 42 relevant districts;
- (o) 8th June 2015: the No. 43 relevant districts;
- (p) 15th June 2015: the No. 44 relevant districts;
- (q) 22nd June 2015: the No. 45 relevant districts;
- (r) 29th June 2015: the No. 46 relevant districts;
- (s) 6th July 2015: the No. 47 relevant districts;
- (t) 13th July 2015: the No. 48 relevant districts;
- (u) 20th July 2015: the No. 49 relevant districts.

The postcodes and part-postcodes in each of the numbered relevant districts are set out in the table contained in the document entitled Index to Relevant Districts, issued by the Department for Work and Pensions on the date of making of this Order. The postcodes and part-postcodes are set out in the first column of the table and cross-refer to the relevant number in the third column. The document is available alongside this Order in the libraries of both Houses of Parliament and may also be obtained free of charge from the UC Policy Division of the Department for Work and Pensions, Level 3E, Caxton House, 6-12 Tothill Street, London, SW1H 9NA, in hard copy, or from the Gov.UK website, in soft copy, at: https://www.gov.uk/government/publications/universal-credit-national-expansion.

Under article 3(2)(v), the UC provisions come into force in relation to a claim for UC and any award that is made in respect of the claim where the claimant claims UC on or after the date specified in any of sub-paragraphs (a) to (u) of article 3(2), in respect of a period that begins on or after that date, and provides incorrect information regarding the claimant residing in the area specified in that sub-paragraph or meeting the modified gateway conditions, but this is only discovered once payments of UC have been made.

Under article 3(3), the day appointed for the commencement of the UC provisions in the above cases is the first day of the period in respect of which the claim is made.

Paragraphs (4) and (5) of article 3 apply the provisions of article 3(6) (period for which a claim for universal credit is made) and article 3A (incorrect information regarding entitlement to claim universal credit) of the No. 9 Order respectively to the cases in article 3(2) of this Order. Article 4 brings into force provisions of the Act relating to the abolition of income-related employment and support allowance and of income-based jobseeker's allowance ("the amending provisions"), in relation to a number of different cases as referred to below.

Under article 4(1) and sub-paragraphs (a), (c), (e), (g), (i), (k), (m), (o), (q), (s), (u), (w), (y), (aa), (cc), (ee), (gg), (ii), (kk), (mm) and (oo) of paragraph (2), the amending provisions come into force in relation to a claim for UC, and any award that is made in respect of the claim, where the claim is made on or after the date specified in any of those sub-paragraphs with respect to a period that begins on or after that date and, on the date on which the claim is made, the claimant resides in the area specified in that sub-paragraph and complies with the modified gateway conditions. (The specified dates and areas are the same as those listed above in connection with the coming into force of the UC provisions).

Under article 4(1) and (2)(qq), the amending provisions come into force in relation to a claim for UC, and any award that is made in respect of the claim, where a claimant claims UC on or after the date specified in relation to a claim for UC within one of the sub-paragraphs of article 4(2) referred to in the previous paragraph in respect of a period that begins on or after that date and provides incorrect information regarding the claimant residing in the area specified in that sub-paragraph or meeting the modified gateway conditions, but this is only discovered once payments of UC have been made.

Under article 4(1) and sub-paragraphs (b), (d), (f), (h), (j), (l), (n), (p), (r), (t), (v), (x), (z), (bb), (dd), (ff), (hh), (jj), (ll) (nn) and (pp) of paragraph (2) ("the relevant ESA and JSA claiming provisions"), the amending provisions come into force in relation to a claim for ESA or JSA, and any award that is made in respect of the claim, where the claim is made on or after the date

specified in any of those sub-paragraphs and, on the date on which the claim is made, the claimant resides in the area specified in that sub-paragraph and complies with the modified gateway conditions. (Again, the specified dates and areas are the same as those listed above in connection with the coming into force of the UC provisions).

Under article 4(1) and (2)(rr), the amending provisions come into force in relation to the case of a claim for ESA or JSA where the claim is not a claim for ESA or JSA as referred to in the relevant ESA and JSA claiming provisions and where the claim is made during the "relevant period" (mainly the period when a claim for UC is being considered or an award of UC is extant). Under article 4(3), the day appointed for the coming into force of the amending provisions in the above cases is the first day of the period in respect of which the claim is made. Paragraphs (6) to (8) of article 4 (conversion of awards of incapacity benefit and severe disablement allowance, old-style ESA and JSA awards) apply the provisions of article 4(6), (7), (9) and (10), and article 5(1)(a) (interpretation of Schedule 5 to the No. 9 Order) and (8) (the

period for which a claim for ESA, JSA or UC is made) of the No. 9 Order to the cases in article 4(2).

Article 5 provides that articles 9 to 22 of the No. 9 Order (transitional provisions) apply in connection with the coming into force of the amending provisions in relation to the case of a claim referred to in article 4(2), and any award made in respect of the claim, as they apply in connection with the coming into force of the amending provisions in relation to the case of a claim referred to in article 4(2)(a), (b) or (g) of the No. 9 Order, and any award made in respect of the claim. Article 6, with effect from 16th February 2015, modifies the Universal Credit (Digital Service) Amendment Regulations 2014 (S.I. 2014/2887) so as those Regulations have effect as if they do not apply to the case of an award of UC made by virtue of this Order (unless one of the exceptions in regulation 5 of those Regulations applies).

Article 7 renumbers as (9) and (10) the paragraphs of article 4 of the No. 9 Order previously added as (8) and (9) by article 4(3) of the 2015 Amendment Order and makes consequential provisions. This corrects a drafting error, as paragraph (8) had already been added to article 4 of the No. 9 Order by article 7(2)(c)(ii) of the Welfare Reform Act 2012 (Commencement No. 20 and Transitional and Transitory Provisions and Commencement No. 9 and Transitional and Transitory Provisions (Amendment)) Order 2014 (S.I. 2014/3094 (C. 133)).
