**The Registration of Consultant Lobbyists (Amendment)
Regulations 2015**

The Chancellor of the Duchy of Lancaster makes these Regulations in exercise of the power conferred by section 22(2) of the Transparency of Lobbying, Non-Party Campaigning and Trade Union Administration Act 2014(a).

Citation and extent

1.—(1) These Regulations may be cited as the Registration of Consultant Lobbyists (Amendment) Regulations 2015.

(2) These Regulations extend to the United Kingdom.

(3) These Regulations come into force on 28th July 2015.

Amendment of the Registration of Consultant Lobbyists Regulations 2015

2. In Regulation 5(1)(b) of the Registration of Consultant Lobbyists Regulations 2015(b) for “paragraph (1)” substitute “section 5(1)”.
