**The Health and Social Care (Miscellaneous Revocations)
Regulations 2015**

The Secretary of State makes these Regulations in exercise of the powers in the enactments specified in the Schedule.

Citation and commencement

1.—(1) These Regulations may be cited as the Health and Social Care (Miscellaneous Revocations) Regulations 2015.

(2) These Regulations come into force on 1st July 2015.
