#### SERVICE OF DOCUMENTS

##### *Service out of the jurisdiction*

#### Scope and interpretation

**6.11.**—(1) This rule and rules 6.12 to 6.19 make provision about—

- (a) service of application forms and other documents out of the jurisdiction; and
- (b) the procedure for service.

(2) In this rule and rules 6.12 to 6.19—

“application form” includes an application notice;

“Commonwealth State” means a State listed in Schedule 3 to the British Nationality Act 1981

“jurisdiction” means, unless the context otherwise requires, England and Wales and any part  
of the territorial waters of the United Kingdom adjoining England and Wales;

“the Service Convention” means the Convention on the service abroad of judicial and extra-  
judicial documents in civil or commercial matters signed at the Hague on November 15, 1965;

“Service Convention country” means a country<sup>F2</sup>... which is a party to the Service Convention;

(3) In rules 6.12 to 6.19, a reference to service by a party includes service by a person who is not  
a party where service by such a person is required under these Rules.
