  - (a) in the entry for Birmingham for "10" substitute "4";
  - (b) in the entry for Coventry for "3" substitute "2";
  - (c) in the entry for Dudley for "3" substitute "2";
  - (d) in the entry for Sandwell for "3" substitute "2";
  - (e) in the entry for Solihull for "2" substitute "1";
  - (f) in the entry for Walsall for "3" substitute "2";
  - (g) in the entry for Wolverhampton for "3" substitute "2".
