11. Any body established pursuant to an order under section 67 of the Local Government Act 1985 (successors to residuary bodies).
12. The London Fire and Emergency Planning Authority as reconstituted by section 328 of the Greater London Authority Act 1999⁽⁸⁾.
13. The Scottish Fire and Rescue Service established under section 1A of the Fire (Scotland) Act 2005⁽⁹⁾.
14. An internal drainage board which is being continued by virtue of section 1 of the Land Drainage Act 1991⁽¹⁰⁾.
15. Transport for London as established under section 154 of the Greater London Authority Act 1999⁽¹¹⁾.
