Amendment of the Provision of Services Regulations 2009

Amendment of regulation 6 (relationship with other requirements)

- 6.—(1) In regulation 6(1), omit “, 5”.
- (2) In regulation 6(2)—
- (a) in sub-paragraph (a), after “enactment” insert “ other than retained direct EU legislation ”^{M1};
 - (b) for sub-paragraph (a)(ii) substitute—
“(ii) immediately before [^{F1}IP completion day], the provision implemented an EU obligation, and”;
 - (c) in sub-paragraph (b), for “a directly applicable EU instrument” substitute “ retained direct EU legislation ”;
 - (d) for sub-paragraph (b)(ii) substitute—
“(ii) immediately before [^{F2}IP completion day], the provision was contained in an EU instrument that came into force before these Regulations were made.”.
- (3) In regulation 6(3), omit “or 4”.
- (4) In regulation 6(4)—
- (a) in sub-paragraph (a), after “enactment” insert “ other than retained direct EU legislation ”;
 - (b) in sub-paragraph (b), for “a directly applicable EU instrument” substitute “ retained direct EU legislation ”;
 - (c) for sub-paragraph (b)(ii) substitute—
“(ii) immediately before [^{F3}IP completion day], the provision was contained in an EU instrument that came into force before these Regulations were made.”.
