**The Designation of Rural Primary Schools (England) Order  
2018**

*Made* - - - - *18th December 2018*

*Coming into force* - - *27th December 2018*

The Secretary of State makes the following Order in exercise of the powers conferred by section 15(7)(b) of the Education and Inspections Act 2006(a).

**Citation and commencement**

1. This Order may be cited as the Designation of Rural Primary Schools (England) Order 2018 and comes into force on 27th December 2018.

**Designation of rural primary schools**

2. The schools in the list called “List of designated rural primary schools 2018”, published on the Gov.uk website on 18th December 2018, are designated as rural primary schools in England.

**Revocation**

3. The Designation of Rural Primary Schools (England) Order 2017(b) is revoked.

**EXPLANATORY NOTE**

*(This note is not part of the Order)*

This Order designates certain primary schools, in England, as rural primary schools for the purpose of section 15 of the Education and Inspections Act 2006. It also revokes the Designation of Rural Primary Schools (England) Order 2017.

Section 15 of the Education and Inspections Act 2006 requires that when either a local authority or governing body of certain schools formulates proposals for the discontinuance of a designated rural primary school it has regard to specific factors. These factors include the likely effect of discontinuance on the local community and any alternatives to the discontinuance of the school. Before publishing proposals for discontinuance the local authority or governing body must consult certain persons, including parents and, where the local authority is a county council, any district and parish councils.

This Order designates rural primary schools by reference to a list of such schools published on 18th December 2018 on the Gov.uk website at: <https://www.gov.uk/government/publications/rural-primary-schools-designation>. When considering proposals to discontinue these schools, local authorities and governing bodies should refer to this list. A copy may also be obtained by writing to the Department for Education at the following address: School Organisation Policy Unit, Department for Education, Level 3, Bishopsgate House, Darlington, DL1 5QE.

A full regulatory impact assessment has not been produced for this instrument as no, or no significant, impact on the private or voluntary sector is foreseen.
