#### Consequential amendments and revocations

### PART 1

#### Consequential amendments

#### Road Traffic Act 1988

- 1.—(1) The Road Traffic Act 1988 <sup>M1</sup> is amended as follows.
- (2) In section 67 (testing of condition of vehicles on roads), omit subsection (9A) <sup>M2</sup>.
- (3) In section 85(1) (interpretation of Part 2)—
  - (a) in the definition of “EC certificate of conformity”<sup>M3</sup>, for paragraph (c), substitute—
    - “(c) in the case of a vehicle to which the tractor type approval Regulation applies, a certificate of conformity issued by a manufacturer under Article 33 of that Regulation;”;
  - (b) for the definition of “the tractor type approval Directive”<sup>M4</sup>, substitute—

““the tractor type approval Regulation” means Regulation (EU) No 167/2013 of the European Parliament and of the Council of 5th February 2013 on the approval and market surveillance of agricultural and forestry vehicles as it may be amended from time to time,”.
- (4) In section 86 (index to Part 2), for “Tractor type approval Directive”<sup>M5</sup>, substitute “Tractor type approval Regulation”.

#### [<sup>F1</sup>Amendment of the Motor Fuel (Composition and Content) Regulations 1999

**1A.** In regulation 5B(7)(c) of the Motor Fuel (Composition and Content) Regulations 1999, for “have the meanings given by Article 1 of Council [Directive 2000/25/EC](#)”, substitute “mean an agricultural or forestry vehicle (as appropriate) which is a tractor, within the meanings given by Articles 3 and 4 of Regulation (EU) No 167/2013 of the European Parliament and of the Council on the approval and market surveillance of agricultural and forestry vehicles, as it may be amended from time to time”.]

### **Amendment of the Supply of Machinery (Safety) Regulations 2008**

2. In paragraph 1(e)(i) of Schedule 3 to the Supply of Machinery (Safety) Regulations 2008 <sup>M6</sup>, for “Directive 2003/37/EC”, substitute “ Regulation (EU) No 167/2013 of the European Parliament and of the Council on the approval and market surveillance of agricultural and forestry vehicles <sup>M7</sup> as it may be amended from time to time ”.

### **Amendment of the Road Vehicles (Approval) Regulations 2009**

3. For regulation 5(2)(a) of the Road Vehicles (Approval) Regulations 2009 <sup>M8</sup>, substitute—  
“(a) tractors, trailers or interchangeable towed equipment (including their systems, components and separate technical units), as defined in Regulation (EU) No 167/2013 of the European Parliament and of the Council on the approval and market surveillance of agricultural and forestry vehicles <sup>M9</sup> as it may be amended from time to time;”.
