

## SCHEDULE 8

Regulation 11

### Persons who may not apply for a licence

1. A person who has at any time held a licence which was revoked under regulation 15 of these Regulations.

2. A person who has at any time held a licence which was revoked under regulation 17 of the Animal Welfare (Breeding of Dogs) (Wales) Regulations 2014 <sup>F1</sup>.

3. A person who has at any time held a licence which was revoked under regulation 13 of the Welfare of Wild Animals in Travelling Circuses (England) Regulations 2012 <sup>F2</sup>.

4. A person who is disqualified under section 33 of the Welfare of Animals Act (Northern Ireland) 2011 <sup>F3</sup>.

5. A person who has at any time held a licence which was revoked under regulation 12 of the Welfare of Racing Greyhounds Regulations 2010 <sup>F4</sup>.

6. A person who is disqualified under section 34 of the Act.

7. A person who is disqualified under section 40(1) and (2) of the Animal Health and Welfare (Scotland) Act 2006 <sup>F5</sup>.

8. A person who is disqualified under section 4(1) of the Dangerous Dogs Act 1991 <sup>F6</sup>.

9. A person who is disqualified under Article 33A of the Dogs (Northern Ireland) Order 1983 <sup>F7</sup>.

10. A person who is disqualified under section 6(2) of the Dangerous Wild Animals Act 1976 <sup>F8</sup> from keeping a dangerous wild animal.

11. A person who is disqualified under section 3(3) of the Breeding of Dogs Act 1973 <sup>F9</sup> from keeping a breeding establishment for dogs.

**13.** A person who is disqualified under section 3(3) of the [Animal Boarding Establishments Act 1963](#) <sup>F11</sup> from keeping a boarding establishment for animals.

**14.** A person who is disqualified under section 5(3) of the [Pet Animals Act 1951](#) <sup>F12</sup> from keeping a pet shop.

**15.** A person who is disqualified under section 1(1) of the [Protection of Animals \(Amendment\) Act 1954](#) <sup>F13</sup> from having custody of an animal.

**16.** A person who is disqualified under section 4(2) of the [Performing Animals \(Regulation\) Act 1925](#) <sup>F14</sup>.

**17.** A person who is disqualified under section 3 of the [Protection of Animals Act 1911](#) <sup>F15</sup> from the ownership of an animal.
