6. In the Enterprise Act 2002 (Part 8 Designated Enforcers: Criteria for Designation, Designation of Public Bodies as Designated Enforcers and Transitional Provisions) Order 2003 <sup>M1</sup>, in article 3 (criteria for designation)—

- (a) in paragraph (b), for “Community infringements” substitute “ Schedule 13 infringements ”;
- (b) in paragraph (f)—
  - (i) omit “and Community enforcers”;
  - (ii) for “Community infringements” substitute “ Schedule 13 infringements ”.
