**The M42 Junction 6 Development Consent (Correction) Order  
2020**

*Made* - - - - 20th October 2020

*Coming into force* - - 21st October 2020

The M42 Junction 6 Development Consent Order 2020 (“the Order”)(a), which granted development consent within the meaning of the Planning Act 2008 (“the Act”), contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act(b).

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, before the end of the relevant period, as defined in paragraph 1(6)(a) of Schedule 4 to the Act, the Secretary of State received a written request from the applicant(c) for the correction of errors and omissions in the Order.

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed Solihull Metropolitan Borough Council, as the local planning authority for the area in which the land to which the Order relates is situated, that the request has been received.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraphs 1(4) and (8) of Schedule 4 to, the Act, makes the following Order:

**Citation and commencement**

1. This Order may be cited as the M42 Junction 6 Development Consent (Correction) Order 2020 and comes into force on 21st October 2020.
