The Local Authorities and Police and Crime Panels (Coronavirus) (Flexibility of Local Authority and Police and Crime Panel Meetings) (England and Wales) Regulations 2020

PART 1

General

Citation, commencement, extent, and application

1. These Regulations may be cited as the Local Authorities and Police and Crime Panels (Coronavirus) (Flexibility of Local Authority and Police and Crime Panel Meetings) (England and Wales) Regulations 2020 and come into force on 4th April 2020.

Interpretation

3. In these Regulations—

"the 1972 Act" means the Local Government Act 1972 MI;

"local authority" means-

- (a) a county council;
- (b) a district council;
- (c) a London borough council;
- (d) the Common Council of the City of London;

- (r) [F1 a Mayoral development corporation established under section 198 of the Localism Act 2011;
- (s) an urban development corporation established under section 135 of the Local Government, Planning and Land Act 1980;
- (t) a parish meeting constituted under section 13 of the Local Government Act 1972;
- (u) Transport for London;]
- "local authority meeting" means a meeting of-
- (a) a local authority;
- (b) an executive of a local authority (within the meaning of Part 1A of the Local Government Act 2000) M10;
- (c) a joint committee of two or more authorities;
- (d) a committee or sub-committee of anything within paragraphs (a) to (c);
