The Immigration (Jersey) Order 2021

Citation, commencement and interpretation

1.—(1) This Order may be cited as the Immigration (Jersey) Order 2021 and comes into force on such day or days (after this Order has been registered by the Royal Court of Jersey) as the Minister may by Order appoint, and different days may be appointed for different provisions and for different purposes.

(3) In this Order—

"the Acts" means the Acts referred to in paragraph (2);

"the Minister" means the Minister for Home Affairs (of Jersey).

- (4) The Interpretation (Jersey) Law 1954(19) applies—
 - (a) to this Order;
 - (b) to the provisions of the Acts as extended by this Order; and
 - (c) in relation to an enactment made—,
 - (i) under this Order, or
 - (ii) under the provisions so extended,

as though this Order and the provisions so extended were a Law.

- (5) In construing the Acts as extended by this Order
 - (a) a reference to an enactment of the United Kingdom is a reference to that enactment as it has effect in Jersey;
 - (b) a reference to the Immigration Acts is a reference to the Immigration Acts of the United Kingdom as they have effect for the time being as extended to Jersey;
 - (c) a reference to the standard scale is a reference to the standard scale for the time being in the Schedule to the Criminal Justice (Standard Scale of Fines) (Jersey) Law 1993(20).
