## PUBLIC HEALTH, ENGLAND

The Health Protection (Coronavirus, International Travel) (England) (Amendment) (No. 14) Regulations 2021

Made - - - - at 8.45 a.m. on 7th May 2021

Laid before Parliament at 1.00 p.m. on 7th May 2021

Coming into force - - at 4.00 a.m. on 8th May 2021

The Secretary of State makes the following Regulations in exercise of the powers conferred by sections 45B, 45F(2) and 45P(2) of the Public Health (Control of Disease) Act 1984(a).

#### Citation, commencement, extent and application

- 1.—(1) These Regulations may be cited as the Health Protection (Coronavirus, International Travel) (England) (Amendment) (No. 14) Regulations 2021 and come into force at 4.00 a.m. on 8th May 2021.
  - (2) These Regulations extend to England and Wales and apply in relation to England only.

# Amendment of the Health Protection (Coronavirus, International Travel) (England) Regulations 2020

- **2.** In Schedule 3 (specified competitions) to the Health Protection (Coronavirus, International Travel) (England) Regulations 2020(**b**)—
  - (a) omit the following entries—

    - (vi) "World Snooker Tour Tour Championship";
    - (vii) "All-Weather Finals Day horse-racing";
    - (viii) "Aintree Grand National Meeting horse-racing";
      - (ix) "Challenger Series Finals Day horse-racing";
      - (x) "Cheltenham April Meeting horse-racing";
