The Cleve Hill Solar Park (Correction) Order 2021

Made - - - - *10th August 2021*

Coming into force - - *11th August 2021*

The Cleve Hill Solar Park Order 2020 (“the Order”)(1), which granted development consent within the meaning of the Planning Act 2008 (“the Act”)(2), contains correctable errors within the meaning of paragraph 1 of Schedule 4 to the Act.

Before the end of the relevant period (as defined in paragraph 1(6)(a) of Schedule 4 to the Act), the Secretary of State received a written request from the applicant(3) for the correction of errors and omissions in the Order under paragraph 1(5)(a) of Schedule 4 to the Act.

In accordance with paragraph 1(7) of Schedule 4 to the Act, the Secretary of State has informed Kent County Council, Swale Borough Council and Canterbury City Council, as the relevant local planning authorities(4), that the request has been received.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraphs 1(4) and 1(8) of Schedule 4 to, the Act, makes the following Order—

Citation and commencement

- 1.—(1) This Order may be cited as the Cleve Hill Solar Park (Correction) Order 2021.
- (2) This Order comes into force on 11th August 2021.
