**The Access to the Countryside (Coastal Margin)  
(Silecroft to Silverdale No. 1) Order 2022**

*Made* - - - - 4th February 2022

*Coming into force* - - 5th February 2022

The Secretary of State makes this Order in exercise of the powers conferred by section 3A(10) of the Countryside and Rights of Way Act 2000(1).

**Citation and commencement**

1. This Order may be cited as the Access to the Countryside (Coastal Margin) (Silecroft to Silverdale No. 1) Order 2022 and comes into force on the day after the day on which it is made.

**End of access preparation period**

2.—(1) In relation to land which is coastal margin as a result of the relevant approval, the day appointed as the day on which the access preparation period(2) ends is 08 February 2022.

(2) In paragraph (1), “the relevant approval” means the approval by the Secretary of State(3) under section 52(1) of the Act(4) of the relevant report on 12 November 2020.

(3) In paragraph (2), “the relevant report” means the report entitled “Coastal Access Beach car park, Silecroft to Green Road railway station” submitted by Natural England to the Secretary of State under sections 51 and 55A of the Act(5) on 08 January 2020(6).

(2) The term “access preparation period” is defined in section 3A(10) of the Countryside and Rights of Way Act 2000.

(3) The functions of the Secretary of State under sections 51 and 52 of the National Parks and Access to the Countryside Act 1949 (c. 97) were originally vested in the Minister of Town and Country Planning in relation to England and Wales (see section 114(1) of that Act). The Minister of Town and Country Planning was renamed the Minister of Local Government and Planning by S.I. 1951/142, and was further renamed the Minister of Housing and Local Government by S.I. 1951/1900. S.I. 1965/143 transferred (so far as relevant) the functions of the Minister of Housing and Local Government to the Minister of Land and Natural Resources. The Ministry of Land and Natural Resources was dissolved by S.I. 1967/156 and the functions of that Minister (so far as relevant) were transferred to the Minister of Housing and Local Government. The Ministry of Housing and Local Government was dissolved and the functions of that Minister were transferred to the Secretary of State by S.I. 1970/1681.

This Order appoints the day on which the access preparation period ends in relation to land which is coastal margin as a result of the approval by the Secretary of State of Natural England's proposals contained in a report relating to coastal access along part of the long-distance route between Silcroft and Silverdale.
