The Norfolk Boreas Offshore Wind Farm (Corrections) Order 2022

Made - - - - 11th August 2022

Coming into force - - 12th August 2022

The Norfolk Boreas Offshore Wind Farm Order 2021 ("the Order")(1), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(2), contained correctable errors within the meaning of the Act(3).
