# The Norfolk Boreas Offshore Wind Farm (Corrections) Order 2022

Made - - - - 11th August 2022

Coming into force 12th August 2022

The Norfolk Boreas Offshore Wind Farm Order 2021 ("the Order")(**a**), which granted development consent within the meaning of the Planning Act 2008 ("the Act")(**b**), contained correctable errors within the meaning of the Act(**c**).

In accordance with paragraph 1(5)(a) of Schedule 4 to the Act, and before the end of the relevant period (as defined in paragraph 1(6)(a) of Schedule 4 to the Act), the Secretary of State received a written request from the applicant(**d**) for the correction of errors and omissions in the Order.

The Secretary of State has informed the relevant local planning authorities to which the Order relates, that the request has been received in accordance with paragraph 1(7) of Schedule 4 to the Act.

The Secretary of State, in exercise of the powers conferred by section 119 of, and paragraphs 1(4) and (8) of Schedule 4 to, the Act, makes the following Order—

#### Citation and commencement

- **1.**—(1) This Order may be cited as the Norfolk Boreas Offshore Wind Farm (Corrections) Order 2022.
  - (2) This Order comes into force on 12th August 2022.
