CIVIL AVIATION

The Air Navigation (Restriction of Flying) (Balmoral to Edinburgh) Regulations 2022

Made - - - - 9th September 2022

Coming into force - - 10th September 2022

The Secretary of State has decided that it is necessary in the public interest to restrict flying in the area specified in regulation 3 by reason of arrangements associated with the death of Her late Majesty Queen Elizabeth II.

The Secretary of State makes the following Regulations in exercise of the powers conferred by article 239 of the Air Navigation Order 2016(a)

Citation and commencement

1. These Regulations may be cited as The Air Navigation (Restriction of Flying) (Balmoral to Edinburgh) Regulations 2022 and they come into force on 10th September 2022.

Interpretation

2. The times referred to in regulation 3 are local times.

Restricted airspace

- **3.**—(1) Subject to paragraphs (10) and (14), from 0700 hours on 10th September 2022 until 1000 hours on 12th September 2022 no aircraft is to fly below 4,500 feet above mean sea level within the area bounded by a circle having a radius of 4 nautical miles whose centre is at 570227N 0031345W.
- (2) Subject to paragraphs (10), (11) and (14), between 0930 hours and 1100 hours on 11th September 2022 no aircraft is to fly below 5,500 feet above mean sea level within the area bounded by—
 - (a) the clockwise arc of a circle having a radius of 4 nautical miles whose centre is at 570227N 0031345W between 570625N 0031449W and 565826N 0031235W, and
 - (b) straight lines joining successively the following points—
 - (i) 565826N 0031235W,
 - (ii) 565942N 0023836W,
 - (iii) 570839N 0023942W, and
 - (iv) 570625N 0031449W.

- (3) Subject to paragraphs (10), (11) and (14), between 1030 hours and 1130 hours on 11th September 2022 no aircraft is to fly below 4,500 feet above mean sea level within the area bounded by straight lines joining successively the following points—
 - (a) 565942N 0023836W,
 - (b) 570000N 0021802W,
 - (c) 570943N 0022155W,
 - (d) 570839N 0023942W, and
 - (e) 565942N 0023836W.
- (4) Subject to paragraphs (10), (11) and (14), between 1100 hours and 1230 hours on 11th September 2022 no aircraft is to fly below 4,500 feet above mean sea level within the area bounded by straight lines joining successively the following points—
 - (a) 570000N 0021802W,
 - (b) 565530N 0020955W,
 - (c) 570000N 0020000W,
 - (d) 571100N 0020000W,
 - (e) 570943N 0022155W, and
 - (f) 570000N 0021802W.
- (5) Subject to paragraphs (10), (11) and (14), between 1145 hours and 1345 hours on 11th September 2022 no aircraft is to fly below 4,500 feet above mean sea level within the area bounded by straight lines joining successively the following points—
 - (a) 563846N 0024523W,
 - (b) 565530N 0020955W,
 - (c) 570000N 0021802W,
 - (d) 564444N 0025502W, and
 - (e) 563846N 0024523W.
- (6) Subject to paragraphs (10), (12) and (14), between 1315 hours and 1415 hours on 11th September 2022 no aircraft is to fly below 4,500 feet above mean sea level within the area bounded by straight lines joining successively the following points—
 - (a) 562651N 0024855W,
 - (b) 563846N 0024523W,
 - (c) 564444N 0025502W,
 - (d) 562957N 0030740W, and
 - (e) 562651N 0024855W.
- (7) Subject to paragraphs (10), (12) and (14), between 1340 hours and 1500 hours on 11th September 2022 no aircraft is to fly below 4,500 feet above mean sea level within the area bounded by straight lines joining successively the following points—
 - (a) 561959N 0031833W,
 - (b) 562651N 0024855W,
 - (c) 562957N 0030740W,
 - (d) 562510N 0033050W, and
 - (e) 561959N 0031833W.
- (8) Subject to paragraphs (10), (12), (13) and (14), between 1415 hours and 1615 hours on 11th September 2022 no aircraft is to fly below 4,500 feet above mean sea level within the area bounded by—
 - (a) straight lines joining successively the following points—
 - (i) 560119N 0031642W,

- (ii) 561959N 0031833W,
- (iii) 562510N 0033050W,
- (iv) 555623N 0032938W,
- (v) 555516N 0032037W, and
- (b) the clockwise arc of a circle having a radius of 5 nautical miles whose centre is at 555700N 0031215W, between 555516N 0032037W and 560119N 0031642W.
- (9) Subject to paragraphs (10), (13) and (14), between 1500 hours and 1845 hours on 11th September 2022 no aircraft is to fly below 6,000 feet above mean sea level within the area bounded by a circle having a radius of 5 nautical miles whose centre is at 555700N 0031215W.
- (10) Paragraphs (1) to (9) do not apply insofar as flying is already prohibited by the Air Navigation (Restriction of Flying) (Balmoral) (Restricted Zone EG R704) Regulations 2019(a), the Air Navigation (Restriction of Flying) (Birkhall) (Restricted Zone EG R705) Regulations 2019(b) or the Air Navigation (Restriction of Flying) (Nuclear Installations) Regulations 2016(c).
- (11) Paragraphs (2) to (5) do not apply to any aircraft making an approach to, or departure from, Aberdeen Airport whilst under the direction of the air traffic control unit at Aberdeen Airport.
- (12) Paragraphs (6) to (8) do not apply to any aircraft making an approach to or departure from Leuchars Station aerodrome whilst under the direction of the air traffic control unit at Leuchars Station.
- (13) Paragraphs (8) and (9) do not apply to any aircraft making an approach to or departure from Edinburgh Airport whilst under the direction of—
 - (a) the air traffic control unit at Edinburgh Airport, or
 - (b) the Prestwick Air Traffic Control Centre.
 - (14) Paragraphs (1) to (9) do not apply to any aircraft—
 - (a) flying in accordance with the permission of the Police Scotland Air Accidents and Incidents Advisor,
 - (b) operated by or on behalf of—
 - (i) Police Scotland,
 - (ii) the Scottish Charity Air Ambulance,
 - (iii) the Maritime and Coastguard Agency for the purpose of Search and Rescue Operations, or
 - (iv) The King's Helicopter Flight,
 - (c) flying with the permission of—
 - (i) the Police Scotland Royalty and VIP Planning North Unit, or
 - (ii) the Metropolitan Police, Royalty and Specialist Protection Unit,
 - (d) operated by a member of the Royal Family, or
 - (e) taking off or landing in the grounds of Balmoral Castle or Birkhall at the invitation of the person in charge of the household there, provided that the Police Scotland Royalty and VIP Planning North Unit or the Metropolitan Police, Royalty and Specialist Protection Unit has been informed in advance of such intended take-off or landing.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations impose restrictions on flying in the vicinity of Balmoral Castle and Birkhall, Royal Deeside, Aberdeenshire, and along a route over parts of Tayside, Grampian, Fife and Lothian by reason of the road move of the body of Her late Majesty Queen Elizabeth II from Balmoral Castle to Edinburgh. These Regulations apply except insofar as flying is already prohibited by the Air Navigation (Restriction of Flying) (Balmoral) (Restricted Zone EG R704) Regulations 2019 (S.I. 2019/1321), the Air Navigation (Restriction of Flying) (Birkhall) (Restricted Zone EG R705) Regulations 2019 (S.I. 2019/1320) and the Air Navigation (Restriction of Flying) (Nuclear Installations) Regulations 2016 (S.I. 2016/1003).

These restrictions form part of the overall security arrangements for the event and have been agreed with the Civil Aviation Authority, the Department for Transport, and the Royal Household.

The times mentioned in regulation 3 are local times.
