**The Validating Alternative Methods for Salmonella
Typing (Amendment) Regulations 2023**

The Secretary of State, in exercise of the powers conferred by Article 4(1) of Regulation (EC) [2160/2003](#) on the control of salmonella and other specified food-borne zoonotic agents⁽¹⁾, makes the following Regulations.

In accordance with the requirements of Article 2A(2) of that Regulation, the Secretary of State has obtained the consent of the Scottish Ministers and the Welsh Ministers.

Citation, commencement and extent

1.—(1) These Regulations may be cited as the Validating Alternative Methods for Salmonella Typing (Amendment) Regulations 2023 and come into force on 4th August 2023.

(2) These Regulations extend to England and Wales, and Scotland.

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations are made in exercise of powers conferred by Article 4(1) of Regulation (EC) 2160/2003 on the control of salmonella and other specified food-borne zoonotic agents. They extend to England and Wales, and Scotland.

These Regulations amend the regulations concerning salmonella in poultry and poultry products to include a reference to a standard adopted by the International Organization for Standardization (ISO) for validating alternative typing methods for salmonella.

A full impact assessment has not been produced for this instrument as no, or no significant, impact on the private, voluntary or public sectors is foreseen.
