**The Pensions Act 2004 (Codes of Practice) (Revocation) Order
2024**

<i>Coming into force</i> - -	<i>28th March 2024</i>

The Secretary of State makes this Order in exercise of the powers conferred by section 92(1) of the Pensions Act 2004(a).

The Pensions Regulator consents to the making of this Order as required by section 92(2) of the Pensions Act 2004.

Citation, commencement and extent

1.—(1) This Order may be cited as the Pensions Act 2004 (Codes of Practice) (Revocation) Order 2024.

(2) This Order comes into force on 28th March 2024.

(3) This Order extends to England and Wales and Scotland.

Revocation of Codes of Practice

2. The following Codes of Practice are revoked with effect from 28th March 2024—

- (a) the Pensions Regulator Code of Practice No. 1: Reporting breaches of the Law(b);
- (b) the Pensions Regulator Code of Practice No. 4: Early leavers – reasonable periods(c);
- (c) the Pensions Regulator Code of Practice No. 5: Reporting late payment of contributions to occupational money purchase schemes(d);
- (d) the Pensions Regulator Code of Practice No. 6: Reporting late payment of contributions to personal pensions(e);
