I, Frederick Lord Birkenhead, Lord High Chancellor of Great Britain, by and with the advice and consent of the undersigned Judges of the Court of Appeal and the High Court of Justice, and with the concurrence of the Treasury, do hereby in pursuance and execution of the powers given by the Sheriffs Act, 1887, fix the fees set forth in the first part of the Schedule hereto annexed as the fees to be demanded, taken and received by any sheriff or officer of a sheriff concerned in the execution of process directed to the sheriff in the several proceedings mentioned in the first part of the said schedule as from the 23rd day of May, 1921, in lieu of the fees specified in the items of the orders made under the Act 7 Will. 4 & 1 Vict. c. 55,(b) set forth in the second part of the Schedule to this Order, which items are hereby annulled as from that day.
