THE PERFORMING ANIMALS RULES, 1925, DATED DECEMBER 3, 1925, MADE BY THE SECRETARY OF STATE FOR THE HOME DEPARTMENT, UNDER SECTION 5 (2) OF THE PERFORMING ANIMALS (REGULATION) ACT, 1925 (15 & 16 Geo. 5. c. 38).

1925 No. 1219

In pursuance of Section 5(2) of the Performing Animals (Regulation) Act, 1925, hereinafter referred to as the Act, I hereby make the following Rules :—

Form of application for registration (Section 1).

1. Every application for registration under the Act shall be made in writing in the form, and shall contain the particulars, set out in the First Schedule hereto.

Application by person having no fixed place of residence in Great Britain (Section 1(2).).

2. If the applicant has no fixed place of residence in Great Britain he shall make his application for registration to the local authority of one of the following districts :---

- In England and Wales :--The City of London, the County of London; the Cities of Birmingham, Bristol, Cardiff, Kingston-upon-Hull, Leeds, Liverpool, Manchester and Newcastle-on-Tyne; and the County Boroughs of Plymouth and Southampton.
- In Scotland :---The Cities of Aberdeen, Dundee, Edinburgh and Glasgow.

Form of Register (Section 1(2)).

3. The register which the local authority is required to keep for the purpose of the Act shall be in the form set out in the Second Schedule hereto. Each registration shall be given a serial number according to the order in which it is made, and the serial number shall be inserted in the certificate of registration issued to the applicant.

4. The local authority shall either arrange the names of the registered persons alphabetically or shall keep as part of the register an alphabetical index of the names of persons registered.

Form of Certificate of Registration (Section 1 (4)).

5. The certificate of registration which the local authority is required to issue to each registered person shall be in the form set out in the Third Schedule hereto.

Application for variation of registered particulars (Section 1 (6)).

6. Applications for the variation of the registered particulars shall be made in the form set out in the Fourth Schedule hereto.

Certified copy of certificate of registration.

7. A local authority may issue a certified copy of any certificate of registration issued by them if satisfied that the original has been destroyed or lost, and may charge therefore the fee hereinafter prescribed; provided that such certified copy shall be issued only to the person to whose registration it relates.

Inspection of Register Entries (Section 1 (5)).

8. The copy of the certificate of registration sent by the local authority to the Home Office shall be open to inspection on payment of the prescribed fee on each day other than Saturday on which the office is open between the hours of 11 and 12 in the morning and 3 and 4 in the afternoon.

Fees (Sections 1 (2) (5) (7) and 5 (3)).
