THE BYSSINOSIS (FEES) REGULATIONS, 1941, DATED APRIL 14, 1941, MADE BY THE SECRETARY OF STATE, AS TO THE FEES TO BE PAID IN RESPECT OF THE FUNCTIONS OF THE ADMINISTRATIVE BOARD AND OF THE MEDICAL BOARD, UNDER THE BYSSINOSIS (WORKMEN'S COMPENSATION) SCHEME, 1941.

In pursuance of the powers conferred on me by section 1 (2) (d) of the Workmen's Compensation and Benefit (Byssinosis) Act, 1940, I. the Right Honourable Herbert Morrison, one of His Majesty's Principal Secretaries of State, hereby make the following Regulations:—

- 1. Definitions. In these Regulations, unless the context otherwise requires—
 - (i) "The Scheme" means the Byssinosis (Workmen's Compensation Scheme, 1941.(a)
 - (ii) "Administrative Board," "Medical Board" and "The disease" have the same meanings as in the Scheme.
- 2. The fees payable in respect of the exercise by the Administrative Board of their functions under the Scheme shall be the fees prescribed in the Table contained in the First Schedule to these Regulations and such fees shall be paid in accordance with and subject to the directions contained therein.
- 3. The fees payable in respect of the exercise by the Medical Board of their functions under the Scheme shall be the fees prescribed in the Table contained in the Second Schedule to these Regulations, and such fees shall be paid in accordance with and subject to the directions contained therein.
- 4. These Regulations may be cited as the Byssinosis (Fees) Regulations, 1941, and shall come into operation on the 1st May, 1941.

⁽²⁾ Where a fee is prescribed by the Regulations as payable by or on behalf of an employer, the employer liable to pay the said fee shall, except as otherwise provided by the Regulations, be the employer from whom the compensation due to the workman is recoverable.

⁽³⁾ Any sum due to the Fund under this Scheme may be recovered summarily or otherwise, as a civil debt.
