Mae Rhan II o Ddeddf Llywodraeth Leol 2000 (Deddf 2000) yn darparu i Gynulliad Cenedlaethol Cymru bennu pa awdurdodau lleol a gaiff weithredu "trefniadau amgen" (h.y. trefniadau ar gyfer cyflawni swyddogaethau'r awdurdod nad ydynt yn golygu creu a gweithredu gweithrediaeth i'r awdurdod) (adran 31(1)(b)) a pha ffurf y dylai'r trefniadau hynny ei chymryd (adran 32(1)).

Mae'r Rheoliadau hyn yn caniatáu i bob cyngor sir a phob cyngor bwrdeistref sirol yng Nghymru weithredu trefniadau amgen, ar yr amod bod y trefniadau hynny ar y ffurf y mae'r Rheoliadau hyn yn gofyn amdani.

Mae rheoliad 4 yn pennu'r pwylgorau y mae'n rhaid eu sefydlu pan fydd awdurdod yn gweithredu trefniadau amgen, sef Bwrdd, prif bwylgor craffu ac unrhyw bwylgorau craffu eraill y penderfynir arnynt gan y cyngor (sef o leiaf dri a hyd at wyth yn ychwanegol at y prif bwylgor craffu). Mae gan yr awdurdodau ddisgresiwn a ddylid sefydlu pwylgor cynllunio, pwylgor trwyddedu, pwylgorau ardal a phwylgorau archwilio.

O dan drefniadau amgen, mae pwylgorau ac is-bwylgorau yn dod o dan o fynion Rhan VA o Ddeddf Llywodraeth Leol 1972 (Deddf 1972) ac mae'n ofynnol cydymffurfio ag adran 15 o Ddeddf Llywodraeth Leol a Thai 1989 (dyletswydd i ddyrannu seddi i grwpiau gwleidyddol) (rheoliad 5). Hefyd, rhaid i'r awdurdodau ddyrannu cadeiryddiaethau pwylgorau

The Local Authorities (Alternative Arrangements) (Wales) Regulations 2001

EXPLANATORY NOTE

(This note does not form part of the Regulations)

Part II of the Local Government Act 2000 (the 2000 Act) provides for the National Assembly for Wales to specify which local authorities may operate "alternative arrangements" (i.e. arrangements for the discharge of the authority's functions which do not involve the creation and operation of an executive of the authority) (section 31(1)(b)) and what form those arrangements should take (section 32(1)).

These Regulations permit all county councils and county borough councils in Wales to operate alternative arrangements provided that those arrangements are in the form required by these Regulations.

Regulation 4 specifies the committees which must be established when an authority operates alternative arrangements. They are a Board, a principal scrutiny committee and such other scrutiny committees as the council may decide (subject to a minimum of three and a maximum of eight in addition to the principal scrutiny committee). Authorities have a discretion whether to establish planning, licensing, area and audit committees.

Under alternative arrangements committees and sub-committees are subject to the requirements of Part VA of the Local Government Act 1972 (the 1972 Act) and there is a requirement for compliance with section 15 of the Local Government and Housing Act 1989 (duty to allocate seats to political groups) (regulation 5). In addition, authorities must allocate the chairpersonships

Mae'r pwylgorau a sefydlir at ddibenion trefniadau amgen (ac eithrio pwylgorau ardal a sefydlir o dan reoliad 4) i gynnwys hyd at ddeg aelod neu ugain y cant o aelodau'r awdurdod (p'un bynnag yw'r mwyaf) (rheoliad 5(2)). Wrth gyfrifo'r ganran hon dylai'r rhifau gael eu talgrynnu i fyny os nad ydynt yn rhifau cyfan.

Rhaid i bwylgorau cynllunio, trwyddedu neu ardal sy'n ymdrin â materion a bennir yn Rhan A o Atodlen 1 (cynllunio gwlad a thref a rheoli datblygu) gael o leiaf wyth aelod (rheoliad 5(4)).

Os cânt eu sefydlu, rhaid i bwylgorau ardal gyda'i gilydd ymdrin â'r cyfan o ardal yr awdurdod lleol. Rhaid cael o leiaf dri ohonynt a bydd gan bob aelod o'r awdurdod hawl i eistedd ar un pwylgor ardal (rheoliad 5(5)).

Caiff Bwrdd awdurdod lleol gynnwys cadeirydd pwylgor cynllunio'r awdurdod (os oes pwylgor o'r fath wedi'i sefydlu) a chadeiryddion unrhyw bwylgorau ardal sydd gan yr awdurdod (os oes pwylgorau o'r fath wedi'u sefydlu).

Pan fydd awdurdod lleol yn sefydlu pwylgor archwilio caiff ddirprwyo i'r pwylgor hwnnw ar yr amod nad oes unrhyw ddeddfiad arall yn ei wahardd. Ni all pwylgorau archwilio gynnwys aelodau o'r Bwrdd ond fe gât gynnwys aelodau nad ydynt yn aelodau o'r awdurdod. Nid oes gan y personau hynny hawl i bleidleisio. Rhaid i Gadeirydd pwylgor archwilio berthyn i grwp gwleidyddol gwahanol i'r un y mae Cadeirydd y Bwrdd yn perthyn iddo (ac eithrio lle nad oes ond un grwp gwleidyddol) a rhaid iddo fod yn aelod o'r awdurdod. Caiff pwylgorau archwilio benodi is-bwylgorau.

Mae rheoliad 6 yn nodi'r gofynion mewn perthynas â phrif bwylgorau craffu a phwylgorau craffu eraill. Rhaid i brif bwylgor craffu beidio â chynnwys aelodau o'r Bwrdd ac mae ei gadeirydd i ddod o grwp gwleidyddol sy'n wahanol i grwp cadeirydd y Bwrdd (rheoliad 6(1)). Caiff pwylgorau craffu (heblaw prif bwylgor craffu) gynnwys hyd at dri o aelodau o'r Bwrdd ond rhaid i aelodau nad ydynt yn aelodau o'r Bwrdd ffurfio mwyafriol aelodaeth y pwylgorau hyn. Ni chaiff aelodau'r Bwrdd gadeirio pwylgorau craffu (rheoliad 6(2)).

Nodir y pwerau hynny sydd i'w dirprwyo i bwylgorau craffu gan yr awdurdodau lleol yn rheoliad 6(3). Mae'r un pwerau i gael eu dirprwyo i brif bwylgorau craffu ag i bwylgorau craffu eraill ond cyfyngir arfer y pwerau hynny i swyddogaethau Bwrdd awdurdod (rheoliad 6(4)).

Rhaid i awdurdod lleol sy'n gweithredu trefniadau amgen ddarparu mecanwaith i alluogi prif bwylgor craffu a phwylgor craffu i gyfeirio penderfyniadau neu

of committees (so far as is practicable) to reflect the political groups in a local authority (regulation 5(3)).

Committees established for the purposes of alternative arrangements (except for area committees established under regulation 4) are to comprise a maximum of ten members or twenty per cent of the authority's members (whichever is greater) (regulation 5(2)). In calculating this percentage numbers are to be rounded up where there are not whole numbers.

Planning, licensing or area committees dealing with matters specified in Part A of Schedule 1 (town and country planning and development control) must have a minimum of eight members (regulation 5(4)).

Area committees, where established, must collectively cover the whole of a local authority's area. They must be at least three in number and each member of an authority shall be entitled to sit on one area committee (regulation 5(5)).

The Board of a local authority may include the chairperson of the authority's planning committee (where such a committee has been established) and the chairpersons of any area committees of the authority (where such committees have been established).

When a local authority establishes an audit committee it may delegate to that committee provided that such delegation is not prohibited by any other enactment. Audit committees cannot include Board members but may include members who are not members of the authority. Those persons are not entitled to vote. The Chairperson of an audit committee must be from a different political group to that of the Chairperson of the Board (except where there is only one political group) and must be a member of the authority. Audit committees may appoint sub-committees.

Regulation 6 sets out requirements in respect of principal scrutiny committees and other scrutiny committees. A principal scrutiny committee shall not include members of the Board and its chairperson is to come from a different political group to that of the chairperson of the Board (regulation 6(1)). Scrutiny committees (other than a principal scrutiny committee) may comprise up to three Board members but members who are non Board members must form the majority of the membership of these committees. Board members cannot chair scrutiny committees (regulation 6(2)).

Those powers to be delegated to scrutiny committees by local authorities are set out in regulation 6(3). Principal scrutiny committees are to be delegated the same powers as other Scrutiny committees but the exercise of those powers is limited to the functions of the Board of an authority (regulation 6(4)).

A local authority operating alternative arrangements must provide a mechanism to enable a principal scrutiny committee and a scrutiny committee to refer

Caiff prif bwyllgorau craffu a phwyllgorau craffu gynnwys aelodau nad ydynt yn aelodau o'r awdurdod, ond ni all yr aelodau hyn gael hawliau pleidleisiau (rheoliad 6(10)) ac nid oes ganddynt hawl i gadeirio pwylgorau o'r fath.

Os nad yw swyddogaeth yr awdurdod lleol o gynnal adolygiadau'r gwerth gorau (adran 5 o Ddeddf Llywodraeth Leol 1999) yn gyfrifoldeb i'r Bwrdd, gall yr adolygiadau hynny gael eu cynnal gan brif bwyllgor craffu neu gan unrhyw bwyllgor craffu.

Mae rheoliad 6 hefyd yn nodi'r gofynion mewn perthynas â hawliau aelodau o brif bwyllgorau craffu a phwyllgorau craffu i godi materion sy'n berthnasol i swyddogaethau pwylgorau o'r fath a'r hyn y gall y pwylgorau hynny ei wneud yn nhermau presenoldeb aelodau nad ydynt yn aelodau o'r pwylgor yn eu cyfarfodydd.

Mae rheoliad 7 yn pennu bod rhaid i awdurdod ddirprwyo i Fwrdd, o dan gyfyngiadau penodol.

Mae rheoliadau 8, 9, 10 ac 11, drwy gyfeirio at yr Atodleni i'r Rheoliadau, yn nodi'r cyfyngiadau ar ba swyddogaethau a all gael eu harfer gan Fwrdd awdurdod lleol. Yn Atodlen 1 rhestrir y swyddogaethau hynny na all gael eu harfer gan y Bwrdd ac yn Atodlen 2 rhestrir y swyddogaethau hynny a all fod yn gyfrifoldeb i Fwrdd awdurdod os bydd yr awdurdod yn penderfynu felly. Mae Rheoliad 10, drwy gyfeirio at Atodlen 3, yn nodi'r camau na allant fod yn gyfrifoldeb i Fwrdd awdurdod yn unig. Yn ôl rheoliad 11, nid yw'r swyddogaethau hynny a restrir yn Atodlen 4, a fyddai'n gyfrifoldeb i Fwrdd heblaw am reoliad 11, i fod yn gyfrifoldeb i'r Bwrdd o dan yr amgylchiadau a nodir yng ngholofn (2) o'r Atodlen honno.

Caiff Bwrdd gyfarwyddo bod unrhyw benderfyniad sydd i'w wneud gan bwyllgor cynllunio, pwylgor trwyddedu neu bwyllgor ardal mewn perthynas â chynllunio gwlaid a thref a rheoli datblygu (rheoliad 12 a Rhan A o Atodlen 1) i gael ei gymryd gan yr awdurdod.

Mae rheoliad 13 yn caniatáu i awdurdod lleol, neu i Fwrdd yr awdurdod, wneud y trefniadau o dan adran 101(5) o Ddeddf 1972, yn ddarostyngedig i ddarpariaethau rheoliad 19 sy'n ei gwneud yn ofynnol i'r trefniadau hyn gael eu gwneud gyda Bwrdd awdurdod lleol arall neu awdurdod lleol arall. Mae'r rheoliad hefyd yn cynnwys darpariaethau penodol ynghylch cyflawni swyddogaethau gan gyd-bwyllgor o dan amgylchiadau o'r fath, gan gynnwys, yn rheoliad 19(8), yr angen i gydymffurfio â Rhan VA o Ddeddf 1972 (cyfle i fynd i gyfarfodydd ac i weld dogfennau), mewn perthynas â chyd-bwyllgorau.

decisions or proposed decisions of the Board (which relate to the functions of the principal scrutiny committee or scrutiny committee) to the full Council for consideration (regulation 6(9)).

Both principal scrutiny committees and scrutiny committees may comprise members who are not members of the authority but such members cannot have voting rights (regulation 6(10)) and are not entitled to chair such committees.

Where a local authority's function of conducting best value reviews (section 5 of the Local Government Act 1999) is not the responsibility of the Board those reviews may be carried out by a principal scrutiny committee or any scrutiny committee.

Regulation 6 also sets out requirements in respect of the rights of members of principal scrutiny committees and scrutiny committees to raise matters relevant to the functions of such committees and what those committees can do in terms of attendance of non-committee members at their meetings.

Regulation 7 specifies that there must be delegation by an authority to a Board, subject to certain limitations.

Regulations 8, 9, 10 and 11, by reference to the Schedules to the Regulations, set out the limitations on what functions may be exercised by a Board of a local authority. Schedule 1 lists those functions which may not be exercised by the Board and Schedule 2 lists those functions which may be the responsibility of an authority's Board, if the authority so decides. Regulation 10, by reference to Schedule 3, sets out what actions may not be the sole responsibility of an authority's Board. By regulation 11 those functions listed in Schedule 4, which but for regulation 11 would be the responsibility of a Board, are not to be the Board's responsibility in the circumstances set out in column (2) of that Schedule.

A Board may direct that any decision to be made by a planning, licensing or area committee in relation to town and country planning and development control functions (regulation 12 and Part A of Schedule 1) shall be made by the authority.

Regulation 13 allows a local authority, or a Board of the authority, to make arrangements under section 101(5) of the 1972 Act, subject to the provisions of regulation 19 which require that such arrangements must be with the Board of another local authority or another local authority. The regulation also contains specific provisions relating to the discharge of functions by a joint committee in such circumstances including, at regulation 19(8), the need for there to be compliance, in respect of joint committees, with Part VA of the 1972 Act (access to meetings and documents).

Yn ychwanegol at gyflawni swyddogaethau drwy'r Bwrdd cyfan, caiff Bwrdd awdurdod lleol gyflawni ei swyddogaethau drwy un aelod o'r Bwrdd, drwy bwylgor o'r Bwrdd neu drwy un o swyddogion yr awdurdod (rheoliad 13(b)).

Mae rheoliadau 15 ac 16 yn darparu i swyddogaethau awdurdod lleol gael eu cyflawni gan awdurdod lleol arall neu gan Fwrdd arall o dan amgylchiadau penodedig. Os oes trefniadau mewn grym, yn unol â rheoliadau 15 ac 16, i unrhyw un o swyddogaethau Bwrdd gael ei chyflawni gan Fwrdd awdurdod lleol arall, mae'r swyddogaethau sydd i fod yn destun y trefniant hwnnw i gael eu trin fel pe baent yn swyddogaethau i'r awdurdod arall at ddibenion Deddf 2000 (rheoliad 17).

Pan fydd awdurdod lleol yn arfer swyddogaethau o dan drefniant o dan reoliad 15 (lle mae'r swyddogaethau yn swyddogaethau i Fwrdd awdurdod arall) caiff yr awdurdod sy'n arfer y swyddogaethau gyflawni'r swyddogaethau hynny drwy bwylgor, is-bwylgor neu swyddog (rheoliad 18).

The Board of a local authority may, in addition to discharging functions via the whole Board, discharge its functions through a single member of the Board, a committee of the Board or an officer of the authority (regulation 13(b)).

Regulations 15 and 16 provide for the discharge of a local authority's functions by another local authority or Board in specified circumstances. Where, in accordance with regulations 15 and 16, arrangements are in force for the discharge of any functions of a Board by the Board of another local authority, the functions which are the subject of that arrangement are to be treated as being those of the other authority for the purposes of the 2000 Act (regulation 17).

When a local authority exercises functions under an arrangement under regulation 15 (where functions are those of the Board of another authority) the exercising authority may discharge such functions by a committee, sub-committee or officer (regulation 18).

The National Assembly for Wales makes the following Regulations in exercise of the powers given to it by sections 31(1) and 32(1) of the Local Government Act 2000(a).

Name, commencement and application

1.-(1) The name of these Regulations is the Local Authorities (Alternative Arrangements) (Wales) Regulations 2001 and they shall come into force on 28th July 2001.

(2) These Regulations apply to Wales only.

Interpretation

2. In these Regulations -

"the 1972 Act" ("*Deddf 1972*") means the Local Government Act 1972(b);

"the 2000 Act" ("*Deddf 2000*") means the Local Government Act 2000;

"alternative arrangements" ("*trefniadau amgen*") means arrangements by a local authority with respect to discharge of their functions which are arrangements in accordance with regulation 4;

ystyr "Deddf 1972" ("the 1972 Act") yw Deddf Llywodraeth Leol 1972(a);

ystyr "Deddf 2000" ("the 2000 Act") yw Deddf Llywodraeth Leol 2000;

ystyr "grwp gwleidyddol" ("political group") yw grwp gwleidyddol yn unol â rheoliad 8 o Reoliadau Llywodraeth Leol (Pwyllgorau a Grwpiau Gwleidyddol) 1990(b);

ystyr "prif bwylgor craffu" ("principal scrutiny committee") yw pwyllgor neu is-bwylgor i'r awdurdod a sefydlir o dan reoliad 4(1);

ystyr "pwyllgor archwilio" ("audit committee") yw pwyllgor i awdurdod lleol a sefydlir o dan reoliad 4(2)(ch) sy'n cael ei sefydlu i arfer swyddogaethau yn unol â rheoliad 5(7) ac a adnabyddir fel y Pwyllgor archwilio neu unrhyw deitl arall y darperir ar ei gyfer yn rheolau sefydlog yr awdurdod lleol;

ystyr "pwyllgor ardal" ("area committee") yw pwyllgor neu is-bwylgor i awdurdod lleol -

- (i) a sefydlir o dan reoliad 4(2)(c) gyda phwerau dirprwyedig i arfer rhai neu'r cyfan o'r swyddogaethau yn rhan A o Atodlen 1; a
- (ii) sy'n bodloni'r amodau canlynol:
 - (a) bod y pwyllgor neu'r is-bwylgor wedi'i sefydlu i gyflawni'r swyddogaethau hynny a gyfeirir atynt ym mharagraff (i) mewn perthynas â rhan o ardal yr awdurdod;
 - (b) bod aelodau'r pwyllgor neu'r is-bwylgor sy'n aelodau'r o'r awdurdod wedi'u hethol dros adrannau neu wardiau etholiadol sydd yn gyfan gwbl neu'n rhannol o fewn y rhan honno; a
 - (c) nad yw poblogaeth y rhan honno, yn ôl amcangyfrif yr awdurdod, yn llai na phymtheg y cant o gyfanswm poblogaeth ardal yr awdurdod fel y mae wedi'i amcangyfrif felly.

ystyr "pwyllgor craffu" ("scrutiny committee") yw pwyllgor neu is-bwylgor i'r awdurdod a sefydlir o dan reoliad 4(1)(c).

ystyr "pwyllgor cynllunio" ("planning committee") yw pwyllgor i'r awdurdod â chanddo bŵer dirprwyedig i arfer rhai neu'r cyfan o'r swyddogaethau hynny yn Atodlen 1, a adnabyddir fel y Pwyllgor Cynllunio neu unrhyw deitl arall y darperir ar ei gyfer yn rheolau sefydlog yr awdurdod lleol;

"area committee" ("pwyllgor ardal") means a committee or sub-committee of a local authority -

- (i) established under regulation 4(2)(c) with delegated powers to exercise some or all of the functions in part A of Schedule 1; and
- (ii) which satisfies the following conditions:
 - (a) the committee or sub-committee is established to discharge those functions referred to in paragraph (4) in respect of part of the area of the authority;
 - (b) the members of the committee or sub-committee who are members of the authority are elected for electoral divisions or wards which fall wholly or partly within that part; and
 - (c) the population of that part, as estimated by the authority, is not less than fifteen percent of the total population of the area of the authority as so estimated;

"audit committee" ("pwyllgor archwilio") means a committee of a local authority established under regulation 4(2)(d) which is established to exercise functions in accordance with regulation 5(7) and which is known as the audit committee or by such other title as the standing orders of the local authority may provide:

"Board" ("Bwrdd") means the committee of a local authority established under regulation 4(1)(a) which is established to exercise the functions mentioned in regulation 7 and which is known as the Board of the Council or by such other title as the standing orders of the local authority may provide;

"licensing committee" ("pwyllgor trwyddedu") means a committee of a local authority with delegated powers to exercise some or all of those functions listed in Schedule 1, which shall be known as the Licensing Committee or by such other title as the standing orders of the local authority may provide;

"local authority" ("awdurdod lleol") means (save where the context otherwise requires) a county council or a county borough council which is operating alternative arrangements;

"planning committee" ("pwyllgor cynllunio") means a committee of the authority with delegated power to exercise some or all of those functions in Schedule 1 which is known as the Planning Committee or by such other title as the standing orders of the local authority may provide;

"political group" ("grwp gwleidyddol") means a political group in accordance with regulation 8 of the Local Government (Committees and Political Groups) Regulations 1990(a);

ystyr "pwyllgor trwyddedu" ("licensing committee") yw pwyllgor i awdurdod lleol a chanddo bwerau dirprwyedig i arfer rhai neu'r cyfan o'r swyddogaethau hynny a restrir yn Atodlen 1, a adnabyddir fel y Pwyllgor Trwyddedu neu unrhyw deitl arall y darperir ar ei gyfer yn rheolau sefydlog yr awdurdod lleol;

ystyr "trefniadau amgen" ("alternative arrangements") yw trefniadau gan awdurdod lleol mewn perthynas â chyflawni eu swyddogaethau sy'n drefniadau yn unol â rheoliad 4.

4.-(1) Rhaid i awdurdod lleol sy'n gweithredu trefniadau amgen sefydlu -

- (a) Bwrdd; a
- (b) yn ddarostyngedig i reoliad 6, prif bwyllgor craffu; ac
- (c) yn ddarostyngedig i reoliad 6 unrhyw bwyllgorau craffu ychwanegol (heb fod yn llai na thri nac yn fwy nag wyth o ran nifer) y gall rheolau sefydlog yr awdurdod lleol ddarparu ar eu cyfer.
- (2) Fe gaiff awdurdod lleol sy'n gweithredu trefniadau amgen sefydlu -
 - (a) pwyllgor cynllunio;
 - (b) pwyllgor trwyddedu
 - (c) unrhyw bwyllgorau ardal y gall rheolau sefydlog yr awdurdod lleol ddarparu ar eu cyfer; ac
 - (ch) pwyllgor archwilio.
- (3) Mae'r trefniadau a nodir yn y Rheoliadau hyn yn cael eu pennu fel y trefniadau amgen at ddibenion Rhan II o Ddeddf 2000.

Gofynion pwyllgorau ac is-bwyllgorau

5.-(1) Mae pob pwyllgor i awdurdod lleol a sefydlir o dan reoliad 4 a phob is-bwyllgor i bwyllgor o'r fath i gael ei drin -

- (a) fel pwyllgor neu is-bwyllgor i brif gyngor at ddibenion Rhan VA o Ddeddf Llywodraeth Leol 1972 (cyfle i fynd i gyfarfodydd ac i weld dogfennau awdurdodau, pwyllgorau ac is-bwyllgorau penodol) a
- (b) fel corff y mae adran 15 o Ddeddf Llywodraeth Leol a Thai 1980(a) (dyletswydd i ddyrrannu seddau i grwpiau gwleidyddol) yn gymwys iddo.

(a) 1989 p.42. Diwygiwyd adran 18 gan adran 99(3) i (9) o Ddeddf Llywodraeth Leol 2000.

"principal scrutiny committee" ("prif bwyllgor craffu") means a committee or sub-committee of the authority established under regulation 4(1)(b);

"relevant body" ("corff perthnasol") for the purposes of regulations 13 and 19, means a local authority or a Board;

"scrutiny committee" ("pwyllgor craffu") means a committee or sub-committee of the authority established under regulation 4(1)(c).

Local authorities which may operate alternative arrangements

3. All local authorities may operate alternative arrangements.

Form of alternative arrangements

4.-(1) All local authority operating alternative arrangements must establish -

- (a) a Board; and
 - (b) subject to regulation 6 a principal scrutiny committee; and
 - (c) subject to regulation 6 such additional scrutiny committees (being not less than three nor more than eight in number) for which the standing orders of the local authority may provide.
- (2) A local authority operating alternative arrangements may establish -
 - (a) a planning committee;
 - (b) a licensing committee;
 - (c) area committees for which the standing orders of the local authority may provide; and
 - (d) an audit committee.

(3) The arrangements set out in these Regulations are specified as the alternative arrangements for the purposes of Part II of the 2000 Act.

Requirements for committees and sub-committees

5.-(1) Every committee of a local authority established under regulation 4 and every sub-committee of such a committee is to be treated -

- (a) as a committee or sub-committee of a principal council for the purposes of Part VA of the Local Government Act 1972 (access to meetings and documents of certain authorities, committees and sub-committees) and
- (b) as a body to which section 15 of the Local Government and Housing Act 1989 (a) (duty to allocate seats to political groups) applies.

(a) 1989 c.42. Section 18 is amended by section 99(3) to (9) of the Local Government Act 2000.

(2) Rhaid i bwyllgor i awdurdod lleol a sefydlir o dan reoliad 4, ac eithrio pwyllgor ardal a sefydlir o dan reoliad 4(2)(c), gynnwys uchafswm o ddeg aelod neu ugain y cant o aelodau'r awdurdod, (wedi'i gyfrifo drwy dalgrynnu nifer yr aelodau i fyny i'r rhif cyfan agosaf pan nad yw nifer yr aelodau yn rhif cyfan wrth gyfrifo'r ganran) p'un bynnag yw'r mwyaf.

(3) Rhaid i awdurdod lleol sy'n gweithredu trefniadau amgen ddyrannu cadeiryddiaethau pwyllgorau a sefydlir o dan reoliad 4 er mwyn sicrhau, cyn bodedd ag y bo'n ymarferol, fod cydbwysedd y grwpiau gwleidyddol yn yr awdurdod lleol yn cael ei adlewyrchu gan y cadeiryddiaethau hynny.

(4) Rhaid i bwyllgor cynllunio, pwyllgor trwyddedu neu bwyllgor ardal a sefydlir o dan reoliad 4 neu is-bwyllgor i bwyllgor o'r fath sy'n gyfrifol am unrhyw un o'r swyddogaethau a restrir yn Rhan A o Atodlen 1 (swyddogaethau sy'n ymwneud â chynllunio gwlad a thref a rheoli datblygu) gael wyt haelod o leiaf.

(5) Pan fydd awdurdod lleol yn sefydlu pwyllgorau ardal -

- (a) rhaid cael o leiaf dri phwyllgor o'r fath a rhaid iddynt ymdrin â'r cyfan o ardal yr awdurdod lleol; a
- (b) bydd gan bob aelod o'r awdurdod lleol hawl i fod yn aelod o un pwyllgor ardal.

(6) Caiff y Bwrdd gynnwys cadeirydd pwyllgor cynllunio'r awdurdod lleol a chadeiryddion pwyllgorau ardal os oes pwyllgorau o'r fath wedi'u sefydlu yn unol â rheoliad (4)(2).

(8) O ran pwyllgor archwilio a sefydlir o dan 4(2)(ch):

- (a) rhaid iddo beidio â chynnwys unrhyw un o aelodau'r Bwrdd; a
- (b) rhaid iddo beidio â chael cadeirydd sy'n aelod o'r un grwp gwleidyddol â Chadeirydd y Bwrdd (ac eithrio lle nad oes ond un grwp gwleidyddol); ac
- (c) caiff benodi un neu fwy o is-bwyllgorau; ac
- (ch) caiff drefnu i unrhyw is-bwyllgor o'r fath gyflawni unrhyw un o'i swyddogaethau.

(9) Ni chaiff is-bwyllgor i bwyllgor archwilio gyflawni unrhyw swyddogaethau heblaw'r rheiny a roddir iddo o dan baragraffau (7) ac (8).

(2) A committee of a local authority established under regulation 4, except an area committee established under regulation 4(2)(c), shall comprise a maximum of ten members or twenty per cent of the authority's members, (calculated by rounding up the number of members to the nearest whole number when in calculating the percentage the number of members is not a whole number) whichever is the greater number.

(3) A local authority operating alternative arrangements shall allocate the chairpersonships of committees established under regulation 4 so as to secure, as far as practicable, that the balance of the political groups in the local authority is reflected by those chairpersonships.

(4) A planning committee, licensing committee or area committee established under regulation 4 or a sub-committee of such a committee with responsibility for any of the functions listed in Part A of Schedule 1 (functions relating to town and country planning and development control) shall have a minimum of eight members.

(5) Where a local authority establishes area committees -

- (a) there shall be at least three such committees and they shall cover the whole of the local authority's area; and
- (b) each member of the local authority shall be entitled to be a member of one area committee.

(6) The Board may include the chairperson of the local authority's planning committee and the chairpersons of area committees where such committees have been established in accordance with regulation 4(2).

(7) To the extent that a local authority's powers in respect of its audit functions under any enactment may be delegated to a committee or sub-committee, a local authority may delegate to an audit committee.

(8) An audit committee established under 4(2)(d):

- (a) shall not include any members of the Board; and
- (b) shall not have a chairperson who is a member of the same political group as the Chairperson of the Board (except where there is only one political group); and
- (c) may appoint one or more sub-committees; and
- (d) may arrange for the discharge of any of its functions any such sub-committee.

(9) A sub-committee of an audit committee may not discharge any functions other than those conferred on it under paragraphs (7) and (8).

6.-(1) Rhaid i brif bwylgor craffu a sefydlir o dan reoliad 4(1)(b):

- (a) beidio â chynnwys unrhyw un o aelodau'r Bwrdd; a
- (b) peidio â chael cadeirydd sy'n aelod o'r un grwp gwleidyddol â chadeirydd y Bwrdd (ac eithrio pan nad oes ond un grwp gwleidyddol); a
- (c) gael cadeirydd sydd yn aelod o'r awdurdod.

(2) Rhaid i bwylgor craffu a sefydlir o dan reoliad 4(1)(c) -

- (a) cynnwys ymhllith ei aelodaeth fwyafri o aelodau'r awdurdod nad ydynt yn aelodau o'r Bwrdd ac fe gaiff gynnwys ymhllith ei aelodaeth hyd at dri aelod o'r Bwrdd ond ni fydd gan unrhyw aelod o'r Bwrdd hawl i fod yn gadeirydd ar bwylgor craffu; a
- (b) cael cadeirydd sydd yn aelod o'r awdurdod.

(3) Bydd gan Bwyllgor Craffu a sefydlir o dan reoliad 4(1)(c) bŵer dirprwyedig -

- (a) i adolygu neu graffu ar benderfyniadau a wnaed, neu gamau a gymerwyd, mewn cysylltiad â chyflawni unrhyw un o swyddogaethau'r awdurdod;
- (b) i gyflwyno adroddiadau neu argymhellion i'r awdurdod mewn cysylltiad â chyflawni unrhyw un o swyddogaethau'r awdurdod;

(10) An audit committee or any sub-committee of such a committee, may include persons who are not members of the authority, but any such persons shall not be entitled to vote at any meeting of such a committee or sub-committee on any question which falls to be decided at that meeting and shall not be entitled to be the chairperson of such a committee or sub-committee.

Principal scrutiny committees and scrutiny committees

6.-(1) A principal scrutiny committee established under regulation 4(1)(b) :

- (a) shall not include any members of the Board; and
- (b) shall not have a chairperson who is a member of the same political group as the chairperson of the Board (except where there is only one political group); and
- (c) shall have a chairperson who is a member of the authority.

(2) A scrutiny committee established under regulation 4(1)(c) -

- (a) must include among its membership a majority of members of the authority who are not Board members and may include among its membership up to three members of the Board but no Board member shall be entitled to be the chairperson of a scrutiny committee; and
- (b) shall have a chairperson who is a member of the authority.

(3) A Scrutiny Committee established under regulation 4(1)(c) shall have delegated power to -

- (a) review or scrutinise decisions made, or other action taken, in connection with the discharge of any function of the authority;
- (b) make reports or recommendations to the authority in connection with the discharge of any function of the authority;
- (c) make reports or recommendations to the authority or the inhabitants of that area;
- (d) recommend, in the case of a decision which has been made but not implemented, that the decision be reconsidered by the committee, sub-committee or person who made it; and
- (e) arrange for its function under sub-paragraph (a) to be exercised by the authority.

(4) A principal scrutiny committee established under regulation 4(1)(c) shall have the delegated power to undertake the functions of a scrutiny committee in accordance with paragraph (3) but those powers shall only be exercisable in so far as they relate to the functions of a Board.

(7) Caiff prif bwylgor craffu a phwyllgor craffu -

- (a) penodi un neu ragor o is-bwylgorau, a
- (b) trefnu i unrhyw is-bwylgor o'r fath gyflawni unrhyw un o'i swyddogaethau.

(8) Ni chaiff is-bwylgor i brif pwylgor craffu neu bwylgor craffu gyflawni unrhyw swyddogaethau heblaw'r rhai a roddir iddo o dan baragraff (6).

(9) Rhaid i drefniadau amgen gan awdurdod lleol gynnwys darpariaeth sydd -

- (a) yn galluogi unrhyw aelod o brif bwylgor craffu neu bwylgor craffu i sicrhau bod unrhyw fater sy'n berthnasol i swyddogaethau'r pwylgor yn cael ei gynnwys ar yr agenda ar gyfer cyfarfod o'r pwylgor ac yn cael ei drafod yno;
- (b) yn galluogi unrhyw aelod o is-bwylgor i bwylgor o'r fath i sicrhau bod unrhyw fater sy'n berthnasol i swyddogaethau'r is-bwylgor yn cael ei gynnwys ar yr agenda ar gyfer cyfarfod o'r is-bwylgor ac yn cael ei drafod yno; ac

(5) Subject to paragraph (6) a scrutiny committee may not otherwise discharge any function other than in accordance with these regulations.

(6) If, or to the extent that, a local authority's function of conducting best value reviews under section 5 of the Local Government Act 1999 (a) is not the responsibility of the Board of the authority, the authority may arrange for the principal scrutiny committee or any scrutiny committee to conduct such a review.

(7) A principal scrutiny committee and a scrutiny committee may -

- (a) appoint one or more sub-committees; and
- (b) arrange for the discharge of any of its functions by any such sub-committee.

(8) A sub-committee of a principal scrutiny committee or a scrutiny committee may not discharge any functions other than those conferred on it under paragraph (6).

(9) Alternative arrangements by a local authority must include provision which enables -

- (a) any member of a principal scrutiny committee or scrutiny committee to ensure that any matter which is relevant to the functions of the committee is included in the agenda for, and is discussed at, a meeting of the committee;
- (b) any member of a sub-committee of such a committee to ensure that any matter which is relevant to the functions of the sub-committee is included in the agenda for, and is discussed at, a meeting of the sub-committee; and
- (c) a principal scrutiny committee or scrutiny committee to refer any matter in connection with a decision or a proposed decision of the Board to the local authority provided that the decision or proposed decision relates to the functions of that committee.

(10) A principal scrutiny committee and a scrutiny committee, or any sub-committee of such a committee, may include persons who are not members of the authority, but any such persons shall not be entitled to vote at any meeting of such a committee or sub-committee on any question which falls to be decided at that meeting.

(11) Subsections (2) and (5) of section 102 of the 1972 Act are to apply to a principal scrutiny committee and a scrutiny committee, or a sub-committee of such a committee, as they apply to a committee appointed under that section.

(12) Caiff prif bwyllogor craffu a phwyllogor craffu, neu is-bwyllogor i bwyllogor o'r fath -

(13) Bydd unrhyw aelod o'r Bwrdd neu unrhyw un o swyddogion yr awdurdod sydd wedi'i awdurdod i fod yn bresennol i ateb cwestiynau yn unol â pharagraff (12) o dan ddyletswydd i wneud hynny ond ni fydd ar unrhyw aelod neu swyddog o'r fath rwymedigaeth i ateb unrhyw gwestiwn y byddai gan y person hwnnw hawl i wrthod ei ateb mewn achos, neu at ddibenion achos, mewn llys yng Nghymru neu Loegr.

7. -(1) Rhaid i awdurdod lleol sy'n gweithredu trefniadau amgen ddirprwyo ei swyddogaethau i Fwrdd yn ddarostyngedig i'r cyfyngiadau yn rheoliadau 8, 9, 10 ac 11.

(2) Ni fydd dim yn y Rheoliadau hyn yn atal awdurdod lleol rhag arfer y swyddogaethau hynny sydd wedi'u dirprwyo i Fwrdd yn unol â pharagraff (1).

Swyddogaethau nad ydynt i fod yn gyfrifoldeb i'r Bwrdd

8.-(1) Nid yw'r swyddogaethau a bennir yng ngholofn (1) o Atodlen 1 i'r Rheoliadau hyn drwy gyfeirio at y deddfiadau a bennir mewn perthynas â'r swyddogaethau hynny yng ngholofn (2) o'r atodlen honno i fod yn gyfrifoldeb i Fwrdd awdurdod.

(2) Nid yw swyddogaethau -

- (a) gosod unrhyw amod, terfyn neu gyfyngiad arall ar gymeradwyaeth, cydsyniad, trwydded, caniatâd neu gofrestriad a ganiateir -
 - (i) wrth arfer swyddogaeth a bennir yng ngholofn (1) o Atodlen 1; neu
 - (ii) heblaw gan Fwrdd yr awdurdod, wrth arfer unrhyw swyddogaeth o dan Ddeddf leol; a
- (b) penderfynu ar unrhyw delerau eraill y mae unrhyw gymeradwyaeth, cydsyniad, trwydded, caniatâd neu gofrestriad o'r fath yn ddarostyngedig iddynt, i fod yn gyfrifoldeb i Fwrdd yr awdurdod.

(3) Nid yw swyddogaeth penderfynu a ddylid cymryd camau gorfodi, ac ym mha fodd y dylid eu gorfodi -

- (a) yn erbyn unrhyw fethiant i gydymffurfio â chymeradwyaeth, cydsyniad, trwydded, caniatâd neu gofrestriad a ganiateir wrth arfer swyddogaeth a bennir yng ngholofn (1) o Atodlen 1,

(12) A principal scrutiny committee and a scrutiny committee, or a sub-committee of such a committee, -

- (a) may require members of the Board and officers of the authority, to attend before it to answer questions, and
- (b) may invite other persons to attend meetings of the committee or sub-committee.

(13) Any member of the Board or officer of the authority who is authorised to attend to answer questions in accordance with paragraph (12) shall be under a duty to do so but any such member or officer shall not be obliged to answer any question which that person would be entitled to refuse to answer in or for the purposes of proceedings in a court in Wales or England.

Functions which are to be the responsibility of the Board

7.-(1) A local authority operating alternative arrangements shall delegate its functions to a Board subject to the limitations in regulations 8, 9, 10 and 11.

(2) Nothing in these Regulations shall prevent a local authority from exercising those functions delegated to a Board in accordance with paragraph (1).

Functions which are not to be the responsibility of the Board

8.-(1) The functions specified in column (1) of Schedule 1 to these Regulations by reference to the enactments specified in relation to those functions in column (2) of that schedule are not to be the responsibility of a Board of an authority.

(2) The functions of -

- (a) imposing any condition, limitation or other restriction on an approval, consent, licence, permission or registration granted -
 - (i) in the exercise of a function specified in column (1) of Schedule 1; or
 - (ii) otherwise than by the Board of the authority, in the exercise of any function under a local Act; and
- (b) determining any other terms to which any such approval, consent, licence, permission or registration is subject, are not to be the responsibility of the Board of the authority.

(3) The function of determining whether, and in what manner, to enforce -

- (a) any failure to comply with an approval, consent, licence, permission or registration granted in the exercise of a function specified in column (1) of Schedule 1,

- (b) yn erbyn unrhyw fethiant i gydymffurfio ag amod, cyfyngiad neu deler y mae unrhyw gymeradwyaeth, cydsyniad, trwydded, caniatâd neu gofrestriad o'r fath yn ddarostyngedig iddynt, neu
- (c) yn erbyn unrhyw doriad arall mewn perthynas â mater na fyddai'r swyddogaeth o benderfynu ar gais am gymeradwyaeth, cydsyniad, trwydded, caniatâd neu gofrestriad yn gyfrifoldeb i Fwrdd yr awdurdod mewn perthynas ag ef,

i fod yn gyfrifoldeb i Fwrdd yr awdurdod.

(4) Nid yw swyddogaeth -

- (a) diwygio, addasu neu amrywio unrhyw gymeradwyaeth, cydsyniad, trwydded, caniatâd neu gofrestriad a ganiateir, nac unrhyw amod, terfyn, cyfyngiad neu deler y mae'n ddarostyngedig iddynt; neu
- (b) diddymu unrhyw gymeradwyaeth, cydsyniad, trwydded, caniatâd neu gofrestriad o'r fath, i fod yn gyfrifoldeb i Fwrdd yr awdurdod.

(5) Nid yw swyddogaeth gwneud unrhyw gynllun a awdurdodir neu a fynnir gan reoliadau o dan adran 18 o Ddeddf Llywodraeth Leol a Thai 1989 (cynlluniau ar gyfer lwfansau sylfaenol, lwfansau presenoldeb a lwfansau cyfrifoldeb arbennig i aelodau awdurdodau lleol), neu swyddogaeth diwygio, diddymu neu ddisodli unrhyw gynllun o'r fath, i fod yn gyfrifoldeb i Fwrdd yr awdurdod.

(6) Nid yw swyddogaethau penderfynu -

- (a) swm unrhyw lwfans sy'n daladwy -
 - (i) o dan is-adran (5) o adran 3 o Ddeddf 1972 (treuliau cadeirydd);
 - (ii) o dan is-adran (4) o adran 5 o'r Ddeddf honno (treuliau is-gadeirydd);
 - (iii) o dan is-adran (4) o adran 173 (lwfans colled ariannol) o'r Ddeddf honno(a);
 - (iv) o dan adran 175 o'r Ddeddf honno (lwfansau ar gyfer mynchy cynadleddau a chyfarfodydd);
- (b) yn ôl pa gyfraddau y mae taliadau i gael eu gwneud o dan adran 174 o'r Ddeddf honno (lwfansau teithio a lwfansau cynhaliaeth);

(4) The individual or body by whom a determination is made pursuant to paragraph (2) shall, as soon as reasonably practicable after the making of the determination, submit to the authority a report which shall include particulars of -

- (a) the determination;
- (b) the emergency or other circumstances in which it was made; and
- (c) the reasons for the determination.

(5) Section 101 of the 1972 Act shall not apply with respect to the discharge of a function referred to in paragraph (1) which, by virtue of that paragraph, is not the responsibility of the Board of the authority.

 - (i) by the Board,
 - (ii) by a member of the Board;
 - (iii) by a committee of the Board;

Discharge of functions by area committees

14.-(1) A relevant body with power to make arrangements in accordance with regulation 13 may arrange for the discharge of any functions which are the responsibility of the Board of the local authority by an area committee of that authority.

(2) Where by virtue of this regulation any functions may be discharged by an area committee, then, unless the relevant body directs otherwise, the area committee may arrange for the discharge of any of those functions by a sub-committee of that committee or by an officer of the authority.

Arrangements for functions of a local authority to be discharged by the Board of another local authority

16.-(1) A local authority may make arrangements with another local authority for the discharge by the Board of that local authority of any functions of the first mentioned authority which are not the responsibility of the Board of that authority if -

- (a) the functions are not functions of that other local authority; or
- (b) the functions are functions of that other local authority and are the responsibility of the Board of that other authority.

(2) Where by virtue of paragraph (1) above any functions may be discharged by a committee of a local authority, then, unless that authority otherwise directs, the committee may arrange for the discharge of any of those functions by a sub-committee or an officer of the authority.

(3) Where by virtue of paragraph (1) or (2) above any functions may be discharged by a sub-committee of a local authority, then, unless that authority or, as the case may be, that committee otherwise directs, the sub-committee may arrange for the discharge of any of those functions by an officer of the authority.

Joint exercise of functions

19.-(1) Arrangements made under section 101(5) of the 1972 Act by a relevant body must be made in accordance with this regulation.

(2) The arrangements must be made -

- (a) where the functions to which the arrangements relate are the responsibility of the Board of the other local authority concerned, with the relevant body which has power to make such arrangements on behalf of that authority;
- (b) in any other case, with the other local authority.

(3) If the arrangements provide for the discharge of functions by a joint committee, appointments of the persons who are to represent each local authority on that committee must be made, and the number of such persons to be appointed must be determined, by the relevant body by which the arrangements are made on

(6) Where arrangements made on behalf of a local authority in accordance with this regulation by a relevant body provide for the appointment to a joint committee of persons who are not members of the Board of that authority, the relevant body must, as soon as reasonably practicable after making the arrangements, secure that copies of a document setting out the provisions of the arrangements are available at the authority's principal office for inspection by members of the public at all reasonable hours.

(7) A relevant body preparing the document referred to in paragraph (6) above shall have regard to any guidance issued by the National Assembly for Wales under section 38 of the 2000 Act.

(8) Part VA of the 1972 Act (access to meetings and documents of certain authorities, committees and sub-committees) shall apply to a joint committee established in accordance with this regulation.

Members of joint committees

20.-(1) Subject to paragraphs (2) and (3) below, every person appointed to a joint committee in accordance with regulation 19 above by a relevant body must be a member of the local authority, and the political balance requirements shall not apply to the appointment of such members.

(2) Where -

- (a) the joint committee has functions in respect of part only of the area of one of the local authorities concerned;
- (b) those functions are the responsibility of the Board of that authority; and
- (c) the population of that part, as estimated by the authority, does not exceed fifteen percent of the total population of the area of the authority
