1. Mae'r Rheoliadau hyn yn diwygion am y trydydd tro Reoliadau Porthiant (Cymru) 2001 (O.S. 2001/343 (Cy.15), "y prif Reoliadau").

2. Mae'r Rheoliadau hyn yn gymwys i Gymru yn unig. Mae Rheoliadau Porthiant (Diwygio) 2002 (O.S. 2002/892, "Rheoliadau Cymru a Lloegr"), sy'n gweithredu'r un newidiadau yn Lloegr ag a wneir mewn perthynas â Chymru gan y Rheoliadau hyn, yn cynnwys dwy ddarpariaeth sydd hefyd yn gymwys i Gymru a Gogledd Iwerddon. Mae rheoliad 3 o Reoliadau Cymru a Lloegr yn gymwys i Gymru, Lloegr a Gogledd Iwerddon i'r graddau y mae'n berthnasol i reoliad 11 (fel y'i diwygiwyd gan Reoliadau Cymru a Lloegr) neu 12 o'r Prif Reoliadau. Mae rheoliad 5 o Reoliadau Cymru a Lloegr hefyd yn gymwys i Gymru, Lloegr a Gogledd Iwerddon.

3. Mae'r Rheoliadau hyn yn gweithredu -

The Feeding Stuffs (Amendment) (Wales) Regulations 2002

EXPLANATORY NOTE

(*This note is not part of the Regulations*)

1. These Regulations amend for the third time the Feeding Stuffs Regulations (Wales) 2001 (S.I. 2001/343 (W.15), "the principal Regulations").

2. These Regulations apply to Wales only. The Feeding Stuffs (Amendment) Regulations 2002 (S.I. 2002/892, "the England and Wales Regulations"), which implement the same changes in England as are made in respect of Wales by these Regulations, contain two provisions which also apply to Wales and Northern Ireland. Regulation 3 of the England and Wales Regulations applies to England, Wales and Northern Ireland in so far as it relates to regulation 11 (as amended by the England and Wales Regulations) or 12 of the principal Regulations. Regulation 5 of the England and Wales Regulations also applies to England, Wales and Northern Ireland.

3. These Regulations implement -

- Commission Directive 2001/79/EC amending Council Directive 87/153/EEC fixing guidelines for the assessment of additives in animal nutrition (OJ No. L267, 6.10.2001, p.1);
- Council Directive 2001/102/EC amending Directive 1999/29/EC on the undesirable substances and products in animal nutrition (OJ No. L6, 10.1.2002, p.45); and
- Commission Directive 2002/1/EC amending Directive 94/39/EC as regards animal feedingstuffs for the support of liver function in case of chronic liver insufficiency.

4. Mae'r Rheoliadau hyn hefyd yn darparu ar gyfer gorfodi'r Rheoliadau canlynol -

- (b) yn ychwanegu tri Rheoliad newydd gan y Comisiwn at restr Rheoliadau'r Comisiwn y rhoddyd awdurdodiad odanynt i farchnata ychwanegion bwyd a gynhwysir yn Atodlen 3 i'r prif Reoliadau (*rheoliad 7 ac Atodlen 1*);
- (c) addasu'r rheolaethau yn y prif Reoliadau sy'n rheoli presenoldeb sylweddau annymunol mewn porthiant anifeiliaid drwy bennu uchafswm lefelau newydd ar gyfer Diocsin mewn porthiant (*rheoliad 8 ac Atodlen 2*);
- (ch) addasu darpariaethau'r prif Reoliadau sy'n rheoli porthiant dietetig o ran y nodweddion maethlon a labelu porthiant sy'n ofynnol pan fwriedir ef i gynorthwyo swyddogaeth yr afu mewn achos o annigonedd cronig yr afu mewn cŵn neu gathod (*rheoliad 10 ac Atodlen 3*);
- (d) gwneud diwygiadau i'r prif Reoliadau i gywiros mân wallau ynddynt (*rheoliadau 4 a 9*); ac
- (dd) gwneud diwygiadau canlyniadol i'r Rheoliadau hynny ac i Reoliadau Porthiant (Samplu a Dadansoddi) 1999 (O.S.1999/1663), Rheoliadau Porthiant (Sefydliadau a Chyfryngwyr) 1999 (O.S. 1999/1872) a Rheoliadau Porthiant (Gorfodi) 1999 (O.S. 1999/2325) (*rheoliadau 1999, 3, 6 ac 11 i 13*).
- (e) Noder hefyd yr effaith ar Reoliadau Cymru a Lloegr y cyfeirir atynt ym mharagraff 2 uchod, sy'n addasu darpariaethau'r prif Reoliadau sy'n pennu'r weithdrefn i'w dilyn mewn perthynas

4. These Regulations also provide for the enforcement of the following Regulations -

- (a) Commission Regulation (EC) No. 2013/2001 concerning the provisional authorisation of a new additive use and the permanent authorisation of an additive in feedingstuffs (OJ No. L272, 13.10.2001, p.24);
 - (b) Commission Regulation (EC) No. 2200/2001 concerning provisional authorisation of additives in feedingstuffs (OJ No. L299, 15.11.2001, p.1); and
 - (c) Commission Regulation (EC) No. 256/2002 concerning the provisional authorisation of an additive and the permanent authorisation of an additive in feedingstuffs (OJ No. L41, 13.2.2002, p.6).
5. These Regulations -
- (a) modify the provisions of the principal Regulations which provide for the enforcement of the provisions of those Regulations which are made under the European Communities Act 1972 (*regulation 5*);
 - (b) add three new Commission Regulations to the list of Commission Regulations under which authorisation for the marketing of feed additives has been granted which is contained in Schedule 3 to the principal Regulations (*regulation 7 and Schedule 1*);
 - (c) modify the controls in the principal Regulations regulating the presence of undesirable substances in animal feed by specifying new maximum levels for Dioxin in feed (*regulation 8 and Schedule 2*);
 - (d) modify the provisions of the principal Regulations regulating dietetic feeds as regards the required nutritional characteristics and labelling of feeds intended for the support of liver function in case of chronic liver insufficiency in dogs or cats (*regulation 10 and Schedule 3*);
 - (e) make amendments to the principal Regulations to correct minor errors in them (*regulations 4 and 9*); and
 - (f) make consequential amendments to those Regulations and to the Feeding Stuffs (Sampling and Analysis) Regulations 1999 (S.I.1999/1663), the Feeding Stuffs (Establishments and Intermediaries) Regulations 1999 (S.I. 1999/1872) and the Feeding Stuffs (Enforcement) Regulations 1999 (S.I. 1999/2325) (*regulations 3, 6 and 11 to 13*).
 - (g) Note also the effect of the England and Wales Regulations referred to in paragraph 2 above, which modify the provisions of the principal Regulations which specify the procedure to be

The National Assembly for Wales, acting in exercise of the powers conferred by sections 66(1), 68(1) and (1A), 69(1), 74A, 75(1), 76(1), 77(4), 78(6), 79(1) and 84 of the Agriculture Act 1970(a) and now exercisable by it in relation to Wales(b), after consultation as required by section 84(1) of that Act with the persons or organisations appearing to represent the interests concerned(c), and having been designated(d) for the purposes of section 2(2) of the European Communities Act 1972(e) in relation to the common agricultural policy of the European Community, in exercise of the powers conferred by the said section 2(2) (in so far as these Regulations cannot be made under the powers in the Agriculture Act 1970 specified above), makes the following Regulations:

Title, commencement and extent

1. These Regulations may be cited as the Feeding Stuffs (Amendment) (Wales) Regulations 2002, shall come into force on 5th August 2002 and shall apply to Wales only.

Amendment of the Feeding Stuffs (Wales) Regulations 2001

2. The Feeding Stuffs (Wales) Regulations 2001 ("the principal Regulations")(f) shall be amended in accordance with regulations 3 to 10 below.

(a) 1970 c. 40.

(b) By virtue of the National Assembly for Wales (Transfer of Functions) 1999 (S.I. No. 1999/672).

(c) The requirement to consult must now be read in conjunction with Article 9 of Regulation (EC) No. 178/2002 (OJ No. L31, 1.2.2002, p.1).

(d) S.I. 1999/2788.

(e) 1972 c. 68. The enabling powers conferred by section 2(2) were extended by virtue of section 1 of the European Economic Area Act 1993 (1993 c. 51).

(f) S.I. 2001/343 (W.15), amended by S.I. 2001/2253 (W.163) and S.I. 2001/3461 (W.280).

3. 3. In each of regulations 7(1) and 24(1), after the expression "the Feeding Stuffs and the Feeding Stuffs (Enforcement) (Amendment) (Wales) Regulations 2001" there shall be added the expression "and the Feeding Stuffs (Amendment) (Wales) Regulations 2002".

4. In paragraph (2) of regulation 17, for the expression "Schedule 10" there shall be substituted the expression "Schedule 9".

5. In paragraph (2) of regulation 24, for the word "regulations" to the end there shall be substituted the following provisions -

"regulation 4 (except in so far as it relates to Part II of Schedule 5), 9(1) (in so far as it regulates putting into circulation), (2) and (3), 10(1) to (4), (6), (6A) and (7), 11(2) (in so far as it falls to be read with paragraph (3)(a), (c) or (d) of that regulation), (4), (6) and (7), 12(3), (4), (6), (7) and (9), 13(1), 15, 16(1) and 17(1)".

6. Regulation 25(a) and (b) shall be revoked.

7. In Schedule 3 (permitted additives and provisions relating to their use), for the provisions in Part IX of the Table (European Community Regulations by which additives are controlled) there shall be substituted the provisions set out in Schedule 1 to these Regulations.

8. In Schedule 7 (prescribed limits for undesirable substances) -

- (a) for the entry for Dioxin (sum of PCDD and PCDF) in column 1 of Chapter A of Part I of the Table and the corresponding entries in columns 2 and 3 respectively of that Chapter; and
- (b) for the entry for Dioxin (sum of PCDD and PCDF) in column 1 of Chapter A of Part II of the Table and the corresponding entries in columns 2 and 3 respectively of that Chapter;

there shall be substituted the entries set out in Schedule 2 to these Regulations.

9. In Schedule 8 (control of certain protein sources) for the entry in column 6 ("ruminants from the beginning of rumination") corresponding with the entry in column 2 relating to "3.1.1 DL-methionine, technically pure" there shall be substituted the entry "All animal species".

10. In Schedule 9 (permitted feeding stuffs intended for particular nutritional purposes and provisions relating to their use) for the entries in columns 2 to 6 of Chapter A relating to the support of liver function in case of chronic liver insufficiency in dogs or cats there shall be substituted the entries set out in Schedule 3 to these Regulations.

Amendment of the Feeding Stuffs (Sampling and Analysis) Regulations 1999

11. The Feeding Stuffs (Sampling and Analysis) Regulations 1999(a) shall be amended in so far as they apply to Wales as follows -

- (a) in Part II of Schedule 1 (manner of taking, preparing, marking, sealing and fastening of samples), in paragraph 5(1), for the expression "section 76(1)(b) of the Act" there shall be inserted the expression "section 76(7) of the Act as that section is modified by regulation 10 of the Feeding Stuffs (Enforcement) Regulations 1999(b) as amended";
- (b) in Part I of Schedule 2 (methods of analysis), at the end of paragraph 3(e)(ii), for the expression "Schedule 5 to the Feeding Stuffs Regulations 1995" there shall be substituted the expression "Schedule 7 to the Feeding Stuffs (Wales) Regulations 2001 as amended by the Feeding Stuffs and the Feeding Stuffs (Enforcement) (Amendment) (Wales) Regulations 2001(c) and the Feeding Stuffs (Amendment) (Wales) Regulations 2002"; and
- (c) in Part II of Schedule 3 (form of certificate of analysis), in note 11(a), for the expression "the Feeding Stuffs Regulations 1995" there shall be substituted the expression "the Feeding Stuffs (Wales) Regulations 2001 as amended by the Feeding Stuffs and the Feeding Stuffs (Enforcement) (Amendment) (Wales) Regulations 2001 and the Feeding Stuffs (Amendment) (Wales) Regulations 2002".

Amendment of the Feeding Stuffs (Establishments and Intermediaries) Regulations 1999
