(Nid yw'r nodyn hwn yn rhan o'r Gorchymyn)

Mae'r Gorchymyn hwn yn addasu deddfwriaeth sylfaenol ac eilaidd ac yn gwneud darpariaethau eraill at ddibenion, yn ganlyniadol i, neu ar gyfer rhoi effaith lawn i ddarpariaethau Rhan II o Ddeddf Llywodraeth Leol 2000 ("Deddf 2000"). Mae'r Gorchymyn hwn a'r addasiadau a wneir ganddo yn gymwys i Gymru yn unig.

Mae erthyglau 3 a 9 yn addasu Deddf Llywodraeth Leol 1972. Mae erthygl 3 yn rhwystro awdurdod lleol neu awdurdod ar y cyd rhag hybu Mesur i ffurfio, newid neu ddiddymu trefniadau gweithrediaeth neu drefniadau amgen neu i newid trefniadau ar gyfer ethol Mae erthyglau 4 a 5 yn cymhwyso'r cymwysterau a'r datgymwysterau ar gyfer ethol a dal swydd fel maer etholedig. Mae **erthygl 6** yn ymestyn darpariaethau ar gyfer dilysrwydd gweithrediadau a wneir gan bersonau anghymwysedig i feiri etholedig ac arweinyddion gweithrediaeth. Mae erthygl 7 yn addasu'r darpariaethau ar gyfer ymadael â swydd o ganlyniad i fethu â mynychu cyfarfodydd fel eu bod yn gymwys i aelodau'r weithrediaeth. Mae erthygl 8 yn addasu'r darpariaethau ar gyfer peidio â phenodi aelodau awdurdodau lleol yn swyddogion fel y gellir penodi person sy'n aelod o weithrediaeth arweinydd a chabinet (a fydd hefyd yn aelod o'r awdurdod) i swydd sy'n derbyn tâl yn ystod y cyfnod o ddeuddeg mis wedi ef neu hi beidio â bod yn aelod felly o'r weithrediaeth. Mae erthygl 9 yn addasu'r ddarpariaeth ddehongli drwy fewnosod diffiniad o "drefniadau amgen".

### LOCAL GOVERNMENT, WALES

The Local Authorities (Executive and Alternative Arrangements) (Modification of Enactments and Other Provisions) (Wales) Order 2002

#### **EXPLANATORY NOTE**

(This note is not part of the Order)

This Order modifies primary and secondary legislation and makes other provisions for the purposes of, in consequence of, or for giving full effect to provisions in Part II of the Local Government Act 2000 ("the 2000 Act"). This Order and the modifications made by it apply to Wales only.

Articles 3 to 9 make modifications to the Local Government Act 1972. Article 3 prevents a local authority or joint authority from promoting a Bill to form, alter or abolish executive arrangements or alternative arrangements or to alter arrangements for electing a mayor. Articles 4 and 5 apply the qualifications and disqualifications for election and holding office as an elected mayor. Article 6 extends to elected mayors and executive leaders provisions for the validity of acts done by unqualified persons. Article 7 modifies the provisions for the vacation of office by failure to attend meetings so that they apply to members of the executive. Article 8 modifies the provisions for members of local authorities not to be appointed as officers so that a person who is a member of a leader and cabinet executive (who will also be a member of the authority) may be appointed to paid office during the twelve month period after he ceases to be such an executive member. Article 9 modifies the interpretation provision by inserting a definition of "alternative arrangements".

Mae erthygl 10 yn addasu adran 31A o Ddeddf Llywodraeth Leol 1974 fel bod cyfyngiadau sy'n ymwneud ag ystyried adroddiad gan y Comisiynydd Lleol yr un mor gymwys i'r weithrediaeth, pwyllgorau'r weithrediaeth ac aelodau'r weithrediaeth ag ydynt i bwyllgorau'r awdurdod ac aelodau'r awdurdod.

Mae **erthygl 11** yn addasu adran 41 o Ddeddf Llywodreth Leol (Darpariaethau Amrywiol) 1976 fel y gellir defnyddio cofnodion penderfyniadau a wnaed gan y weithrediaeth, aelodau'r weithrediaeth a phwyllgorau'r weithrediaeth fel tystiolaeth mewn achos sifil, yn yr un modd â chofnodion cyfarfodydd y cyngor a'i bwyllgorau.

Mae erthygl 12 yn addasu adran 74 o Ddeddf Trafnidiaeth 1974 fel nad oes modd i aelod o'r weithrediaeth sydd hefyd yn gyfarwyddwr cwmni trafnidiaeth gyhoeddus gymryd rhan yng nghyfarfodydd y weithrediaeth neu bwyllgor o'r weithrediaeth neu wneud penderfyniadau ar ei ben ei hun pan fo contractau sy'n ymwnueud â'r cwmni hwnnw yn cael eu hystyried.

Mae **erthygl 13** yn gwneud diwygiadau canlyniadol i adran 5 o Ddeddf Pwysau a Mesurau 1985.

Mae **erthygl 14** yn addasu adran 6 o Ddeddf Llywodraeth Leol 1986 fel nad yw darpariaethau cyhoeddusrwydd awdurdodau lleol Rhan II y Ddeddf honno yn gymwys i weithrediaethau awdurdodau lleol trwy rinwedd adran 22 o Ddeddf Llywodraeth Leol 2000.

Mae erthygl 15 yn addasu adran 18 o Ddeddf Meysydd Awyr 1986 fel nad oes modd i aelod gweithrediaeth sydd hefyd yn gyfarwyddwr cwmni maes awyr cyhoeddus gymryd rhan yng nghyfarfodydd y weithrediaeth, neu bwyllgor gweithrediaeth neu wneud penderfyniad ar ei ben ei hun pan fod contractau neu faterion eraill sy'n ymwneud â'r cwmni maes awyr yn cael eu hystyried.

Mae **erthygl 16** yn addasu adran 3 o Ddeddf Peilota 1987 fel nad yw peilot harbwr sy'n aelod o weithrediaeth awdurdod yn cael ei rwystro rhag cymryd rhan mewn penderfyniad ar y cyd pan fo gwybodaeth am beilota yn bwysig.

Mae erthygl 17 yn addasu'r darpariaethau contractau cyflenwi cyhoeddus neu gontractau gwaith yn Neddf Llywodraeth Leol 1988. Caiff Atodlen 2 ei haddasu fel bod gweithrediaeth awdurdod lleol yn awdurdod cyhoeddus at ddibenion adran 17 o'r Ddeddf honno (eithrio ystyriaethau anfasnachol tra'n arfer swyddogaethau mewn perthynas â chontractau cyflenwi cyhoeddus neu gontractau gwaith awdurdod lleol). Caiff adran 19 ei haddasu fel bod adran 17 yn gymwys i awdurdod lleol arall, sy'n cyflawni swyddogaethau ar ran gweithrediaeth awdurdod lleol, ac i weithrediaeth awdurdod lleol arall, sy'n cyflawni swyddogaethau ar ran awdurdod lleol neu weithrediaeth awdurdod lleol.

**Article 10** modifies section 31A of the Local Government Act 1974 so that restrictions relating to consideration of a report from the Local Commissioner apply equally to the executive, committees of the executive and members of the executive as they do to committees of and members of the authority.

Article 11 modifies section 41 of the Local Government (Miscellaneous Provisions) Act 1976 so that records of decisions made by the executive, members of the executive and committees of the executive can be used as evidence in civil proceedings in the same way as minutes of meetings of the council and its committees.

Article 12 modifies section 74 of the Transport Act 1974 so that a member of the executive who is also a director of a public transport company cannot take part in meetings of the executive or a committee of the executive or make a decision acting alone where contracts concerning that company are being considered.

**Article 13** makes a consequential amendment to section 5 of the Weights and Measures Act 1985.

Article 14 modifies section 6 of the Local Government Act 1986 so that the local authority publicity provisions in Part II of that Act do not apply where access to information provisions apply to local authority executives by virtue of section 22 of the Local Government Act 2000.

Article 15 modifies section 18 of the Airports Act 1986 so that a member of an executive who is also a director of a public airport company cannot take part in meetings of the executive, or a committee of an executive or make a decision alone where contracts or other matters concerning the airport company are being considered.

**Article 16** modifies section 3 of the Pilotage Act 1987 so that a harbour pilot who is a member of the executive of an authority is not prevented from taking part in a collective decision where knowledge of pilotage is material.

Article 17 modifies the public supply or works contracts provisions in the Local Government Act 1988. Schedule 2 is modified so that a local authority executive is a public authority for the purposes of section 17 of that Act (exclusion of non-commercial considerations when exercising functions in relation to a public authority's public supply or works contracts). Section 19 is modified so that section 17 applies to another local authority, which is discharging functions on behalf of a local authority's executive, and to another local authority's executive, which is discharging functions on behalf of local authority or a local authority's executive.

Mae erthyglau 18 i 20 yn addasu Deddf Cyllid Llywodreth Leol 1988. Mae erthygl 18 yn ychwanegu diffiniadau pellach i'r adran ar ddehongli. Mae erthygl 19 yn addasu adran 114 ac yn mewnosod adran 114A newydd fel bod darpariethau i brif swyddog cyllid awdurdod lunio adroddiad ar achosion o gamymddwyn ariannol gan awdurdod lleol yn cael eu hymestyn i weithrediaeth awdurdod lleol. Pan fo adroddiad wedi cael ei wneud, bydd y darpariaethau yn adran 115B (dyletswyddau gweithrediaethau mewn perthynas ag adroddiadau) a fewnosodwyd gan erthygl 20, yn gymwys, gan gynnwys rhwymedigaeth i'r prif weithredwr wneud adroddiad ar ôl ystyried adroddiad y prif swyddog cyllid. Mae adran 116 yn cael ei haddasu fel bod gwybodaeth ynghylch cyfarfodydd y weithrediaeth o dan adran 115B yn cael ei hanfon at archwilydd yr awdurdod.

Mae **erthyglau 21 i 25** yn addasu Deddf Llywodraeth Leol a Thai 1989. Mae **erthygl 21** yn addasu adran 2 fel bod rhoi cyngor yn rheolaidd i weithrediaeth, pwyllgor gweithrediaeth neu aelod o'r weithrediaeth yn ddyletswydd swydd mewn awdurdod lleol at ddibenion yr adran honno. Mae erthygl 22 yn addasu adran 5 ac yn mewnosod adran 5A newydd fel bod y darpariaethau ar i swyddog monitro awdurdod lunio adroddiad pan fo awdurdod lleol yn torri'r gyfraith, yn camweinyddu neu'n ymddwyn yn anghyfiawn yn cael eu hymestyn i weithrediaeth awdurdod lleol. Rhaid i'r weithrediaeth baratoi adroddiad ar ôl ystyried adroddiad y swyddog monitro. Mae erthygl 23 yn ymestyn y darpariaethau sy'n ymwneud â chynorthwywyr grŵpiau gwleidyddol fel na all cynorthwy-ydd gwleidyddol gyflawni swyddogaethau sy'n arferadwy gan neu ar ran gweithrediaeth awdurdod lleol. Mae erthygl 24 yn mewnosod diffiniadau pellach yn adran 21 (dehongli Rhan I). Mae erthygl 25 yn addasu Rhan V (cwmnïau y mae gan awduroddau lleol fuddiant ynddynt) fel bod rhai darpariaethau sy'n cyfeirio at aelodau awdurdod, neu bwyllgor neu is-bwyllgor awdurdod, yn cael eu hymestyn i weithrediaeth, aelodau gweithrediaeth neu bwyllgor gweithrediaeth fel sy'n briodol.

Mae **erthygl 26** yn addasu adran 97 o Ddeddf y Diwydiant Dŵr 1991 fel pan fo ymgymerydd carthffosiaeth wedi trefnu i rai swyddogaethau carthffosiaeth gael eu harfer gan awdurdod lleol bod swyddogaethau o'r fath yn cael eu trin fel swyddogaethau'r awdurdod lleol at ddibenion adran 13 o Ddeddf 2000.

Mae **erthygl 27** yn addasu adran 106 o Ddeddf Cyllid Llywodraeth Leol 1992 fel na all aelod o'r weithrediaeth nad ydyw wedi talu ei dreth gyngor ers o leiaf dau fis gymryd rhan ym mhenderfyniadau'r weithrediaeth mewn perthynas â chyllideb y cyngor, y dreth gyngor neu archebiant.

Mae **erthygl 28** yn addasu adran 70 o Ddeddf Dadreoleiddio a Chontractio Allan 1994 (swyddogaethau awdurdodau lleol) fel ei bod yn gymwys mewn perthynas â gweithrediaeth awdurdod lleol.

Articles 18 to 20 modify the Local Government Finance Act 1988. Article 18 adds further definitions to the interpretation section. Article 19 modifies section 114 and inserts a new section 114A so that provisions for an authority's chief finance officer to make a report in cases of financial misconduct by a local authority are extended to a local authority's executive. Where a report has been made, the provisions in new section 115B (duties of executive as regards reports), inserted by article 21, apply, including a requirement for the executive to make a report after considering the chief finance officer's report. Section 116 is modified so that information about meetings of the executive under section 115B is sent to the authority's auditor.

Article 21 to 25 modify the Local Government and Housing Act 1989. Article 21 modifies section 2 so that giving advice on a regular basis to an executive, executive committee or executive member is a duty of a post under a local authority for the purposes of that section. Article 22 modifies section 5 and inserts a new section 5A so that provisions for an authority's monitoring officer to make a report in cases of a contravention of law, maladministration or injustice by a local authority are extended to a local authority's executive. The executive must prepare a report after considering the monitoring officer's report. Article 23 extends the provisions relating to assistants for political groups so that a political assistant cannot discharge functions which are exercisable by or on behalf of a local authority's executive. Article 24 inserts further definitions in section 21 (interpretation of Part I). Article 25 modifies Part V (companies in which local authorities have interests) so that certain provisions which refer to members of an authority, or a committee or sub-committee of an authority, are extended to an executive, members of an executive or an executive committee, as appropriate.

Article 26 modifies section 97 of the Water Industry Act 1991 so that where a sewerage undertaker has arranged for certain sewerage functions to be exercised by a local authority then such functions are treated as functions of the local authority for the purposes of section 13 of the 2000 Act.

**Article 27** modifies section 106 of the Local Government Finance Act 1992 so that an executive member who has not paid their council tax for at least two months shall not take part in executive decisions in respect of the council's budget, council tax or precept.

**Article 28** modifies section 70 of the Deregulation and Contracting Out Act 1994 (functions of local authorities) so that it applies in relation to a local authority's executive.

Mae **erthygl 29** yn addasu adran 50 o Ddeddf Hawliau Cyflogaeth 1996 fel bod gan gyflogeion yr hawl i gael amser i ffwrdd o'u gwaith er mwyn ymgymryd â busnes fel aelod o weithrediaeth awdurdod lleol.

Mae erthygl 30 yn addasu Atodlen 1 i Ddeddf Ddifenwi 1996 fel bod cofnodion cyfarfodydd cyhoeddus y weithrediaeth neu bwyllgorau'r weithrediaeth a chofnodion penderfyniadau a wneir gan aelodau unigol gweithrediaeth yn cael eu dosbarthu fel gwybodaeth freintiedig yn ddarostyngedig i eglurhad neu wrth-ddweud mewn achosion o ddifenwad.

Mae **erthygl 31** yn addasu Atodlen 1 i Ddeddf Addysg 1996 gan wneud diwygiadau canlyniadol i bwerau'r Ysgrifennydd Gwladol i wneud darpariaeth ynghylch pwyllgorau rheoli unedau cyfeirio disgyblion.

Mae **erthygl 32** yn addasu adran 66 o Ddeddf Ynadon Heddwch 1997 fel na all ynad heddwch sy'n aelod o awdurdod lleol weithredu fel aelod o Lys y Goron neu lys yr ynadon mewn unrhyw achos sy'n ymwneud â phenderfyniad a wnaed gan y weithrediaeth neu gan unrhyw berson sy'n gweithredu ar ran y weithrediaeth.

Mae erthygl 33 yn addasu adran 23 o Ddeddf Addysgu ac Addysg Uwch 1988 fel pan fo'r Ysgrifennydd Gwladol wedi trefnu bod rhai swyddogaethau sy'n ymwneud â chefnogi myfyrwyr yn cael eu harfer gan awdurdod lleol bod y swyddogaethau hynny yn cael eu trin fel swyddogaethau'r awdurdod at ddibenion adran 13 o Ddeddf 2000.

Mae **erthygl 34** yn addasu adran 137 o Ddeddf Pwerau Llysoedd Troseddol 2000 fel bod yr adran hon yn gymwys pan fo awdurdod yn gweithredu trefniadau gweithredol.

Mae erthygl 35 yn addasu rheoliad 5 o Rheoliadau Asiantaethau Mabwysiadu 1983 er mwyn darparu pan fo awdurdod lleol yn gweithredu trefniadau gweithredol ac felly nad oes ganddo bwyllgor gwasanaethau cymdeithasol y gall benodi aelod ohono i'r panel mabwysiadu, bod y cyfeiriad at y pwyllgor gwasanaethau cymdeithasol yn cael ei drin fel cyfeiriad at weithrediaeth yr awdurdod neu bwyllgor trosolwg a chraffu yr awdurdod (pan fo swyddogaethau'r pwyllgor hwnnw yn ymwneud yn gyfangwbl neu'n rhannol â swyddogaethau gwasanaethau cymdeithasol yr awdurdod hwnnw).

Mae erthygl 36 yn addasu'r Diffiniad o Rheoliadau Ymwelwyr Annibynnol (Plant) 1991. Caiff person a benodir gan awdurdod lleol fel ymwelydd annibynnol ei ystyried fel person sy'n annibynnol o'r awdurdod sy'n ei benodi pan, er enghraifft, nad yw'r person a benodir yn gysylltiedig â'r awdurdod lleol trwy rinwedd bod yn aelod o'r awdurdod. Mae'r addasiad yn ymestyn y ddarpariaeth hon fel bod person hefyd yn

**Article 29** modifies section 50 of the Employment Rights Act 1996 so that employees have a right to time off work in order to undertake business as a member of a local authority executive.

Article 30 modifies Schedule 1 to the Defamation Act 1996 so that records of public meetings of the executive or committees of the executive and records of decisions made by individual members of an executive are classified as information which is privileged subject to explanation or contradiction in defamation proceedings.

Article 31 modifies Schedule 1 to the Education Act 1996 making consequential amendments to the Secretary of State's powers to make provision concerning management committees for pupil referral units

Article 32 modifies section 66 of the Justices of the Peace Act 1997 so that a justice of the peace who is a member of a local authority cannot act as a member of a Crown Court or magistrates court in any proceedings concerning decisions made by the executive or by any person on behalf of the executive.

Article 33 modifies section 23 of the Teaching and Higher Education Act 1988 so that where the Secretary of State has arranged for certain functions relating to student support to be exercised by a local education authority then such functions are to be treated as functions of the authority for the purposes of section 13 of the 2000 Act.

**Article 34** modifies section 137 of the Powers of Criminal Courts Act 2000 so that this section applies where a local authority is operating executive arrangements.

Article 35 modifies regulation 5 of the Adoption Agencies Regulations 1983 to provide that where a local authority operates executive arrangements and therefore has no social services committee from which to appoint a member to the adoption panel, the reference to the social services committee is to be treated as a reference to the authority's executive or an overview and scrutiny committee of the authority (where that committee's functions relate wholly or partly to the authority's social services functions).

Article 36 modifies the Definition of Independent Visitors (Children) Regulations 1991. A person appointed by a local authority as an independent visitor is regarded as independent of the authority appointing him where, for example, the person appointed is not connected with the local authority by virtue of being a member of the authority. The modification extends this provision so that a person is also connected with

Mae Rheoliad 8 o Rheoliadau Plant (Llety Diogel) 1991 yn gwneud darpariaethau fel mai dim ond yr awdurdod lleol sy'n edrych ar ôl y plentyn hwnnw gaiff wneud cais i lys o dan adran 25 o Ddeddf Plant 1989 (p. 41) (defnydd o lety i gyfyngu ar ryddid) mewn perthynas â phlentyn. Mae hyn yn ddarostyngedig i adran 101 o Ddeddf Llywodraeth Leol 1972. Mae **erthygl 37** o'r Gorchymyn hwn yn gwneud y ddarpariaeth yn rheoliad 8 hefyd yn ddarostyngedig i ddarpariaethau yn neu o dan adrannau 14 i 20 o Ddeddf Llywodraeth Leol 2000.

Mae rheoliad 4 o Reoliadau'r Dreth Gyngor (Gweinyddu a Gorfodi) 1992 yn galluogi awdurdod bilio i ofyn am wybodaeth benodol at ddibenion ei swyddogaethau o dan Ran I o Ddeddf Cyllid Llywodraeth Leol 1992. Mae eithriadau i'r wybodaeth y gellir gofyn amdani. Mae'r eithriadau hyn yn cael eu haddasu gan **erthygl 38** o'r Gorchymyn hwn fel eu bod yn cynnwys gwybodaeth a gafwyd gan weithrediaeth, neu bwyllgor neu aelod o weithrediaeth, awdurdod lleol yn rhinwedd yr awdurdod lleol hwnnw fel cyngor cyfansoddol o awdurdod heddlu.

Mae erthygl 39 yn addasu'r diffiniad o "awdurdod lleol" yn Rheoliadau Addysg (Anghenion Addysgol Arbennig) (Cymeradwyo Ysgolion Annibynnol) 1994 er mwyn adlewyrchu'r ffaith, pan fo awdurdod lleol yn gweithredu trefniadau gweithredol, bod gan ei weithrediaeth gyfrifoldeb ar gyfer arfer y rhan fwyaf o'i swyddogaethau gwasanaethau cymdeithasol.

Mae **erthygl 40** yn gwneud darpariaethau amrywiol mewn perthynas ag aelodau gweithrediaeth sy'n peidio â bod yn aelodau o'r awdurdod lleol.

Mae **erthygl 41** yn gwneud darpariaethau ar gyfer maer dros dro ac aelodau dros dro pan nad oes modd i aelodau gweithrediaeth maer a chabinet weithredu.

the local authority by virtue of being a council manager and therefore a council manager is not to be regarded as independent of the authority.

Regulation 8 of the Children (Secure Accommodation) Regulations 1991 provides that applications to a court under section 25 of the Children Act 1989 (c. 41) (use of accommodation for restricting liberty) in respect of a child must be made only by the local authority which are looking after that child. This is subject to section 101 of the Local Government Act 1972. **Article 37** of this Order makes the provision in regulation 8 also subject to provisions in or under sections 14 to 20 of the Local Government Act 2000.

Regulation 4 of the Council Tax (Administration and Enforcement) Regulations 1992 enable a billing authority to request certain information for the purpose of its functions under Part I of the Local Government Finance Act 1992. There are exceptions to the information that can be requested. These exceptions are modified by **Article 38** of this Order to include information that was obtained by an executive, or a committee or member of an executive, of a local authority in that local authority's capacity as a constituent council of a police authority.

Article 39 modifies the definition of "local authority" in the Education (Special Educational Needs) (Approval of Independent Schools) Regulations 1994 to reflect the fact that, where a local authority is operating executive arrangements, its executive has responsibility for exercising most of its social services functions.

**Article 40** makes various provisions in relation to members of an executive who cease to be members of the local authority.

**Article 41** makes provisions for an interim mayor and interim members where members of a mayor and cabinet executive are unable to act.

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Gorchymyn canlynol drwy arfer y pwerau a roddwyd iddo gan adrannau 47, 105 a 106 o Ddeddf Llywodraeth Leol 2000(**a**), a'r holl bwerau eraill sy'n ei alluogi yn y cyswllt hwnnw:

The Local Authorities (Executive and Alternative Arrangements) (Modification of Enactments and Other Provisions) (Wales) Order 2002

Made 21st March 2002

Coming into force 1st April 2002

The National Assembly for Wales makes the following Order in exercise of the powers conferred upon it by sections 47, 105 and 106 of the Local Government Act 2000(a), and of all other powers enabling it in that behalf:

### Name, commencement, application and interpretation

- (3) Where a councillor is appointed by an executive leader as a member of a leader and cabinet executive -
  - (a) subject to sub-paragraph (b), unless the councillor resigns as a member of the executive or ceases to be a councillor, if the end of the term of office of the executive leader is provided for in executive arrangements, the councillor shall hold office until the end of that term;
  - (b) the executive leader may remove that person if the executive leader thinks fit.
- (4) Where, under the executive arrangements of a leader and cabinet executive, the authority determine the number of councillors who may be appointed to the executive under section 11(3)(b) of the Local Government Act  $2000(\mathbf{b})$ , and the executive leader appoints the councillors to the executive, the executive leader shall -

#### Mayor and cabinet executives

- **41**.-(1) The provisions in this article apply in relation to executive arrangements by a local authority which involve a mayor and cabinet executive.
- (2) For the purposes of this article an elected mayor, deputy mayor or member of the executive is to be considered unable to act only if either suspended from office or is unfit to act on health grounds.
  - (3) If for any reasons -
    - (a) the elected mayor is unable to act or the office of elected mayor is vacant;
  - (b) the deputy mayor is unable to act or the office of deputy mayor is vacant; and
  - (c) only one other member of the executive is able to act,

that other member must act in the elected mayor's place.

- (4) Subject to paragraphs (5) and (6), if for any reason -
  - (a) the elected mayor is unable to act or the office of elected mayor is vacant; and
  - (b) no other member of the executive is able to act or, because of vacancies, there are no other members of the executive,

the authority shall, as soon as reasonably practicable, appoint a councillor of the authority ("the interim mayor") ("y maer dros dro") to act in the place of the elected mayor and appoint at least two, but not more than nine, councillors of the authority ("the interim members") ("yr aelodau dros dro") to act in the place of members of the executive appointed by the elected mayor.

- (5) The interim mayor and interim members shall not appoint councillors of the authority to the executive nor remove them from office.
- (6) For the purposes of section 11(8) of the Local Government Act 2000 (local authority executives), the interim mayor and interim members shall be treated as if they are not members of the executive.
- (7) Notwithstanding section 80 of the 1972 Act (disqualifications for election and holding office as a member of a local authority) or section 35 of the Local Government Act 1985 (disqualification), a person shall not be disqualified from being a member of a local authority or, as the case may be, a joint authority solely because that person is an interim mayor or an interim member.
