Mae'r Gorchymyn hwn yn dwyn i rym ar 1 Awst 2003, 1 Medi 2003 ac 1 Tachwedd 2003, y darpariaethau hynny yn Neddf Addysg 2002 a bennir yn Rhannau I i III o'r Atodlen i'r Gorchymyn hwn.

This Order brings into force on 1st August 2003, 1st September 2003 and 1st November 2003, those provisions of the Education Act 2002 specified in Parts I to III of the Schedule to this Order.

Mae'r cyfeiriadau isod at adrannau ac Atodlenni (heb fanylion pellach) yn gyfeiriadau at adrannau o Ddeddf Addysg 2002 ac Atodlenni iddi.

References below to sections and Schedules (without more) are references to sections of and Schedules to the Education Act 2002.

Yn achos darpariaethau sy'n cael eu dwyn i rym gan y Gorchymyn hwn ac sy'n diwygio deddfwriaeth sy'n bodoli eisoes, mae'r cyfeiriadau at yr Ysgrifennydd Gwladol yn y darpariaethau hynny i'w darllen, mewn perthynas â Chymru, fel cyfeiriadau at Gynulliad Cenedlaethol Cymru - gweler adran 211.

In the case of provisions brought into force by this Order which amend existing legislation, references to the Secretary of State in those provisions are to be read, in relation to Wales, as references to the National Assembly for Wales - see section 211.

Dyma fydd effaith y darpariaethau a bennir yn Rhan I o'r Atodlen -

The effect of the provisions specified in Part I of the Schedule is as follows -

Mae adrannau 60 i 64 yn ymwneud â phwerau Cynulliad Cenedlaethol Cymru (y Cynulliad Cenedlaethol) i gyfarwyddo AALl.

Sections 60 to 64 relate to the powers of the National Assembly for Wales (the National Assembly) to direct LEAs.

Mae adran 60 yn diwygio adran 497A o Ddeddf Addysg 1996 (Deddf 1996) fel bod modd i gyfarwyddyd gyfeirio at holl swyddogaethau AALl; fel bod modd gwneud cyfarwyddyd pellach pan ddaw un blaenorol i ben os caiff y Cynulliad Cenedlaethol ei fodloni, pe na bai'n gwneud cyfarwyddyd pellach, na fyddai'r AALl yn cyflawni'r swyddogaeth o dan sylw i safon ddigonol; fel bod modd i'r Cynulliad Cenedlaethol gyfarwyddo AALl i gymryd camau mwy penodol; ac yn y fath fodd ag i alluogi'r Cynulliad Cenedlaethol i gyfarwyddo bod swyddogaeth i'w harfer ganddo neu gan ei enwebai.

Section 60 amends section 497A of the Education Act 1996 (the 1996 Act) so that a direction can relate to all functions of an LEA; so that a further direction can be made when a previous one comes to an end if the National Assembly is satisfied that if it did not make a further direction, the LEA would not perform the function in question to an adequate standard; so that the National Assembly can direct an LEA to take more specific action; and so as to enable the National Assembly to direct that a function is to be exercised by it or by its

Mae adran 61 yn mewnosod adran 497AA newydd o Ddeddf 1996 sy'n ei gwneud yn ofynnol i AALL gydweithredu â'r Cynulliad Cenedlaethol, neu ei enwebai, os yw'r Cynulliad Cenedlaethol yn ystyried gwneud cyfarwyddyd. Mae adran 62 yn gwneud diwygiadau canlyniadol i adran 497B o Ddeddf 1996. Mae adrannau 63 a 64 yn galluogi'r Cynulliad Cenedlaethol o dan amgylchiadau penodol i gyfarwyddo AALL i gael cyngor oddi wrth berson penodedig.

Mae adran 178(1) a (4) yn diwygio Deddf Dysgu a Medrau 2000 i estyn ystod arolygiadau ardal at bersonau sydd dros 14 oed.

Mae adran 215 ac Atodlenni 21 a 22 yn gwneud mân ddiwygiadau canlyniadol a diddymiadau.

Dyma fydd effaith y darpariaethau a bennir yn Rhan II o'r Atodlen -

Mae adran 27 yn galluogi corff llywodraethu ysgol a gynhelir i ddarparu cyfleusterau neu wasanaethau er budd y gymuned. Mae adran 28 yn gosod terfynau ar arfer y pŵer hwn. Mae adran 19(6) ac Atodlen 1, paragraff 3(1), (3) i (8), ac adran 40 ac Atodlen 3, paragraffau 1 i 5 yn gwneud darpariaeth sy'n dilyn fel canlyniad i gyflwyno'r pŵer hwn.

Mae adran 29 yn ailddeddfu, gyda diwygiadau, adran 39 o Ddeddf Safonau a Fframwaith Ysgolion 1998 (Deddf 1998). Roedd adran 39(1) o Ddeddf 1998 yn ei gwneud yn ofynnol i gyrff llywodraethu sefydlu gweithdrefn cwyno yn unol â rheoliadau, ond ni wnaethpwyd rheoliadau o dan yr adran honno. Mae adran 29(1) a (2) nawr yn ei gwneud yn ofynnol i gorff llywodraethu gael gweithdrefn cwyno fel y'i nodir yn yr adran ac yn unol â chyfarwyddyd. Mae adran 29(3) a (4) yn rhoi pŵer i gorff llywodraethu i'w gwneud yn ofynnol i ddisgyblion fynd i unrhyw le y tu allan i'r ysgol at ddibenion y cwricwlwm. Mae adran 29(5) yn ei gwneud yn ofynnol i gorff llywodraethu a phennaeth gydymffurfio â chyfarwyddiadau AALL mewn perthynas â iechyd a diogelwch.

Mae adrannau 136 i 140 yn cynnwys pwerau i wneud rheoliadau ynglŷn â chymwysterau athrawon a phenaethiaid addysg bellach, mewn perthynas â chyrtsiau sy'n arwain at gymwysterau o'r fath ac mewn perthynas â darparu cyrsiau addysg uwch mewn sefydliadau addysg bellach.

Mae adrannau 181 i 185 yn galluogi'r Cynulliad Cenedlaethol i wneud rheoliadau sy'n darparu ar gyfer talu lwfansau i bersonau cymwys dros oedran ysgol gorfodol sy'n cymryd rhan mewn addysg neu hyfforddiant nad yw'n addysg uwch.

Mae adran 197 yn galluogi'r Cynulliad Cenedlaethol i wneud rheoliadau sy'n ei gwneud yn ofynnol i AALL a chyrrff llywodraethu wneud cytundebau partneriaeth, sy'n nodi sut y byddant yn cyflawni eu swyddogaethau mewn perthynas ag ysgol.

Section 61 inserts a new section 497AA of the 1996 Act which requires an LEA to co-operate with the National Assembly, or its nominee, if the National Assembly is contemplating making a direction. Section 62 makes consequential amendments to section 497B of the 1996 Act. Sections 63 and 64 enable the National Assembly in certain circumstances to direct an LEA to obtain advice from a specified person.

Section 178(1) and (4) amend the Learning and Skills Act 2000 to extend area inspections to persons who are aged over 14.

Section 215 and Schedules 21 and 22 make minor and consequential amendments and repeals.

The effect of the provisions specified in Part II of the Schedule is as follows -

Section 27 enables the governing body of a maintained school to provide facilities or services for the benefit of the community. Section 28 sets limits on the exercise of this power. Section 19(6) and Schedule 1, paragraph 3(1), (3) to (8), and section 40 and Schedule 3, paragraphs 1 to 5 make provision consequential on the introduction of this power.

Section 29 re-enacts, with amendments, section 39 of the School Standards and Framework Act 1998 (the 1998 Act). Section 39(1) of the 1998 Act required governing bodies to establish a complaints procedure in accordance with regulations, but no regulations were made under that section. Section 29 (1) and (2) now requires a governing body to have a complaints procedure as set out in the section and in accordance with guidance. Section 29 (3) and (4) gives a governing body the power to require pupils to attend any place outside the school for curriculum purposes. Section 29(5) requires a governing body and a head teacher to comply with an LEA's directions in relation to health and safety.

Sections 136 to 140 contain regulation making powers in relation to the qualifications of further education teachers and principals, in relation to courses leading to such qualifications and in relation to the provision of courses of higher education at further education institutions.

Sections 181 to 185 enable the National Assembly to make regulations providing for allowances to be paid to eligible persons over compulsory school age taking part in education or training which is not higher education.

Section 197 enables the National Assembly to make regulations requiring LEAs and governing bodies to enter into partnership agreements, setting out how they will carry out their functions in relation to a school.

Mae adran 199 ac Atodlen 19 yn diwygio darpariaethau Deddf 1996 ynglŷn â chludiant. Maent yn ei gwneud yn ofynnol i AALL baratoi datganiad polisi sy'n nodi eu trefniadau ar gyfer darparu cludiant ar gyfer dysgwyr ôl-16 neu gefnogaeth ar gyfer cludiant o'r fath.

Mae adran 202 yn cynnwys pwerau i wneud rheoliadau ynglŷn â chofnodion addysgol sefydliadau addysg bellach.

Mae adran 203 yn cynnwys pwerau i wneud rheoliadau ynglŷn â defnyddio offer a deunyddiau peryglus mewn sefydliadau addysg bellach.

Mae adran 206 ac Atodlen 20 yn diwygio Deddf 1996 a Deddf Addysg Bellach ac Uwch 1992 i estyn y darpariaethau ynglŷn â niwsans neu aflonyddwch ar safleoedd addysgol i ysgolion arbennig na chynhelir mohonynt, ysgolion annibynnol, safleoedd sy'n cael eu darparu gan AALL ar gyfer hyfforddiant mewn gweithgareddau sy'n ymwneud â chwaraeon, gweithgareddau adloniadol neu weithgareddau awyr agored ac i sefydliadau o fewn y sector addysg bellach.

Mae adran 215 ac Atodlenni 21 a 22 yn gwneud mân ddiwygiadau canlyniadol a diddymiadau.

Dyma fydd effaith y darpariaethau a bennir yn Rhan III o'r Atodlen -

Mae adran 43 yn mewnosod adran 47A newydd o Ddeddf 1998, sy'n ei gwneud yn ofynnol i AALL sefydlu fforymau ysgol. Bydd y rhain yn cynrychioli cyrff llywodraethu a phenaethiaid ac yn cynghori'r AALL ar faterion sy'n ymwneud â'i gyllideb ysgolion.

Section 199 and Schedule 19 amend provisions of the 1996 Act relating to transport. They require LEAs to prepare a policy statement setting out their arrangements for the provision of, or support for, transport for post 16 learners.

Section 202 contains regulation making powers in relation to educational records of further education institutions.

Section 203 contains regulation making powers in relation to the use of hazardous equipment and materials in further education institutions.

Section 206 and Schedule 20 amend the 1996 Act and the Further and Higher Education Act 1992, to extend the provisions relating to nuisance or disturbance on educational premises to non-maintained special schools, independent schools, premises provided by an LEA for instruction in sporting, recreational or outdoor activities and to institutions within the further education sector.

Section 215 and Schedules 21 and 22 make minor and consequential amendments and repeals.

The effect of the provisions specified in Part III of the Schedule is as follows -

Section 43 inserts a new section 47A of the 1998 Act, requiring LEAs to establish school forums. These will represent governing bodies and head teachers and will advise the LEA on matters relating to its schools budget.

1. Enw'r Gorchymyn hwn yw Gorchymyn Deddf Addysg 2002 (Cychwyn Rhif 2) (Cymru) 2003.

2. Mae'r darpariaethau sy'n cael eu dwyn i rym gan y Gorchymyn hwn yn cael eu dwyn i rym mewn perthynas â Chymru yn unig (ac eithrio mewn perthynas ag adrannau 139 a 197).

3. Yn y Gorchymyn hwn, oni nodir fel arall, mae cyfeiriadau at Rannau, adrannau ac Atodlenni yn gyfeiriadau at Rannau ac adrannau o Ddeddf Addysg 2002 a'r Atodlenni iddi.

Name, application and interpretation

1. This Order is called the Education Act 2002 (Commencement No. 2) (Wales) Order 2003.

2. Provisions brought into force by this Order are brought into force only in relation to Wales (except in relation to sections 139 and 197).

3. In this Order, unless otherwise stated, references to Parts, sections and Schedules are references to Parts and sections of and Schedules to the Education Act 2002.

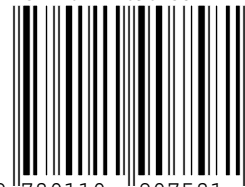
