Mae'r Rheoliadau hyn yn diwygio Rheoliadau Addysg (Lleoedd a Gynorthwyir) (Mân Dreuliau) 1997 ("Rheoliadau 1997") mewn perthynas â blwyddyn ysgol yn dechrau ar 1 Medi 2003 neu wedyn. Mae Rheoliadau 1997 yn darparu ar gyfer talu grantiau o ran mân dreuliau, ac ar gyfer peidio â chasglu mân dreuliau, mewn perthynas â disgyblion sy'n gymwys i barhau i gael lleoedd a gynorthwyir mewn ysgolion annibynnol yn rhinwedd adran 2 o Ddeddf Addysg (Ysgolion) 1997, er bod y cynllun cymorth lleoedd wedi'i ddileu gan adran 1 o'r Ddeddf honno.

Mae'r Rheoliadau hyn yn llacio'r prawf moddion ariannol (a nodir yn rheoliad 2 o Reoliadau 1997) ac yn cynyddu swm y grant sy'n daladwy ar gyfer grant gwisg ysgol o ran gwariant ar ddillad a dynnwyd mewn perthynas â'r flwyddyn ysgol 2003/2004 a'r blynnyddoedd ysgol dilynol.

Mae'r Rheoliadau hyn hefyd yn llacio'r prawf moddion ariannol (a nodir yn rheoliad 4 o Reoliadau 1997) ar gyfer grantiau teithio ac yn cynyddu swm y grant a delir.

Mae'r Rheoliadau hyn hefyd yn ychwanegu Credyd Treth i Blant i'r rhestr o fudd-dâl neu lwfans yn Rheoliadau 1997 y mae eu derbyn yn galluogi i'r ffioedd am brydiau ysgol beidio â chael eu talu.

The Education (Assisted Places) (Incidental Expenses) (Amendment) (Wales) Regulations 2003

EXPLANATORY NOTE

(This note is not part of the Regulations)

These Regulations amend the Education (Assisted Places) (Incidental Expenses) Regulations 1997 ("the 1997 Regulations") in respect of a school year beginning on or after 1st September 2003. The 1997 Regulations provide for the payment of grants as regards incidental expenses, and for the remission of incidental expenses, in respect of pupils eligible to continue to hold assisted places at independent schools by virtue of section 2 of the Education (Schools) Act 1997, notwithstanding the abolition of the assisted places scheme by section 1 of that Act.

These Regulations relax the means test (set out in regulation 2 of the 1997 Regulations) and increase the amount of grant payable for uniform grant in respect of clothing expenditure incurred in relation to the 2003/2004 and subsequent school years.

These Regulations also relax the means test (set out in regulation 4 of the 1997 Regulations) for travel grant and increase the amount of grant payable.

These Regulations also add Child Tax Credits to the list of benefits or allowances in the 1997 Regulations the receipt of which enable charges for school meals to be remitted.

The Education (Assisted Places) (Incidental Expenses) (Amendment) (Wales) Regulations 2003

Made

15th July 2003

Coming into force

1st September 2003

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred on the Secretary of State by section 3(3), (4), (5) and (9) of the Education (Schools) Act 1997(a) and now vested in the National Assembly for Wales(b).

Citation, commencement and application

1.-(1) These Regulations are called the Education (Assisted Places) (Incidental Expenses) (Amendment) (Wales) Regulations 2003 and shall come into force on 1st September 2003.

(2) These Regulations apply to Wales only.

(3) These Regulations apply in relation to any school year beginning on or after 1st September 2003.

Amendment of the Education (Assisted Places) (Incidental Expenses) Regulations 1997

2.-(1) The Education (Assisted Places) (Incidental Expenses) Regulations 1997(c) are amended as follows.

(2) In regulation 2(2), for "£12,227" there is substituted "£12,508".

- (5) In regulation 9(3), after sub-paragraph (b) insert "or"
 (c) Child Tax Credit prescribed for the purposes of section 512ZB(4)(a)(iv) of the Education Act 1996(a).".


