The National Assembly for Wales, in exercise of the powers conferred by sections 16(1)(a), (e) and (f), 18(1)(c), 26(1) and (3) and 48(1) of the Food Safety Act 1990(a) and now vested in it(b), and having had regard in accordance with section 48(4A) of that Act to relevant advice given by the Food Standards Agency, hereby makes the following Regulations:

- (b) shall come into force on 30th October 2003;
- (c) shall apply to Wales only.
