Gall fod gan berson sy'n arfer yr hawl i brynu tŷ annedd yng Nghymru yr hawl o dan Ran V o Ddeddf Tai 1985 ("y Ddeddf"), o dan adrannau 129 i 131 o Atodlen 4 i'r Ddeddf, i ddisgownt sy'n gymesur â chanran o'r pris cyn disgownt.

A person exercising the right to buy a dwelling-house in Wales under Part V of the Housing Act 1985 ("the Act") may be entitled, under sections 129 to 131 of and Schedule 4 to the Act, to a discount equal to a percentage of the price before discount.

Mae adran 131 o'r Ddeddf yn darparu terfynau ar swm y disgownt y mae gan brynwr arfaethedig hawl iddo ac mae adran 131(2) yn galluogi'r Ysgrifennydd Gwladol i wneud Gorchymyn yn rhagnodi'r mwyafswm y gellir gostwng y pris sy'n daladwy am y tŷ annedd o dan y cynllun hawl i brynu. Breinir y pwerau a roddwyd i'r Ysgrifennydd Gwladol bellach yng Nghynulliad Cenedlaethol Cymru i'r graddau y maent yn arferadwy yng Nghymru.

Section 131 of the Act provides limits upon the amount of discount to which the proposed purchaser is entitled and section 131(2) empowers the Secretary of State to make an Order prescribing the maximum sum by which the price payable for a dwelling house under the right to buy scheme may be reduced by discount. The powers given to the Secretary of State by section 131 of the Act are now vested in the National Assembly for Wales so far as exercisable in Wales.

O dan adran 131(2), gwnaeth yr Ysgrifennydd Gwladol Orchymyn Tai (Hawl i Brynu) (Terfynau ar y Disgownt) (Cymru) 1999 ("y prif Orchymyn") a ragnododd, ymysg pethau eraill, mai mwyafswm y disgownt hwn oedd £24,000. Mae'r Gorchymyn hwn yn diwygio'r prif Orchymyn drwy ddarparu mai mwyafswm y disgownt sydd ar gael yw £16,000.

Under section 131(2), the Secretary of State made the Housing (Right to Buy) (Limits on Discount) (Wales) Order 1999 ("the Principal Order") which prescribed, amongst other matters, that this maximum discount was £24,000. This Order amends the Principal Order by providing that the maximum discount available is £16,000.

The National Assembly for Wales makes the following Order in exercise of the power given to the Secretary of State by section 131(2) of the Housing Act 1985(a) which is now vested in the National Assembly for Wales so far as exercisable in Wales(b):

1.-(1) Enw'r Gorchymyn hwn yw Gorchymyn Tai (Hawl i Brynu) (Terfynau'r Disgownt) (Diwygio) (Cymru) 2003 a daw i rym ar 2 Ebrill 2003.

1.-(1) The name of this Order is the Housing (Right to Buy) (Limits of Discount) (Amendment) (Wales) Order 2003 and it comes into force on 2nd April 2003.

(2) Mae'r Gorchymyn hwn yn gymwys i Gymru yn unig.

(2) This Order applies to Wales only.
