EXPLANATORY NOTE

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Addysg (Lleoedd a Gynorthwyir) 1997 ("Rheoliadau 1997") ymhellach.

These Regulations further amend the Education (Assisted Places) Regulations 1997 ("the 1997 Regulations").

Mae'r Rheoliadau hyn yn gymwys ynghylch cwestiynau o beidio â chasglu sy'n codi ym mlwyddyn ysgol 2006/07 ac nas penderfynwyd ar y dyddiad y daw'r Rheoliadau hyn i rym arno. Cwestiwn o beidio â chasglu yw cwestiwn sy'n ymwneud â hawl rhiant o dan Reoliadau 1997 fel nas cesglir oddi wrtho ffioedd sy'n daladwy am addysg plentyn mewn ysgol annibynnol.

The Regulations apply in relation to remission questions that arise in respect of the 2006/07 school year and which have not been determined at the date on which these Regulations come into force. A remission question is a question as to a parent's entitlement under the 1997 Regulations to a remission in the fees payable in respect of a child's education at an independent school.

Mae'r swm sydd i'w dynnu o'r incwm perthnasol o ran perthnasau dibynnol o dan reoliad 10(4) a (6) o Reoliadau 1997 yn cael ei gynyddu o £1,575 i £1,625.

The reductions to be made in relevant parental income in respect of dependent relatives pursuant to regulation 10(4) and (6) of the 1997 Regulations are increased from £1,575 to £1,625.

Mae'r Rheoliadau hyn hefyd yn diwygio'r prawf modd ar gyfer ad-dalu ffioedd: gosodir lefel yr incwm na chesglir y ffioedd, naill ai yn gyfangwbl neu'n rhannol, arno neu islaw iddo ar £12,470 yn lle £12,182, gyda chynnydd cyfatebol yng ngraddau'r ad-daliadau pan fo'r incwm perthnasol uwchlaw'r swm hwnnw.

These Regulations also amend the means test for the remission of fees: the level of income at or below which fees are to be wholly remitted is set at £12,470 instead of £12,182, with corresponding increases in the extent of remission where relevant income exceeds that sum.

Mae Cynulliad Cenedlaethol Cymru, ar ôl iddo ymgynghori, yn unol ag adran 3(7) o Ddeddf Addysg (Ysgolion) 1997(1), â'r cyrff hynny y mae'n ymddangos iddo eu bod yn briodol ac â chynrychiolyddion ysgolion sy'n darparu lleoedd a gynorthwyir o dan adran 2(1) o'r Ddeddf honno, yn gwneud y Rheoliadau a ganlyn o dan y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adran 3(1), (2), (5) a (9) o'r Ddeddf honno(2):

The National Assembly for Wales, having consulted, in accordance with section 3(7) of the Education (Schools) Act 1997(1), such bodies as appear to it to be appropriate and representative of schools which provide assisted places under section 2(1) of that Act, makes the following Regulations in exercise of the powers conferred upon the Secretary of State by section 3(1), (2), (5) and (9) of that Act(2):

Enwi, cychwyn a chymhwyso**Title, commencement and application**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Addysg (Lleoedd a Gynorthwyir) (Diwygio) (Cymru) 2006 a deuant i rym ar 23 Tachwedd 2006.

1.-(1) The title of these Regulations is the Education (Assisted Places) (Amendment) (Wales) Regulations 2006 and they come into force on 23 November 2006.

(2) Mae Rheoliad 3 yn gymwys o ran Cymru ynghylch cwestiwn o beidio â chasglu perthnasol.

(2) Regulation 3 applies in relation to Wales in respect of a relevant remission question.

(3) Ym mharagraff 2 uchod, ystyr "cwestiwn o beidio â chasglu perthnasol" yw cwestiwn o beidio â chasglu o dan Rheoliadau Addysg (Lleoedd a Gynorthwyir) 1997 ac-

(3) In paragraph (2) above, "relevant remission question" means a remission question under the Education (Assisted Places) Regulations 1997 and which-

- (a) sy'n codi ynglŷn â blwyddyn ysgol sy'n dechrau ar neu ar ôl 1 Medi 2006; a
- (b) nas penderfynwyd ar y dyddiad y daw'r Rheoliadau hyn i rym.

- (a) arises in respect of a school year beginning on or after 1 September 2006; and
- (b) has not been determined at the date on which these Regulations come into force.

Diwygio Rheoliadau Addysg (Lleoedd a Gynorthwyr) 1997

3.-(1) Diwygir Rheoliadau Addysg (Lleoedd a Gynorthwyr) 1997(2) fel a ganlyn.

(2) Yn rheoliad 10(4) a (6), yn lle "£1,575" ym mhob man y'i gwelir rhodder "£1,625".

(3) Ym mharagraff 1 o Atodlen 2, rhodder "£12,470" yn lle "£12,182".

(4) Yn lle'r tabl sy'n dilyn paragraff 2(1) o'r Atodlen honno, rhodder y tabl canlynol-

Amendment of the Education (Assisted Places) (Amendment) (Wales) Regulations 2005

2. At the end of paragraph (3) of regulation 1 of the Education (Assisted Places) (Amendment) (Wales) Regulations 2005(1), there is inserted "provided that the question is not one referred to paragraph (3) of regulation 1 of the Education (Assisted Places) (Amendment) (Wales) Regulations 2006".

Amendment of the Education (Assisted Places) Regulations 1997

3.-(1) The Education (Assisted Places) Regulations 1997(2) are amended as follows.

(2) In regulation 10(4) and (6), substitute "£1,625" for "£1,575" in each place where it appears.

(3) In paragraph 1 of Schedule 2, substitute "£12,470" for "£12,182".

(4) For the table following paragraph 2(1) of that Schedule substitute the following table-
