Mae'r Rheoliadau hyn, sy'n gymwys i Gymru, yn diwygio'r Rheoliadau Ardrethu Annomestig (Cymru) 1992 ("Rheoliadau 1992").

These Regulations, which apply in relation to Wales, amend the Non-Domestic Rating Contributions (Wales) Regulations 1992 ("the 1992 Regulations").

O dan Ran II o Atodlen 8 i Ddeddf Cyllid Llywodraeth Leol ("Deddf 1988") mae'n ofynnol i awdurdodau bilio (yng Nghymru, cynghorau sir a chynghorau bwrdeistref sirol) dalu symiau (a elwir yn gyfraniadau ardrethu annomestig) i Gynulliad Cenedlaethol Cymru. Mae Rheoliadau 1992 yn cynnwys rheolau ar gyfer cyfrifo'r cyfraniadau hynny ar gyfer awdurdodau bilio Cymru.

Under Part II of Schedule 8 to the Local Government Finance Act 1988 ("the 1988 Act") billing authorities (in Wales, county and county borough councils) are required to pay amounts (called non-domestic rating contributions) to the National Assembly for Wales. The 1992 Regulations contain rules for the calculation of those contributions for Welsh billing authorities.

Mae'r Rheoliadau hyn yn diwygio Rheoliadau 1992-

These Regulations amend the 1992 Regulations by-

- trwy newid geiriad paragraff 3(1) o Atodlen 1 (Rheolau ar gyfer Cyfrifo Cyfraniadau Ardrethu Annomestig) bod y didyniad o 90% y cyfeirir ato yn y paragraff hwnnw yn cyfeirio yn unig at ryddhad ardrethu disgresiynol a roddir gan awdurdodau bilio mewn perthynas â hereditamentau y mae adran 47(2)(b), (ba) neu (c) yn gymwys iddynt. O ganlyniad ni fydd yna ddidyniad mewn perthynas â rhyddhad disgresiynol ardrethi a roddir gan yr awdurdod bilio i drethdalwyr sy'n meddiannu hereditamentau y mae adran 43(4B) o Ddeddf 1988 yn gymwys iddynt (hereditamentau sy'n cael rhyddhad gorfodol ardrethi busnesau bychain);

- changing the wording of paragraph 3(1) of Schedule 1 (Rules for the Calculation of Non-Domestic Rating Contributions) such that the 90% deduction referred to in that paragraph only relates to discretionary rate relief granted by billing authorities in respect of hereditaments to which section 47(2)(b), (ba) or (c) apply. Consequently there will be no deduction in respect of discretionary rate relief granted by the billing authority to ratepayers who occupy hereditaments to which section 43(4B) of the 1988 Act applies (hereditaments which receive mandatory small business rate relief);

- trwy roi lluosydd newydd ym mharagraff 2(12) o Atodlen 2 yn lle'r un presennol (Rhagdybiaethau parthed swm gros); a

- substituting a new multiplier in paragraph 2(12) of Schedule 2 (Assumptions as to gross amount); and

- trwy roi Atodlen 4 newydd yn lle'r un bresennol (Ffigyrau Poblogaeth Oedolion).

- substituting a new Schedule 4 (Adult Population Figures).

Mae Cynulliad Cenedlaethol Cymru yn gwneud y Rheoliadau a ganlyn drwy arfer y pwerau a roddwyd i'r Ysgrifennydd Gwladol gan adrannau 60, 140(4) a 143(1) a (2) o Ddeddf Cyllid Llywodraeth Leol 1988 (1) a pharagraffau 4 a 6 o Atodlen 8 iddi ac a freiniwyd bellach yng Nghynulliad Cenedlaethol Cymru:

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred on the Secretary of State by sections 60, 140(4) and 143(1) and (2) of, and paragraphs 4 and 6 of Schedule 8 to, the Local Government Finance Act 1988(1) and now vested in the National Assembly for Wales:

**Enwi, cymhwyso a chychwyn**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Cyfraniadau Ardrethu Annemestig (Cymru) (Diwygio) 2006 a deuant i rym ar 31 Rhagfyr 2006.

(2) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

**Title, application and commencement**

1.-(1) The title of these Regulations is the Non-Domestic Rating Contributions (Wales) (Amendment) Regulations 2006 and they come into force on 31 December 2006.

(2) These Regulations apply in relation to Wales.

**Diwygio Rheoliadau Cyfraniadau Ardrethu  
Annemestig (Cymru) 1992**

2.-(1) Diwygir Rheoliadau Cyfraniadau Ardrethu Annemestig (Cymru) 1992(2) fel a ganlyn parthed blynyddoedd ariannol sy'n dechrau ar neu ar ôl 1 Ebrill 2007.

(2) Ym mharagraff 3(1)(b) o atodlen 1, yn lle'r geiriau "other than" hyd at ddiwedd y paragraff hwnnw, rhodder "in relation to which section 47(2)(b), (ba) or (c) applies were taken into account".

(3) Ym mharagraff 2(12) o atodlen 2, yn lle "1.004" rhodder "1.001".

**Amendment to the Non-Domestic Rating  
Contributions (Wales) Regulations 1992**

2.-(1) The Non-Domestic Rating Contributions (Wales) Regulations 1992(2) are amended as follows in relation to financial years beginning on or after 1 April 2007.

(2) In paragraph 3(1)(b) of schedule 1, for the words "other than" to the end of that paragraph, substitute "in relation to which section 47(2)(b), (ba) or (c) applies were taken into account".

(3) In paragraph 2(12) of schedule 2, for "1.004" there is substituted "1.001".
