Mae'r Rheoliadau hyn yn rhagnodi'r ffioedd sydd i'w talu gan bobl sy'n gwneud cais am gael tatws hadyd (tatws plannu) wedi'u dosbarthu o dan Rheoliadau Tatws Hadyd 1991. Maent yn dirymu ac yn disodli Rheoliadau Tatws Hadyd (Ffioedd) 1998 mewn perthynas â Chymru.

Mae'r Rheoliadau yn cyflwyno dau ddosbarth newydd o ffi, sef ffi ar gyfer arolygu tatws hadyd cyn-sylfaenol, a ffi ar gyfer arolygu tatws o dan gynllun neu drefniant y darperir ar ei gyfer gan baragraff 4(c)(ii) o Ran II o Atodlen 1 i Rheoliadau 1991.

Mae pob ffi arall a ragnodir gan y Rheoliadau yn aros heb ei newid ers Rheoliadau 1998. Cost cyflawni'r gwasanaethau y codir taliadau amdanynt yw pob ffi. Mae Arfarniad Rheoliadol wedi ei baratoi ar gyfer y Rheoliadau hyn a gellir cael copi oddi wrth yr Adran Amgylchedd Cynllunio a Chefn Gwlad, Cynulliad Cenedlaethol Cymru, Parc Cathays, Caerdydd, CF10 3NQ.

## SEEDS, WALES

**The Seed Potatoes (Fees) (Wales)  
Regulations 2006**

### EXPLANATORY NOTE

*(This note is not part of the Regulations)*

These Regulations, which revoke and replace the Seed Potatoes (Fees) Regulations 1998 in relation to Wales, prescribe the fees payable by applicants for classification of seed potatoes under the Seed Potatoes Regulations 1991.

The Regulations introduce two new categories of fee. These are for the inspection of pre-basic seed potatoes and for the inspection of seed potatoes under a scheme or arrangement as provided for by paragraph 4(c)(ii) of Part II of Schedule 1 to the 1991 Regulations.

All of the other fees prescribed by the Regulations remain unchanged from the 1998 Regulations. All fees represent the cost of performing the services for which charges are made. A Regulatory Appraisal in relation to these Regulations has been prepared and a copy is available from the Department for Environment, Planning and Countryside, Welsh Assembly Government, Cathays Park, Cardiff, CF10 3NQ.

Mae Cynulliad Cenedlaethol Cymru, drwy arfer y pwerau a roddwyd gan adran 16(1) ac (1A)(e) o Ddeddf Amrywogaethau a Hadau Planhigion 1964(1) ac sydd bellach wedi'u breinio ynddo(2), ar ôl ymgynghori â chynrychiolwyr y buddiannau hynny y mae'n ymddangos iddo yr effeithir arnynt, drwy hyn yn gwneud y Rheoliadau a ganlyn:

The National Assembly for Wales, in exercise of the powers conferred by section 16(1) and (1A)(e) of the Plant Varieties and Seeds Act 1964(1) and now vested in it(2), after consultation with representatives of such interests as appear to it to be concerned, hereby makes the following Regulations:

**Enw, cychwyn a chymhwyso**

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Tatws Hadyd (Ffioedd) (Cymru) 2006 a deuant i rym ar 3 Mawrth 2006.

(2) Mae'r Rheoliadau hyn yn gymwys i Gymru.

**Title, commencement and application**

1.-(1) The title of these Regulations is the Seed Potatoes (Fees) (Wales) Regulations 2006 and these Regulations come into force on 3 March 2006.

(2) These Regulations apply in relation to Wales.

**Ffioedd**

2.-(1) Rhaid i berson sy'n gwneud cais am gael tatws hadyd wedi'u dosbarthu dalu i Gynulliad Cenedlaethol Cymru o ran ei swyddogaethau o dan Reoliadau Tatws Hadyd 1991(3) ac a restrir yn yr Atodlen, neu i unrhyw berson a awdurdodir ganddo i gyflawni'r swyddogaethau hynny ar ei ran, y ffioedd a restrir yn yr Atodlen o ran y swyddogaethau hynny.

**Fees**

2.-(1) An applicant for classification of seed potatoes must pay to the National Assembly for Wales in respect of its functions under the Seed Potatoes Regulations 1991(3) listed in the Schedule, or to any person authorised by it to carry out such functions on its behalf, the fees listed in the Schedule in respect of such functions.

(2) O dan Orchymyn Trosglwyddo Swyddogaethau (Cymru) (Rhif 1) 1978 (OS 1978/272), erthygl 2(1) ac Atodlen 1, trosglwyddwyd swyddogaethau'r Gweinidog Amaethyddiaeth, Pysgodfeydd a Bwyd o dan y Ddeddf Amrywogaethau a Hadau Planhigion 1964, i'r graddau yr oeddent yn arferadwy mewn perthynas â Chymru, i'r Ysgrifennydd Gwladol ac o dan Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (OS 1999/672), erthygl 2(1) ac Atodlen 1, trosglwyddwyd y swyddogaethau a drosglwyddwyd i'r Ysgrifennydd Gwladol gan Orchymyn 1978 i Gynulliad Cenedlaethol Cymru.

(3) OS 1991/2206, a ddiwygiwyd gan OS 1992/1031, 1993/1878, 1994/2592, 1997/1474, 2001/3666. Mae swyddogaethau wedi eu breinio yng Nghynulliad Cenedlaethol Cymru yn rhinwedd Erthygl 3 o Orchymyn Cynulliad Cenedlaethol Cymru (Trosglwyddo Swyddogaethau) 1999 (O.S. 1999/672).

(2) Under the Transfer of Functions (Wales) (No.1) Order 1978 (SI 1978/272), article 2(1) and Schedule 1, the functions of the Minister of Agriculture, Fisheries and Food under the Plant Varieties and Seeds Act 1964 were, so far as they were exercisable in relation to Wales, transferred to the Secretary of State and under the National Assembly for Wales (Transfer of Functions) Order 1999 (SI 1999/672), article 2(1) and Schedule 1, the functions transferred to the Secretary of State by the 1978 Order were transferred to the National Assembly for Wales.

(3) SI 1991/2206, amended by SI 1992/1031, 1993/1878, 1994/2592, 1997/1474, SI 2001/3666. Functions are vested in the National Assembly for Wales by virtue of Article 3 of the National Assembly for Wales (Transfer of Functions) Order 1999 (SI 1999/672)

(2) Mae'r ffi a bennir yn yr Atodlen fel y ffi sy'n daladwy am bob swyddogaeth yn ddarostyngedig i unrhyw leiafswm ffi a bennir yno.

#### **Tynnu cais yn ôl**

3. Os yw person sy'n gwneud cais am gael tatws hadyd wedi'u dosbarthu yn tynnu ei gais neu ei chais yn ôl cyn i'r arolygydd gyrraedd er mwyn arolygu'r cnwd am y tro cyntaf, rhaid i'r person hwnnw neu honno dalu ffi o £15 i Gynulliad Cenedlaethol Cymru neu i unrhyw berson a awdurdodir ganddo i wneud arolygiad o'r fath ar ei ran.

#### **Dirymu rheoliadau blaenorol**

4. Mae Rheoliadau Tatws Hadyd (Ffioedd) 1998(1) yn cael eu dirymu mewn perthynas â Chymru.

Llofnodwyd ar ran y Cynulliad Cenedlaethol o dan adran 66(1) o Ddeddf Llywodraeth Cymru 1998(2)

28 Chwefror 2006

(2) The fee specified in the Schedule as payable for each function is subject to any minimum fee there specified.

#### **Withdrawal of application**

3. Where an application for the classification of seed potatoes is withdrawn by the applicant before the arrival of an inspector for the purpose of inspecting the crop for the first time, the applicant must pay to the National Assembly for Wales or to any person authorised by it to carry out such inspection on its behalf a fee of £15.

#### **Revocation of previous regulations**

4. The Seed Potatoes (Fees) Regulations 1998(1) are revoked in respect of Wales.
