Mae adran 19 o Ddeddf Addysg 1996 ("y Ddeddf") yn ei gwneud yn ofynnol i awdurdodau addysg lleol wneud trefniadau i ddarparu addysg addas yn yr ysgol neu heblaw mewn ysgol ar gyfer y plant hynny o oedran ysgol gorfodol nad ydynt, oherwydd salwch, gwaharddiad o'r ysgol neu fel arall, yn derbyn am unrhyw gyfnod, addysg addas oni wneir trefniadau o'r fath ar eu cyfer. Adnabyddir unrhyw ysgol a sefydlwyd ac a gynhelir gan awdurdod addysg lleol sydd wedi'i threfnu'n arbennig i ddarparu addysg ar gyfer plant o'r fath, yn uned cyfeirio disgyblion.

Mae Atodlen 1 i'r Ddeddf yn darparu ar gyfer rheoliadau sy'n cymhwysod ddedfiadau i unedau cyfeirio disgyblion.

Mae'r Rheoliadau hyn yn cymhwysod gwahanol ddeddfiadau addysg i unedau cyfeirio disgyblion yng Nghymru. Maent yn cymryd i ystyriaeth ddeddfwriaeth addysg a basiwyd, ers i rheoliadau gael ei gwneud ddiwethaf i gymhwysod ddedfiadau i unedau cyfeirio disgyblion yng Nghymru. Mae'r rheoliadau cynt hynny'n cael eu dirymu gan reoliad 2 o'r Rheoliadau hyn.

The Education (Pupil Referral Units) (Application of Enactments) (Wales) Regulations 2007

### **EXPLANATORY NOTE**

*(This note is not part of the Regulations)*

Section 19 of the Education Act 1996 ("the Act") requires local education authorities to make arrangements for the provision of suitable education at school or otherwise than at school for those children of compulsory school age who, by reason of illness, exclusion from school or otherwise, may not for any period receive suitable education unless such arrangements are made for them. Any school established and maintained by a local education authority which is specially organised to provide education for such children is known as a pupil referral unit.

Schedule 1 to the Act provides for regulations to apply enactments to pupil referral units.

These Regulations apply various education enactments to pupil referral units in Wales. They take account of education legislation enacted since regulations were last made applying enactments to pupil referral units in Wales. Those earlier regulations are revoked by regulation 2 of these Regulations.

In the exercise of its powers under section 569(4) and (5) of, and paragraph 3 of Schedule 1 to, the Education Act 1996(1), the National Assembly for Wales hereby makes the following Regulations:

**Title, commencement, application and interpretation**

1.-(1) The title of these Regulations is the Education (Pupil Referral Units) (Application of Enactments) (Wales) Regulations 2007 and they come into force on 23 April 2007.

(2) These Regulations apply in relation to units in Wales.

(3) In these Regulations "units" means pupil referral units.

**Revocation**

2. The Education (Pupil Referral Units) (Application of Enactments) Regulations 1994(2) and the Education (Pupil Referral Units) (Application of Enactments) (Amendment) Regulations 1996(3) are revoked.

**Deddf Addysg 1996**

2. Mae adran 405 o'r Ddeddf honno yn gymwys o ran unedau fel y mae'n gymwys o ran ysgolion a gynhelir gyda'r addasiad fod y geiriau ", except so far as such education is comprised in the National Curriculum," yn cael eu hepgor.

2. Section 405 of that Act applies in relation to units as it applies in relation to maintained schools with the modification that the words ", except so far as such education is comprised in the National Curriculum," are omitted.
3. Section 559 of that Act(2) applies in relation to a child who is a registered pupil at a unit as it applies in relation to a child who is a registered pupil at a community, foundation, voluntary or special school.

**School Standards and Framework Act 1998**

4.-(1) Section 19 of the School Standards and Framework Act 1998(3) applies in relation to units as it applies in relation to maintained schools in Wales with the following modifications.

(2) Subsection (1) applies if at any time the circumstances set out in section 15(6) of that Act apply in relation to a unit.

(3) In subsection (2) the reference to the governing body in paragraph (a) is omitted, and paragraphs (b) and (c) are omitted.

**8.** Mae adran 30(4) o'r Ddeddf honno'n gymwys o ran unedau fel y mae'n gymwys o ran ysgolion a gynhelir (o fewn ystyr Pennod 1 o Ran 3 o'r Ddeddf honno) gyda'r addasiad fod y geiriau "the governing body or (as the case may be)" a "the governing body or" yn cael eu hepgor.

**9.** Mae adran 32 o'r Ddeddf honno yn gymwys o ran unedau fel y mae'n gymwys o ran ysgolion a grybwyllir yn adran 32(1) gyda'r addasiad yn adran 32(1)(b), yn achos uned sydd â phwylgor rheoli, mai'r awdurdod addysg lleol ynghyd â'r pwylgor rheoli fydd yn penderfynu amserau'r sesiynau ysgol.

**10.** Mae adran 101(1)(d) o'r Ddeddf honno yn gymwys o ran unedau fel y mae'n gymwys o ran ysgolion arbennig.

## Deddf Addysg 2005

**11.-(1)** Mae Rhan 1 o Deddf Addysg 2005(2) yn gymwys o ran unedau fel pe baent yn ysgolion a gynhelir y mae adran 28 o'r Ddeddf honno yn gymwys iddi gyda'r addasiadau canlynol.

(4) In subsection (3) the reference to the governing body is omitted.

**5.** Section 61 of that Act applies in relation to units as it applies in relation to maintained schools in Wales (within the meaning of Part II of that Act) with the modification that for references to the governing body there are substituted references to the management committee of the unit or, in the case of a unit not having a management committee, the local education authority.

**6.** Subsections (1), (2) and (4) of section 62 of that Act apply in relation to units as they apply in relation to maintained schools (within the meaning of Part II of that Act) with the modifications that-

- (a) the reference in subsection (2)(b) to the governing body is a reference to the teacher in charge of the unit, and
- (b) the reference in subsection (4) to the governing body is omitted.

## Education Act 2002

**7.** Section 29(3) of the Education Act 2002(1) applies in relation to units as it applies in relation to maintained schools (within the meaning of Chapter 1 of Part 3 of that Act).

**8.** Section 30(4) of that Act applies in relation to units as it applies in relation to maintained schools (within the meaning of Chapter 1 of Part 3 of that Act) with the modification that the words "the governing body or (as the case may be)" and "the governing body or" are omitted.

**9.** Section 32 of that Act applies in relation to units as it applies in relation to schools mentioned in section 32(1) with the modification that in section 32(1)(b), in the case of a unit having a management committee, the local education authority together with the management committee shall determine the times of the school sessions.

**10.** Section 101(1)(d) of that Act applies in relation to units as it applies in relation to special schools.

(2) Yn lle'r diffiniad o "awdurdod priodol" yn rheoliad 4(1), rhodder "yr awdurdod addysg lleol".

**13.-(1)** Parts 1 and 2 of the Education (School Inspection) (Wales) Regulations 2006(2) apply in relation to units as if they were maintained schools to which section 28 of the Education Act 2005 applies, with the following modifications.

(2) For the definition of "appropriate authority" in regulation 4(1), there is substituted "the local education authority".

(3) In regulation 7(1), sub-paragraphs (a) to (d) are omitted.

(4) Regulation 7(1)(f) applies to units as it applies to secondary schools.

#### **The Staffing of Maintained Schools (Wales) Regulations 2006**

**14.-(1)** Part 1 of the Staffing of Maintained Schools (Wales) Regulations 2006(3) applies in relation to units as it applies in relation to schools referred to in regulation 3 with the following modifications.

- (b) Wrth benderfynu os yw person yn addas ar gyfer ei benodi'n athro neu'n athrawes â gofal, neu'n athro gweithredol neu'n athrawes weithredol â gofal uned, rhaid i'r awdurdod addysg lleol roi sylw i unrhyw ganllawiau a roddir o dro i dro gan y Cynulliad Cenedlaethol".

(3) Hepgorer rheoliad 11.

(4) Yn lle rheoliad 12, rhodder-

- "(a) Wrth benodi person i swydd, neu wrth gymryd person ymlaen i weithio mewn dull arall, mewn uned, rhaid i'r awdurdod addysg lleol roi sylw i unrhyw ganllawiau a roddir o dro i dro gan y Cynulliad Cenedlaethol.
- (b) Mae'r rheoliad hwn yn gymwys o ran swyddi staff cymorth a gwaith staff cymorth fel y mae'n gymwys o ran swyddi addysgu a gwaith athrawon".

(5) Hepgorer rheoliad 13.

(6) Yn lle rheoliad 14, rhodder-

"I'r graddau y mae'n rhesymol ymarferol i wneud hynny, rhaid i'r awdurdod addysg lleol geisio cyngor yr athro neu'r athrawes â gofal uned, a rhaid iddo ystyried unrhyw gyngor a roddir, cyn gwneud unrhyw benodiad neu ymrwymo i gymryd unrhyw un ymlaen o dan reoliad 12.".

(3) In regulation 5-

- (a) in paragraph (1), "15, 26 and 27" are omitted;
- (b) in paragraph (2), sub-paragraphs (b) and (c) are omitted; and
- (c) paragraph (3) is omitted.

(4) Regulation 6 is omitted.

(5) In regulation 7, paragraphs (4)(a) and 5 are omitted.

**15.-**(1) Part 2 of those Regulations applies in relation to units as it applies in relation to schools referred to in regulation 9 with the following modifications.

(2) For regulation 10, there is substituted-

- "(a) The local education authority must ensure that whenever there is a vacancy in the post of teacher in charge of the unit a person is appointed as acting teacher in charge in order to carry out the functions of the teacher in charge under any enactment.
- (b) In determining whether a person is suitable for appointment as a teacher in charge, or an acting teacher in charge, of a unit, the local education authority must have regard to any guidance given from time to time by the National Assembly".

(3) Regulation 11 is omitted.

(4) For regulation 12, there is substituted-

- "(a) In appointing a person to a post, or engaging a person otherwise to work, at a unit, the local education authority must have regard to any guidance given from time to time by the National Assembly.
- (b) This regulation applies in relation to support staff posts and the work of support staff as it applies in relation to teaching posts and the work of teachers".

(5) Regulation 13 is omitted.

(6) For regulation 14, there is substituted-

"In so far as it is reasonably practicable to do so, the local education authority must seek the advice of the teacher in charge of the unit, and must consider any advice given, before making any appointment or entering into any engagement under regulation 12.".

(7) Regulations 15 and 17 to 19 are omitted.

"(1) Mae gan yr awdurdod addysg lleol a chan yr athro neu'r athrawes â gofal uned y pwer i atal unrhyw berson a gyflogir, neu a gymerwyd ymlaen heblaw o dan gontract cyflogaeth, i weithio yn yr ysgol ac, ym marn yr awdurdod neu (yn ôl y digwydd) ym marn yr athro neu'r athrawes â gofal, y mae angen ei atal.

(3) Dim ond yr awdurdod addysg lleol a all roi diwedd ar ataliad o dan y rheoliad hwn a phan roddir diwedd ar ataliad, rhaid i'r awdurdod hysbysu'r pennath ar unwaith.

(4) Yn y rheoliad hwn ystyr "atal" yw atal heb golli tâl".

(8) For regulation 16, there is substituted-

"(1) Both the local education authority and the teacher in charge of a unit have power to suspend any person employed, or engaged otherwise than under a contract of employment, to work at the school where, in the opinion of the authority or (as the case may be) the teacher in charge, suspension is required.

(2) A person who exercises the power to suspend must immediately inform the other person with the power to suspend under paragraph (1).

(3) A suspension under this regulation may be ended only by the local education authority and, when a suspension is ended, the authority must immediately inform the head teacher.

(4) In this regulation "suspend" means suspend without loss of emoluments."
