EXPLANATORY NOTE

(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)

(This note is not part of the Regulations)

Mae'r Rheoliadau hyn yn diwygio Rheoliadau Cartrefi Plant (Cymru) 2002. Mae'r Rheoliadau yn darparu ar gyfer lefelau gofynnol isaf o gymwysterau a phrofiad ar gyfer rheolwyr a staff cartrefi plant, dynodi aelod o staff cartref plant i ddiogelu a hybu lles pob plentyn a leolir yn y cartref o ran iechyd ac addysg, cofrestru staff a rheolwyr gyda Chyngor Gofal Cymru, y niferoedd gofynnol o staff parhaol, gofyniad i sicrhau bod plant yn cael mynd at ddeintydd, ac yn gwneud mân newidiadau eraill i'r Prif Reoliadau. Mae'r rheoliadau hefyd yn gwneud diwygiadau canlyniadol i Reoliadau Cofrestru Gofal Cymdeithasol a Gofal Iechyd Annibynnol (Cymru) 2002.

These Regulations amend the Children's Homes (Wales) Regulations 2002. The Regulations make provision for minimum levels of qualification and experience for managers and staff of children's homes, the designation of a member of staff of a children's home to safeguard and promote the health and educational welfare of each child placed in the home, registration of staff and managers with the Care Council for Wales, minimum numbers of qualified staff, minimum numbers of permanent staff, a requirement to ensure that children have access to a dentist, and make other minor amendments to the principal Regulations. The Regulations also make consequential amendments to the Registration of Social Care and Independent Health Care (Wales) Regulations 2002.

1.-(1) Enw'r Rheoliadau hyn yw Rheoliadau Cartrefi Plant (Cymru) (Diwygiadau Amrywiol) 2007 a deuant i rym ar 1 Gorffennaf 2007, ac eithrio rheoliad 2(12), a ddaw i rym ar 15 Chwefror 2007.

(2) Yn y Rheoliadau hyn ystyr "y Prif Reoliadau" (*"the Principal Regulations"*) yw Rheoliadau Cartrefi Plant (Cymru) 2002(2)

(3) Mae'r Rheoliadau hyn yn gymwys o ran Cymru.

Diwygio'r Prif Reoliadau.

2.-(1) Yn y rheoliad hwn, oni bai i'r cyd-destun fynnu fel arall, mae unrhyw gyfeiriad at reoliad â rhif yn gyfeiriad at y rheoliad yn y Prif Reoliadau sy'n dwyn y rhif hwnnw ac mae unrhyw gyfeiriad mewn rheoliad at baragraff â rhif yn gyfeiriad at y paragraff yn y rheoliad hwnnw sy'n dwyn y rhif hwnnw.

The National Assembly for Wales in exercise of the powers conferred upon it by sections 1(4), 12(2), 16(1), 22(1), (2)(a) to (d), (f) to (j), (3), (4), (5)(a) and (c), (7)(c) and 118 (5) to (7) of the Care Standards Act 2000(1) and having consulted such persons as it considers appropriate, makes the following Regulations:

Title, commencement, interpretation and application

1.-(1) The title of these Regulations is the Children's Homes (Wales) (Miscellaneous Amendments) Regulations 2007 and they will come into force on 1 July 2007, except for regulation 2(12), which comes into force on 15 February 2007.

(2) In these Regulations "the Principal Regulations" means the Children's Homes (Wales) Regulations 2002(2).

(3) These Regulations apply in relation to Wales.

Amendment of the Principal Regulations.

2.-(1) In this regulation, unless the context otherwise requires, any reference to a numbered regulation is to the regulation in the Principal Regulations bearing that number and any reference in a regulation to a numbered paragraph is to the paragraph of that regulation bearing that number.

(2) Mae'r Prif Reoliadau wedi'u diwygio yn unol â darpariaethau canlynol y rheoliad hwn.

(3) Yn rheoliad 2 (Dehongli), mewnosoder y canlynol yn y lle priodol-

"ystyr "cyflogai parhaol" ("*permanent employee*") yw person a gyflogir yn llawn amser neu'n rhan-amser gan y person cofrestredig, gan gynnwys personau a gyflogir ar gongtract gwasanaeth am dymor penodedig am ddim llai na chyfnod o chwech mis."

"ystyr "cymhwyster perthnasol" ("*relevant qualification*") yw cymhwyster a gynhwysir mewn rhestr a gynhelir gan y Cynulliad Cenedlaethol at ddiben y Rheoliadau hyn;

"ystyr "gweithiwr dolen gyswllt" ("*link worker*") yw aelod o staff cartref plant sy'n briodol o ran ei hynafedd a chanddo gyfrifoldeb penodol am ddiogelu a hybu lles plentyn unigol o ran iechyd ac addysg ac am gydgyssylltu â darparwyr addysg a gofal iechyd ar ran y plentyn hwnnw;"

(4) Yn rheoliad 8 (Ffitrwydd y rheolwr) ar ôl paragraff (2) mewnosoder-

"(2A). Yn ddarostyngedig i baragraff (2B) a (2C), mae cyfeiriad at gymwysterau a phrofiad ym mharagraff (2)(b)(i) yn cynnwys gofyniad bod rhaid iddo-

- (a) ddal cymhwyster perthnasol; a
- (b) fod wedi gweithio am ddim llai na phum mlynedd ym maes gofal preswyl i blant.

(2B). Pan fo rheolwr nad yw'n dal cymhwyster perthnasol wedi'i benodi i reoli plant cartref cyn 1 Gorffennaf 2007 ni fydd y person hwnnw heb oni bai fod yn ffit i reoli cartref plant ei fod yn enill y cymhwyster perthnasol, ddim hydrach na-

- (a), 1 Tachwedd 2007; neu
- (b) unrhyw ddyddiad diweddarach y bydd y Cynulliad yn cytuno arno o dan amgylchiadau eithriadol;

(2C) Nid yw paragraff (2A)(b) yn gymwys o ran rheolwr a benodwyd cyn 1 Gorffennaf 2007.

(2Ch). Nid oes dim ym mharagraffau (2A) hyd at (2C) sy'n effeithio ar unrhyw ofyniad i reolwr feddu ar gymwysterau, medrau neu brofiad arall sy'n berthnasol i'r materion a nodir ym mharagraff (2)(b).

(2D). Ni fydd person yn ffit i reoli cartref plant os nad yw wedi'i gofrestru'n rheolwr gyda Chyngor Gofal Cymru heb fod yn hwyrach na -

- (i) 1 Tachwedd 2007; neu
- (ii) unrhyw ddyddiad diweddarach y bydd y Cynulliad yn cytuno arno o dan amgylchiadau eithriadol."

(2) The Principal Regulations are amended in accordance with the following provisions of this regulation.

(3) In regulation 2 (Interpretation), insert the following in the appropriate place-

"link worker" ("*gweithiwr dolen gyswllt*") means a member of children's home staff of appropriate seniority with particular responsibility for protecting and promoting the health and educational welfare of an individual child and for liaison with education and health care providers on that child's behalf ;"

"permanent employee" ("*cyflogai parhaol*") means a person employed full or part time by the registered person, including persons employed on a temporary contract of service for a fixed term of not less than six months; "

"relevant qualification" ("*cymhwyster perthnasol*") means a qualification contained in a list maintained by the National Assembly for the purpose of these Regulations;".

(4) In regulation 8 (Fitness of manager) after paragraph (2) insert-

"(2A). Subject to paragraph (2B) and (2C), a reference to qualifications and experience in paragraph (2)(b)(i) includes a requirement that he or she must-

- (a) hold a relevant qualification; and
- (b) have worked for not less than five years in the field of children's residential care.

(2B). Where a manager who does not hold a relevant qualification was appointed before 1 July 2007 that person is not fit to manage a children's home unless he or she obtains a relevant qualification not later than-

- (a) 1 November 2007; or
- (b) such later date as the National Assembly may, in exceptional circumstances, agree

(2C) Paragraph (2A)(b) does not apply in relation to a manager appointed before 1 July 2007.

(2D) Nothing in paragraphs (2A), to (2C) affects any requirement for a manager to possess other qualifications, skills or experience relevant to the matters set out in paragraph (2)(b).

(2E) A person is not fit to manage a children's home unless he or she is registered as a manager with the Care Council for Wales not later than-

- (a) 1 November 2007; or
- (b) such later date as the National Assembly may, in exceptional circumstances, agree."

(5) Yn rheoliad 11 (Hybu lles) ar ôl paragraff (2) mewnosoder-

"(3) Wrth gydymffurfio â gofynion y rheoliad hwn a rheoliadau 18(1)(c) a 20(1), rhaid i'r person cofrestredig ddynodi aelod o staff i fod yn weithiwr dolen gyswllt ar gyfer pob plentyn."

(6) Yn rheoliad 12 (Cynllun lleoliad y plentyn), ym mharagraff (1)(b), ar ôl y geiriau "gofal iechyd ac addysg y plentyn", mewnosoder-

"gan gynnwys enw a manylion cyswllt gweithiwr dolen gyswllt y plentyn."

(7) Yn rheoliad 18 (Addysg, cyflogaeth a gweithgareddau hamdden)-

(a) ar ôl is-baragraff (1)(b) dileer y gair "ac"; a

(b) ar ôl is-baragraff (1)(c), mewnosoder-

"(ch) mae gweithiwr dolen gyswllt plentyn yn cymryd rhan mewn unrhyw adolygiad sy'n cynnwys ystyried cynnydd addysgol y plentyn, p'un a yw'r adolygiad yn cael ei gynnal o dan Reoliadau Adolygu Achosion Plant (Cymru) 2007(1) neu fel arall."

(8) Yn rheoliad 20 (Anghenion iechyd plant)-

(a) ar ddiwedd is-baragraff (2)(a), ar ôl y geiriau "ymarferydd cyffredinol" mewnosoder-

"a'i fod wedi'i roi o dan ofal ymarferydd deintyddol cofrestredig." a

(b) ar ôl is-baragraff (2)(dd) mewnosoder-

"(e) bod gweithiwr dolen gyswllt plentyn yn cymryd rhan mewn unrhyw adolygiad sy'n cynnwys ystyried unrhyw agwedd o iechyd plentyn, p'un a yw'r adolygiad hwnnw yn cael ei gynnal o dan Reoliadau Adolygu Achosion Plant (Cymru) 2007 neu fel arall."

(9) Yn rheoliad 25 (Staffio cartrefi plant)

(a) ar ôl paragraff (1) mewnosoder-

"(1A) Wrth gydymffurfio â pharagraff (1) rhaid i'r person cofrestredig sicrhau nad oes, ar bob adeg ar ôl 1 Gorffennaf 2010, neu unrhyw ddyddiad diweddarach y bydd y Cynulliad yn cytuno arno o dan amgylchiadau eithriadol, dim llai na 80% o'r staff gofal yn y cartref plant yn dal cymhwyster perthnasol.";

(b) ar ôl paragraff (2) mewnosoder-

"(2A). Wrth gydymffurfio â pharagraff (2) rhaid i'r person cofrestredig sicrhau nad oes ar unrhyw adeg ar ôl 1 Mawrth 2008 neu unrhyw ddyddiad y bydd y Cynulliad yn cytuno arno o dan amgylchiadau eithriadol dim llai na 90% o'r staff gofal sy'n gweithio mewn cartref plant yn gyflogeion parhaol."

(5) In regulation 11 (Promotion of welfare) after paragraph (2) insert-

" (3) In complying with the requirements of this regulation and regulations 18(1)(c) and 20(1), the registered person must designate a member of staff to be the "link worker" for each child."

(6) In regulation 12 (Child's placement plan), in paragraph (1)(b), after the words "health care and education", insert-

"including the name and contact details of the child's link worker."

(7) In regulation 18 (Education, employment and leisure activity)-

(a) after sub-paragraph (1)(b) delete the word "and"; and

(b) after sub-paragraph (1)(c), insert-

"(d) a child's link worker participates in any review involving consideration of the child's educational progress, whether conducted under the Review of Children's Cases (Wales) Regulations 2007 or otherwise."

(8) In regulation 20 (Health needs of children)-

(a) at the end of sub-paragraph (2)(a), after the words "general practitioner" insert-

"and placed under the care of a registered dental practitioner; and

(b) after sub-paragraph (2)(f) insert-

"(g) a child's link worker participates in any review involving consideration of any aspect of a child's health, whether conducted under the Review of Children's Cases (Wales) Regulations 2007(1) or otherwise."

(9) In regulation 25 (Staffing of children's homes)-

(a) after paragraph (1) insert-

"(1A) In complying with paragraph (1) the registered person must ensure that at all times after 1 July 2010, or such later date as the Assembly may, in exceptional circumstances agree, not less than 80% of the care staff at the children's home hold a relevant qualification."; and

(b) after paragraph (2) insert-

"(2A) In complying with paragraph (2) the registered person must ensure that at all times after 1 March 2008 or such later date as the Assembly may, in exceptional circumstances agree, not less than 90% of care staff working at the children's home are permanent employees."

(10) Yn rheoliad 26 (Ffitrwydd gweithwyr), ar ôl paragraff (2), mewnosoder-

"(2A) Yn ddarostyngedig i baragraff (2B) a (2C), o ran aelod o staff gofal cartref plant, mae cyfeiriad at gymwysterau a phrofiad ym mharagraff (2)(b) yn cynnwys gofyniad bod rhaid i berson ddal cymhwyster perthnasol.

(2B) Pan fo person nad yw'n dal cymhwyster perthnasol wedi cael ei benodi i weithio mewn cartref plant cyn 1 Gorffennaf 2007 ni fydd y person hwnnw yn ffit i weithio mewn cartref plant ori bai ei fod yn ennill, y cymhwyster perthnasol ddim hwyrach na-

(a) tair blynedd ar ôl 1 Gorffennaf 2007; neu

(b) unrhyw ddyddiad hwyrach y bydd y Cynulliad Cenedlaethol o dan amgylchiadau eithriadol yn cytuno arno.

(2C) Pan fo person nad yw'n dal cymhwyster perthnasol wedi'i benodi i weithio mewn cartref plant ar ôl 1 Gorffennaf 2007, nid yw'r person hwnnw heb fod yn ffit i weithio mewn cartref plant ori bai ei fod yn ennill cymhwyster perthnasol ddim hwyrach na-

(a) tair blynedd ar ôl y dyddiad cyntaf ar ôl 1 Gorffennaf 2007 pan benodwyd ef i weithio mewn cartref plant; neu

(b) erbyn unrhyw ddyddiad hwyrach y bydd y Cynulliad Cenedlaethol o dan amgylchiadau eithriadol yn cytuno arno.

(2Ch) Pan fo person sy'n ddarostyngedig i ofyniad i gael cymhwyster perthnasol cyn pen cyfnod o amser a bennir yn unol â pharagraff (2B) neu (2C) yn cael ei benodi yn ystod y cyfnod hwnnw i swydd wahanol ym maes gofal preswyl plant, gyda'r un cyflogwr neu gyda chyflogwr arall, nid yw'r cyfnod hwnnw o amser i'w newid oherwydd y rheswm hwnnw yn unig.

(2D) Nid oes dim ym mharagraffau (2A) hyd at (2C) sy'n effeithio ar unrhyw ofyniad i berson feddu ar gymwysterau, medrau neu brofiad arall sy'n berthnasol i'r materion a nodir ym mharagraff (2)(b) ac (c).

(2Dd) Nid yw person a benodwyd i weithio mewn cartref plant cyn 1 Gorffennaf 2007 yn ffit i weithio mewn cartref plant os nad yw yn cofrestru fel gweithiwr gofal cymdeithasol gyda Chyngor Gofal Cymru heb fod yn hwyrach na-

(a) 1 Mawrth 2008; neu

(b) unrhyw ddyddiad diweddarach y bydd y Cynulliad yn cytuno arno o dan amgylchiadau eithriadol.

(10) In regulation 26 (Fitness of workers), after paragraph (2), insert-

"(2A) Subject to paragraph (2B) and (2C), in relation to a member of the care staff of a children's home, a reference to qualifications and experience in paragraph (2)(b) includes a requirement that that person must hold a relevant qualification.

(2B) Where a person who does not hold a relevant qualification was appointed to work at a children's home before 1 July 2007, that person is not fit to work at a children's home unless he or she obtains a relevant qualification-

(a) within a period of three years beginning with 1 July 2007; or

(b) by such later date as the National Assembly may in exceptional circumstances agree.

(2C) Where a person who does not hold a relevant qualification is appointed to work at a children's home after 1 July 2007, that person is not fit to work at a children's home unless he or she obtains a relevant qualification-

(a) within a period of three years beginning with the first date following 1 July 2007 on which he or she is appointed to work at a children's home; or

(b) by such later date as the National Assembly may in exceptional circumstances agree.

(2D) Where a person subject to a requirement to obtain a relevant qualification within a period of time specified in accordance with paragraph (2B) or (2C), is appointed during that period to a different post within the field of children's residential care, with the same or a different employer, the period of time so specified is not altered for that reason alone.

(2E) Nothing in paragraphs (2A) to (2C) affects any requirement for a person to possess other qualifications, skills or experience relevant to the matters set out in paragraph (2)(b) and (c).

(2F) A person appointed to work in a children's home before 1 July 2007 is not fit to work in a children's home unless he or she registers as a social care worker with the Care Council for Wales not later than-

(a) 1 March 2008; or

(b) such later date as the National Assembly may in exceptional circumstances agree.

(2E) Nid yw person a benodwyd i weithio mewn cartref plant ar ôl 1 Gorffennaf 2007 yn ffit i weithio mewn cartref plant os nad yw'n cofrestru fel gweithiwr gofal cymdeithasol gyda Chyngor Gofal Cymru heb fod yn hwyrach na-

(a) chwe mis ar ôl y dyddiad cyntaf ar ôl 1 Gorffennaf 2007 pan benodwyd ef i weithio mewn cartref plant; neu

(b) unrhyw ddyddiad diweddarach y bydd y Cynulliad yn cytuno arno o dan amgylchiadau eithriadol".

(11) Yn rheoliad 27 (Cyflogi staff), ar ôl paragraff (4) mewnosoder-

"(4A). O dan y Rheoliadau hyn, pan fo ffitrwydd unrhyw berson a gyflogir gan y person cofrestredig yn dibynnu arno'n ennill cymhwyster perthnasol cyn pen amser penodedig, rhaid i'r person cofrestredig, i'r graddau y mae'n ymarferol, ei alluogi i ennill y cymhwyster cyn pen yr amser penodedig."

(12) Yn rheoliad 33(1) (Adolygiad o ansawdd gofal)-

(a) ym mharagraff (2)(c)(iv) yn lle'r geiriau "cartref gofal" rhodder y geiriau "cartref plant"; a

(b) ym mharagraff (4)(a) yn lle'r geiriau "defnyddwr gwasanaeth" rhodder y geiriau "plant sy'n cael eu lletya yn y cartref plant";.

(13) Yn Atodlen 2 (Yr wybodaeth y mae ei hangen mewn Perthynas a Phersonau sy'n Ceisio Rhedeg neu Reoli Cartref Plant neu Weithio Mewn Un), ar ol paragraff 5, mewnosoder-

"5A Tystiolaeth ddogfennol o gofrestru gyda Cyngor Gofal Cymru."

(14) Yn Atodlen 4 (Cofnodion eraill) ar ol paragraff 2 (e) mewnosoder.

Diwygiadau i Reoliadau Cofretru Gofal Cymdeithasol a Gofal Iechyd Annibynnol (Cymru) 2002

3.-(1) Mae Rheoliadau Cofrestru Gofal Cymdeithasol a Gofal Iechyd Annibynnol (Cymru) 2002(2) wedi'u diwygio o ran cartrefi plant, yn unol â darpariaethau canlynol y rheoliad hwn.

(2G) A person appointed to work in a children's home after 1 July 2007 is not fit to work in a children's home unless he or she registers as a social care worker with the Care Council for Wales not later than-

(a) six months from the first date following 1 July 2007 on which he or she is appointed to work at a children's home; or

(b) such later date as the National Assembly may in exceptional circumstances agree.".

(11) In regulation 27 (Employment of staff), after paragraph (4) insert-

"(4A) Where, under these Regulations, the fitness of any person employed by the registered person depends upon their obtaining a relevant qualification within a specified time, the registered person must, so far as is practicable, enable him or her to obtain the qualification within the time specified.".

(12) In regulation 33(1) (Review of quality of care)-

(a) in paragraph (2)(c)(iv) substitute the words "care home" with "children's home"; and

(b) in paragraph (4)(a) substitute the words "service users" with "children accommodated in the children's home";.

(13) In Schedule 2 (Information Required in Respect of Persons Seeking to Carry on, Manage or Work at a Children's Home) , after paragraph 5, insert-

"5A Documentary evidence of registration with the Care Council for Wales.".

(14) In Schedule 4 (Other Records), after paragraph 2(g) insert-

"(h) whether he or she is registered with the Care Council for Wales.".

Amendments to the Registration of Social Care and Independent Health Care (Wales) Regulations 2002

3.-(1) The Registration of Social Care and Independent Health Care (Wales) Regulations 2002(2) are amended in relation to children's homes, in accordance with the following provisions of this regulation.

(2) In Part III of Schedule 1, after paragraph 16(e) insert-

"(ea) where the establishment is a children's home, whether the person is registered with the Care Council for Wales and if so, details of their registration;"

(3) In Part I of Schedule 3, after paragraph 2, insert-

" 2A Where the establishment is a children's home, details of the applicant's registration with the Care Council for Wales."
